B. Treasurer's Report

David Faux, Treasurer, reported that Su looked over Treasurer's records, and everything seems to be in order.

 - a. Olivia reported no updates beyond pending sculptures' placement in N. Dakota park (see OB-1).
- 2. Public Relations (Paola Sepulveda and Kerry Dixon, Co-Chairs).
 - **a.** Paola reported the possibility (per Ben McConville, GIS Coordinator) of public-facing and private-facing aspects to Otocast, and suggested meeting with Collection Management to evaluate this.
 - i. When our Otocast contract ends in June 2019, we may be able to keep current functionality through a map managed through the city (possibly built off ARC GIS). The possible interface allows images and audio at pin drops.
 - ii. Kerry pointed out that a benefit to in-house management would be transferring maintenance information (some of it paper) to a singular, central, usable electronic database. Olivia connected this to Collection Management's mission of stewardship, and added that this would make maintenance simpler to keep on a preventative schedule. PAC discussed the extent of paper records, and the need to transfer them to a singular electronic resource.
 - iii. Next step: Paola and Tasheik will meet with Ben.
 - **b.** Kerry reported that shirts have been ordered.

 - o Providing birdhouse kits was suggested as a better fit with city's granting.

- Bob reported that the two dragon sculptures are installed at SW corner of City Hall/Community Center.
 - o Name: "The Trogdors" (formerly/colloquially known as "Orange Dragon" and "Purple Dragon")
 - Signage is pending

 - o Several staff members shifting or retiring
 - o Bob will alert us to new staff contact person
- Bob is retiring April 1, 2019
