#### I. Background/Summary

The City of Ames, Iowa is an entitlement recipient of federal funds from the U.S. Department of Housing and Urban Development (HUD) for the Community Development Block Grant (CDBG) Program and HOME Investment Partnerships (HOME) Program Funds.

In accordance with the City's 2019 updated Citizen Participation Plan:

- 1. The City will amend its approved plan whenever it makes a decision to make a change in its allocation priorities or a change in the method of distribution of funds; to carry out an activity using funds from any program covered by the Consolidated Plan (including program income), not previously described in the action plan; or to change the purpose, scope, location or beneficiaries of an activity.
- 2. The City will use the following criteria to determine what changes in the planned or actual activities constitute a substantial amendment to the Consolidated Plan; any of the following will require a substantial amendment following this citizen participation plan:
  - a. Changes in the use of CDBG funds from one eligible activity to another eligible activity that exceeds \$100,000.
  - b. Carrying out a new CDBG eligible activity in an amount greater than \$100,000.

A change in the entity responsible for carrying out an activity, a change in the location of a proposed project, or any updates or corrections will not constitute a substantial amendment.

3. The City will publish a summary of the proposed substantial amendment in the local newspaper in a manner that affords citizens, public agencies and other interested parties a reasonable opportunity to examine its contents and to submit comments. The entire substantial amendment and attachments will be published on the City's web site. The City will also make copies of the proposed substantial amendment available at the Planning and Housing Department office and the City of Ames Public Library for review during public hours. Ten (10) free copies of the proposed plans will be made available. One free copy will be provided to each individual or organization requesting said copy until the supply is exhausted.

The City of Ames will hold at least one public hearing on the proposed substantial amendment to the Consolidated Plan prior to the submittal. Notice of the public hearing will be published in the local newspaper not less than four days or more than twenty days before the public hearing. There will be a 30-day comment period on the proposed substantial amendment to the Consolidated Plan.

4. The City will consider any comments or views of citizens received in writing or orally at the public hearings in preparing the final substantial amendment to the consolidated plan. A summary of these comments or views, and a summary of any comments or views not accepted and the reasons therefore, shall be attached to the final amended consolidated plan.

In accordance with 24 CFR 91.505, the City of Ames will be submitting a <u>substantial amendment</u> to its' 2019-20 CDBG Annual Action Plan to HUD proposing the following changes:

- Add an additional activity to the 2019-20 Annual Action Plan projects;
- Revised the 2019-20 CDBG Program Budget to reflect the new activity; and
- Correct the amount of 2018-19 Rollover funds.

#### II. Substantial Amendment to the Action Plan/ CDBG Budget

It was discovered after discussions with Public Works and Parks and Recreation Departments that an opportunity became available where CDBG funds could be used to facilitate construction of a **Shared Used Path** from Franklin Park to S. Wilmoth Ave. This activity would be part of additional improvements being planned in the area by both Public Works and Parks and Recreation. Public Works will be installing a bike path to the west side of Franklin Park to Beedle Drive and Parks and Recreation will be installing additional recreational features in Franklin Park (See Attachments 1, and 2).

The overall shared use path route was originally identified as part of the 2040 Long Range Transportation Plan. The proposed CDBG Bike Path project section would involve the acquisition and demolition of a two-story single-family rental on S. Franklin. The house is located in the pathway where the bike path would need to be installed. The single-family unit is currently being rented; therefore, pursuing this project would also involve the relocation of occupants.

In the adopted 2019-20 Action Plan, the City budgeted to implement an Acquisition/Reuse for Affordable Housing activity, which would involve the purchase of a single-family structure that we would either demolish or rehabilitate for affordable housing for a low income household. The purchase of the structure under a Shared Use Path activity would be considered a "public improvement" activity with no requirement for an affordable housing reuse component. The goal of the Shared Use Path activity would be to utilize the funding that was set aside under the Acquisition/Reuse for Affordable Housing in the amount of approximately \$400,000.

Below shows the proposed amended program budget for 2019-20 Action Plan program activities. The activities being recommended are the same as in the adopted Action Plan, however, the budget for the Shared Use Path activity is being substituted for the Acquisition/Reuse for Affordable Housing activity. The overall budget has been adjusted due to the reduction in the amount of "roll over" funds available.

The rationale for adding the Bike Path as new project activity is as follows:

- The proposed project is located in the City's approved Neighborhood Revitalization Strategy Area (NRSA) and therefore is consistent with the goals and priorities in our 2019-23 Consolidated Plan to positively benefit low income residents in the area.
- This activity will enhance improvements to the area along with current the mixed-income subdivision development of the 321 State Avenue parcel, and the acquisition of Franklin Park.
- The activity will continue to meets the City Council's goals of strengthening our neighborhoods.
- Continues the investment of improving both the housing stock and the infrastructure needs vital core neighborhoods.
- The proposed project would result in the City's ability to meet HUD's 2019-20 timely expenditure requirements.





# Public Input Sought for Substantial Amendment to the City's CDBG 2019-20 Annual Action Plans

AMES, Iowa – The public is encouraged to provide input to the City of Ames request for a Substantial Amendment to its CDBG 2019-2020 Annual Action Plans, which will outline adding an additional proposed activity, project location, and proposed budget being funded by the Housing and Community Development Act of 1974 using Community Development Block Grant funding.

The additional activity would involve installation of a Shared Use Bike Path from Franklin Park to S. Wilmoth. This activity would be part of additional improvements being planned in the area by both Public Works and Parks and Recreation. Public Works will be installing a bike path to the west side of Franklin Park to Beedle Drive and Parks and Recreation will be installing additional recreational features in Franklin Park. The federal budget allocation for the 2019-20 CDBG program is \$581,207 and for the HOME Program is \$481,968.

HEARING ON AMENDMENT TO 2019-2020 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) ANNUAL ACTION PLAN: Housing Coordinator Vanessa Baker-Latimer reviewed the amendment to the 2019-2020 CDBG Annual Action Plan. She advised Council that if the request was approved, staff would move forward with purchasing the property.

Council Member Betcher asked if there was a time by which the tenants would have to be relocated. Ms. Baker-Latimer said not right away. Once the property is approved, staff may allow the tenants to stay to the end of the lease term without collecting rent. She said they would contact the tenants and work with them on relocation before moving forward with the project.

Mayor Haila opened the public hearing. Since no one wished to speak, he closed the public hearing.

Moved by Martin, seconded by Beatty-Hansen, to approve Alternative 1: adopting RESOLUTION NO. 20-055 to amend the 2019-20 CDBG Annual Action Plan to reallocate funds (\$400,000) from the Acquisition/Reuse for Affordable Housing activity to a Public Improvement activity to install a Shared Use Path from Franklin Park to S. Wilmoth.

# RESOLUTION APPROVING AMENDMENT TO THE 2019-20 CDBG ANNUAL ACTION PLAN FOR THE CITY OF AMES, IOWA

WHEREAS, at the December 17, 2019, meeting, the City Council directed staff to prepare a substantial amendment to the 2019-20 Annual Action Plan to reallocate \$400,000 from the Acquisition/Reuse for Affordable Housing activity to a Public Improvement Acquisition/Reuse activity; and,

WHEREAS, CDBG funds for the Shared Use Path project will involve the acquisition and demolition of a two-story single-family rental on South Franklin and the house is located in the pathway where the bike path would need to be installed to connect directly to other segments; and,

WHEREAS, the single-family unit is currently being rented; therefore, pursuing this project would also involve the relocation of occupants at a future date; and,

WHEREAS, as outlined at the December 17, 2019 meeting, in order to pursue this new project activity, the current Annual Action Plan would need to be amended; and,

WHEREAS, an Amendment to the Action Plan requires a 30-day comment period for the public and a public hearing at City Council before it can be submitted as an additional activity to the Field Office and the 30-day substantial Amendment to the Action Plan comment period was from December 18, 2019 through January 19, 2020, with no comments being received; and,

WHEREAS, Staff's rationale for adding the Bike Path as a new project activity is as follows:

- The proposed project is located in the City's approved Neighborhood Revitalization Strategy Area (NRSA) and is consistent with the goals and priorities in the 2019-23 Consolidated Plan to positively benefit low-income residents in the area.
- This activity will enhance improvements to the area along with the current mixed-income subdivision development of the 321 State Avenue parcel, and the acquisition of Franklin Park.
- The activity will continue to meets the City Council's goals of strengthening our neighborhoods.
- Continues the investment of improving both the housing stock and the infrastructure needs vital core neighborhoods.
- The proposed project would result in the City's ability to meet HUD's 2019-20 timely expenditure requirements.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Ames, Iowa, that the approval of the Amendment to the 2019-20 CDBG Annual Action Plat to reallocate (\$400,000) from the Acquisition/Reuse for Affordable Housing activity to a Public Improvement activity to install a Shared Use Path is hereby approved.
