

# Water Pollution Control Facility Recognized for Peak Performance

The Ames Water Pollution Control Facility (WPCF) received the prestigious Platinum 30 Peak Performance Award recently from the National Association of Clean Water Agencies (NACWA). The award recognizes the Ames WPCF for 30 consecutive years of perfect compliance with its National Pollutant Discharge

### ARE YOU ON A SNOW ROUTE?

#### ELECTRIC SERVICES NAMED SMART ENERGY PROVIDER



Ames Electric Services was recently notified it is one of 27 public power utilities that have earned a Smart Energy Provider (SEP) designation from the American Public Power Association.

The SEP designation is given to utilities that demonstrate commitment to and proficiency in energy efficiency, distributed generation, and environmental initiatives that support

a goal of providing low-cost, quality, safe, and reliable electric service. The



Smart Energy Provider designations were presented recently during APPA's Customer Connections Virtual Conference.

This year's 27 utilities bring the total to 94 public power utilities nationwide that hold the Smart Energy Provider designation.

"We are honored to have received this designation because we

are committed to the principles being recognized," said Donald Kom, Ames

Electric Services Director. "Ames has a long history of progressive programs and services, and we have continued those initiatives through our SunSmart Ames solar farm, our rebate programs, and our commitment to installing more electric vehicle charging stations.

The SEP designation, which lasts for two years (Dec.1, 2020 to Nov. 30, 2022) recognizes public power utilities for demonstrating leading practices in four key disciplines: smart energy program structure; energy efficiency and distributed energy programs; environmental and sustainability initiatives; and the customer experience. This is the second year APPA has offered the SEP designation.

#### Carbon Monoxide Danger

Carbon monoxide is an odorless, colorless gas produced when fuel burns. If a fuel-burning device such as a furnace or kerosene heater is installed, operated, or vented incorrectly, the carbon monoxide it gives off can build up in the air. Should the concentration of carbon monoxide get high enough, you will develop the symptoms of carbon monoxide poisoning.

Symptoms may be hard to recognize because at first they are much like symptoms of the flu: headache, weakness, dizziness, and nausea. Other symptoms can include shortness of breath, chest pain, confusion, loss of consciousness, and heart arrhythmias. If you suspect carbon monoxide in your home or experience symptoms, call the Ames Fire Department at 515.239.5109.

# ENERGY QYA

Q: I'm going to be gone over the winter. I want to reduce my utility bills and conserve energy, but I don't want any unexpected surprises. Any advice?

A. Turning down your thermostat to save energy and money is a great idea, but never below 55 degrees. If you're heading off for the weekend, the week, or even longer, remember to take care of your plumbing. Frozen pipes are an issue whenever the temperature dips, and weather can turn cold without warning. Be prepared before you leave.

A safe bet would be to set your heat at 62° F before you leave for the winter, even if it is not very cold when you leave. Iowa is well-known for ever-changing weather.

Another suggestion is heat tape. According to the manufacturer's instructions, it should be applied on pipes that are near exterior or uninsulated walls. Pipe insulation or jacketing used in conjunction with heat tape will lessen the chance of your pipes freezing. Open cupboard doors below sinks in the kitchen and bathrooms. If your indoor meter is in your basement, open the utility room door to let the heat in.

#### Q: How do I know if I'm buying an efficient appliance?

A: Appliances can be expensive. That's why it's important to do a little research before you buy. According to the National Association of Home Builders and Bank of America Home Equity, a new refrigerator will last about 13 years, a washing

machine about 10 years, and a dishwasher about nine years.

Before you make a purchase, look for the Energy Star label. Energy Star has done all the testing necessary to determine which appliances exceed federal standards for efficiency. Most Energy Star certified appliances are 30 to 50 percent more efficient than standard appliances.

However, the Energy Star is only half the story. It's also important to look for the yellow and black Energy Guide label. This handy at-a-glance guide will show you the estimated annual energy consumption and operating cost for each appliance so you can compare them yourself. The Energy Guide label is required to be placed on all appliances by the manufacturers. The label provides information about energy consumption and shows you how much energy an appliance uses compared with similar models. Keep in mind that the numbers are averages; actual costs will differ somewhat depending on how you use them.

It is important to note that the yellow Energy Guide doesn't mean the appliance is efficient. Only those with the Energy Star label in the lower right-hand corner are identified as exceeding federal standards for efficiency. The Energy Star certification is necessary to qualify for a rebate from Ames Electric Services' Smart Energy program.
