Details: Officers called to a suicidal subject. Upon their arrival, the subject was attempting to cut their own throat with a knife. Officer deployed a Taser to stop the subject from further self-harm. Subject was taken to Mary Greeley Medical Center for evaluation.

Incident 2:

Use of Force: Pointing duty handgun at suspect Date: July 5, 2021 at 16:26
Details: Officers were called to investigate a burglary. The suspect fled in a vehicle. After a short pursuit, officers were able to stop the vehicle. The suspect was ordered to exit the vehicle while at gunpoint. The suspect was taken into custody without any further use of force.
Charges: Eluding, Driving While Revoked, and open container
Demographics: 36-year-old black male

Incident 3:

Use of Force: Grabbed arms and held for handcuffing Date: July 20, 2021 at 17:46
Details: Officers were called to a private residence where a guardian reported a juvenile having a mental health issue and out of control. The juvenile attempted to start a fire to burn the house down. When officers arrived, the parent was physically restraining the juvenile from assaulting family members. Officers grabbed the juvenile and held them down until they could be secured with handcuffs and transferred to MGMC for evaluation.

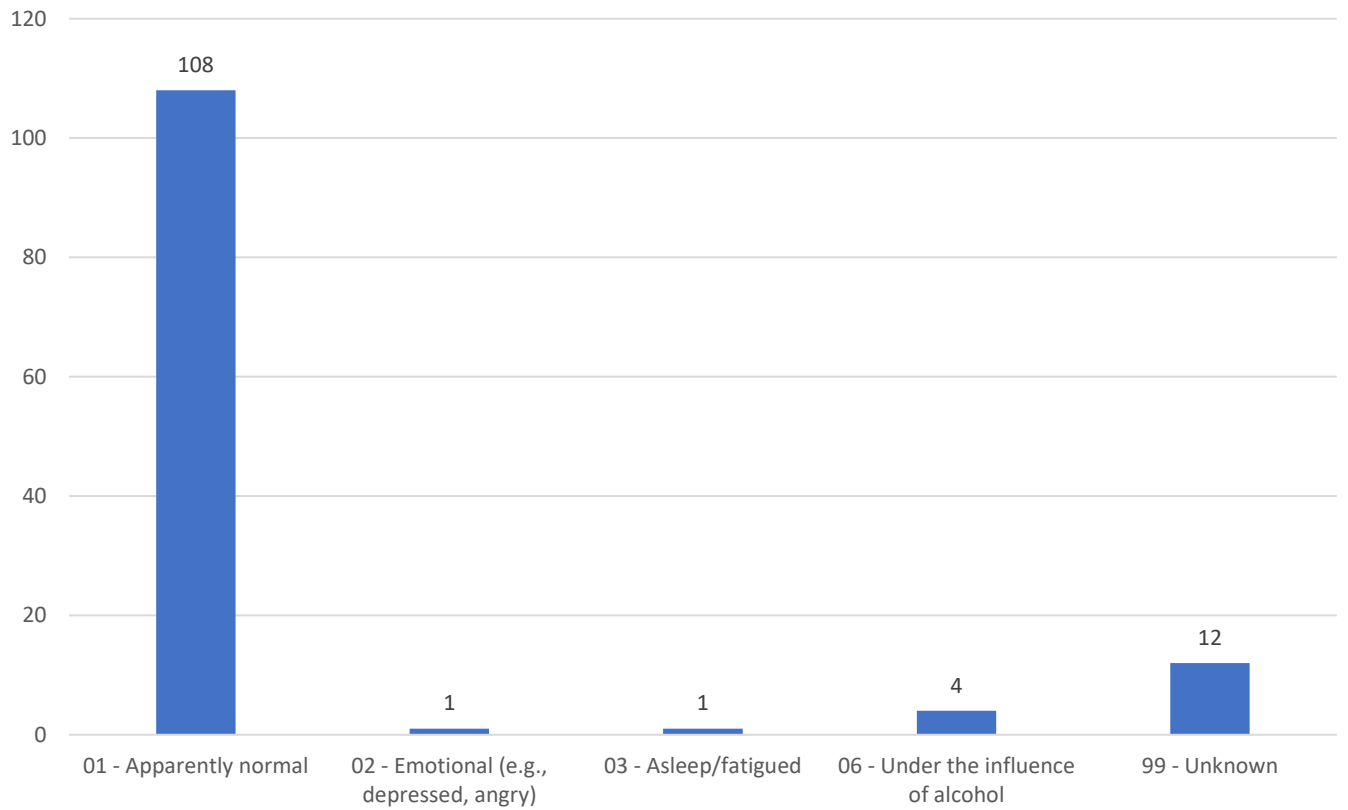


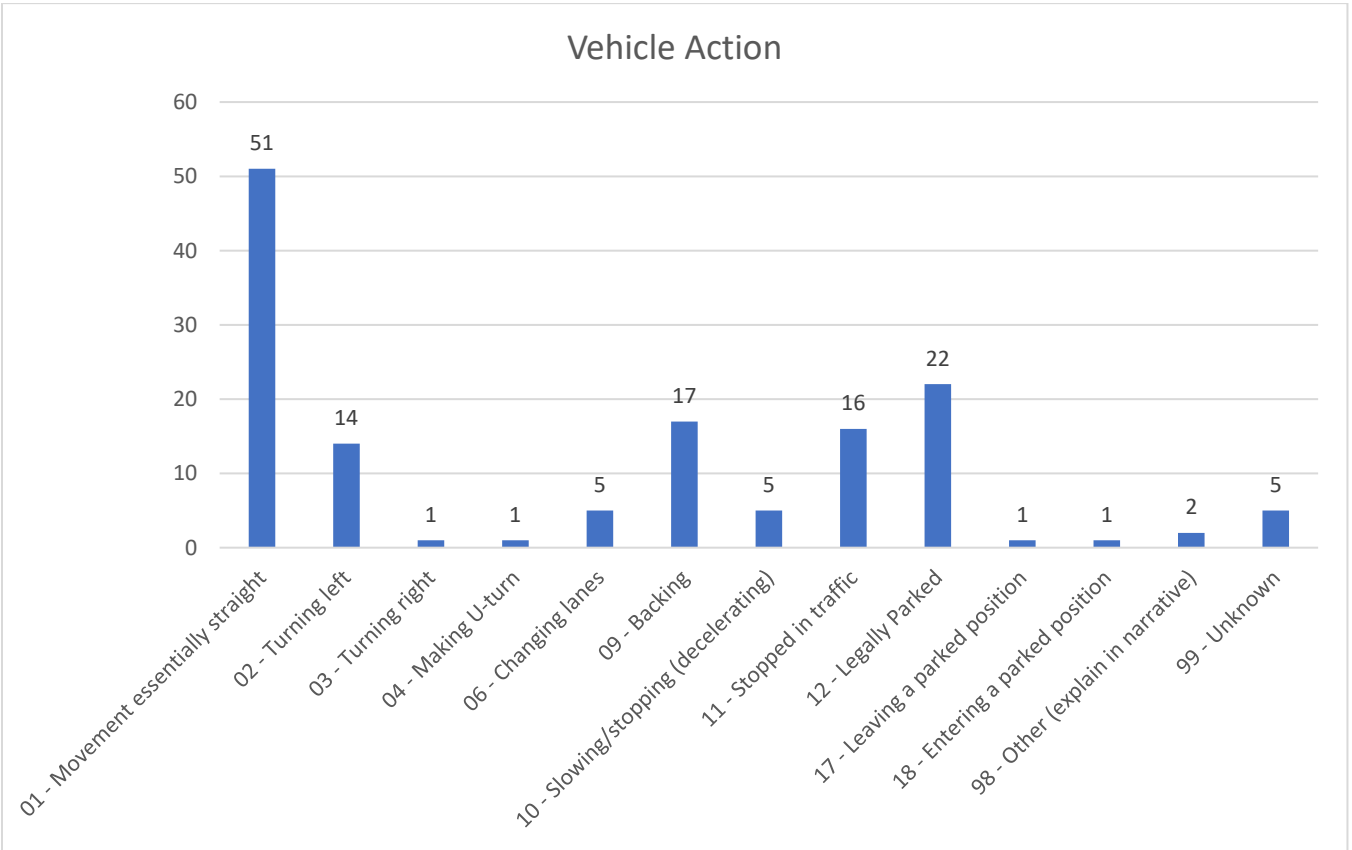
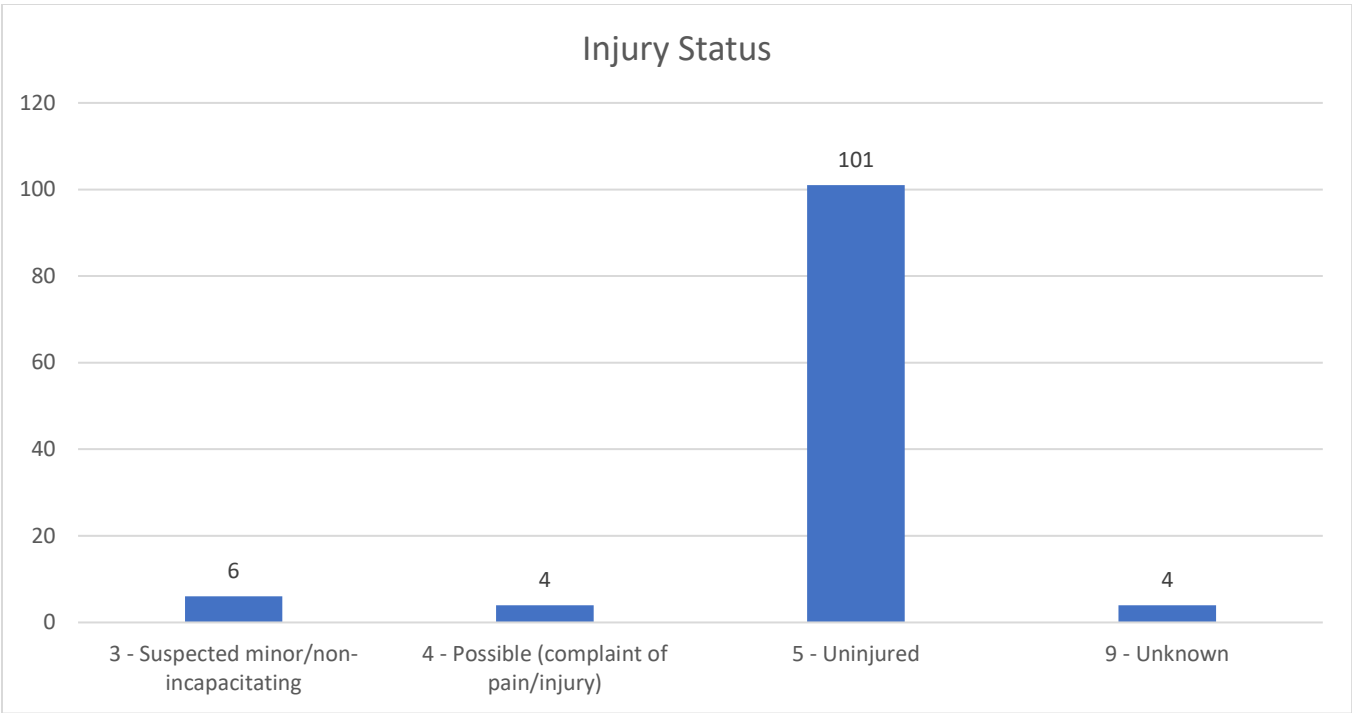


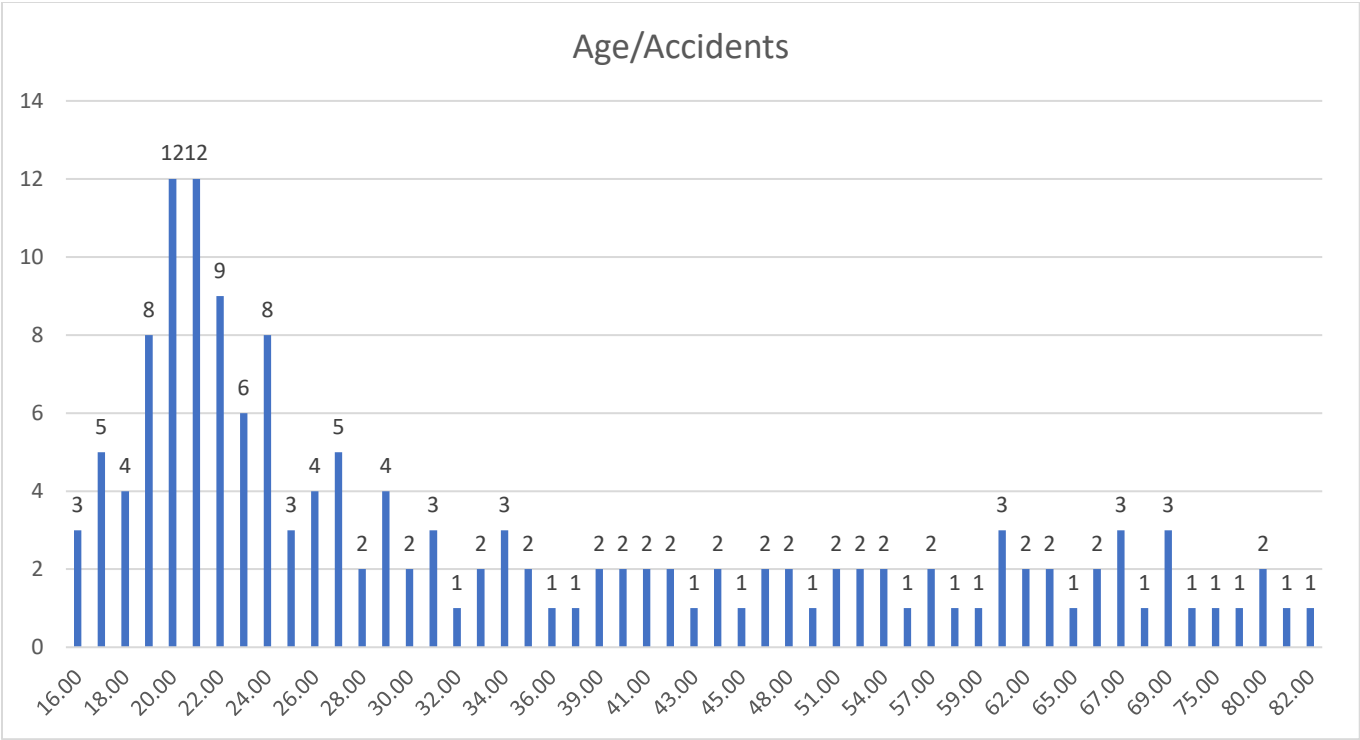
Airbag Deployment



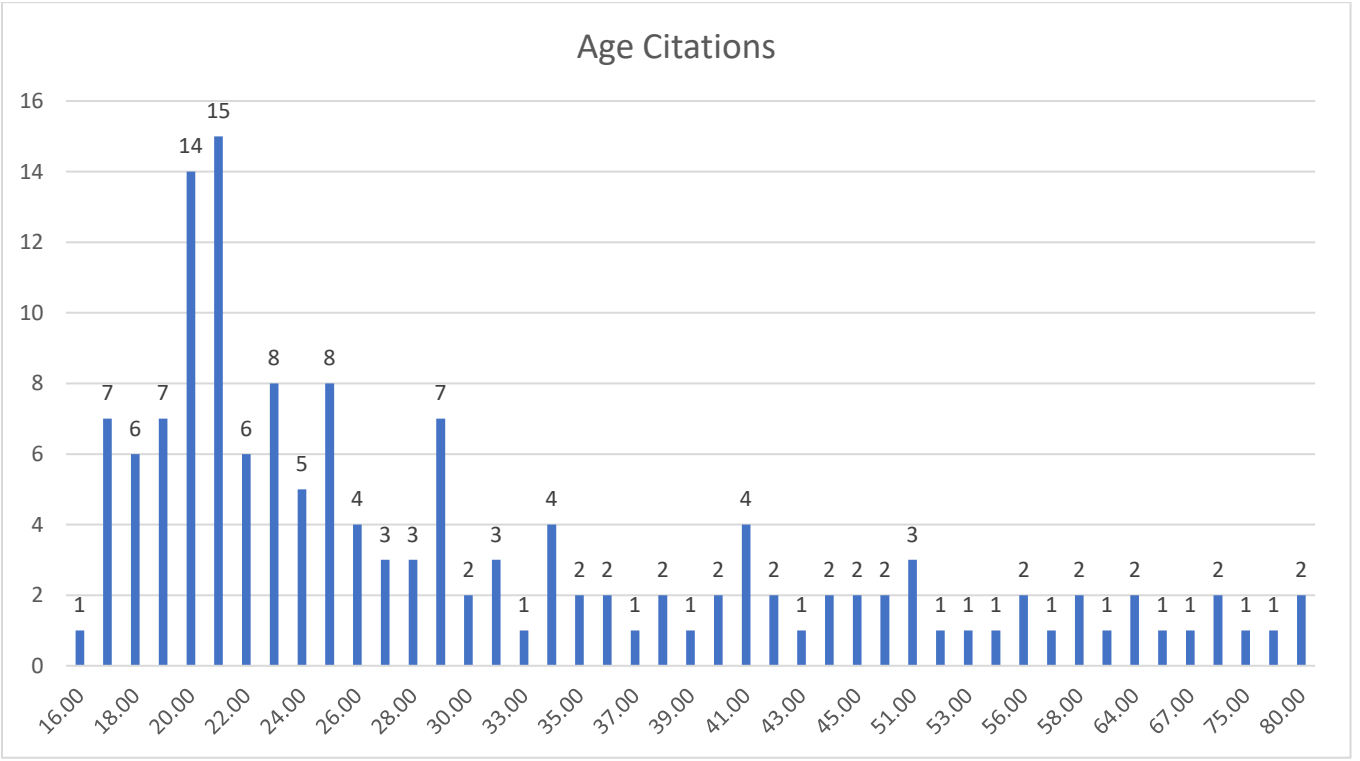

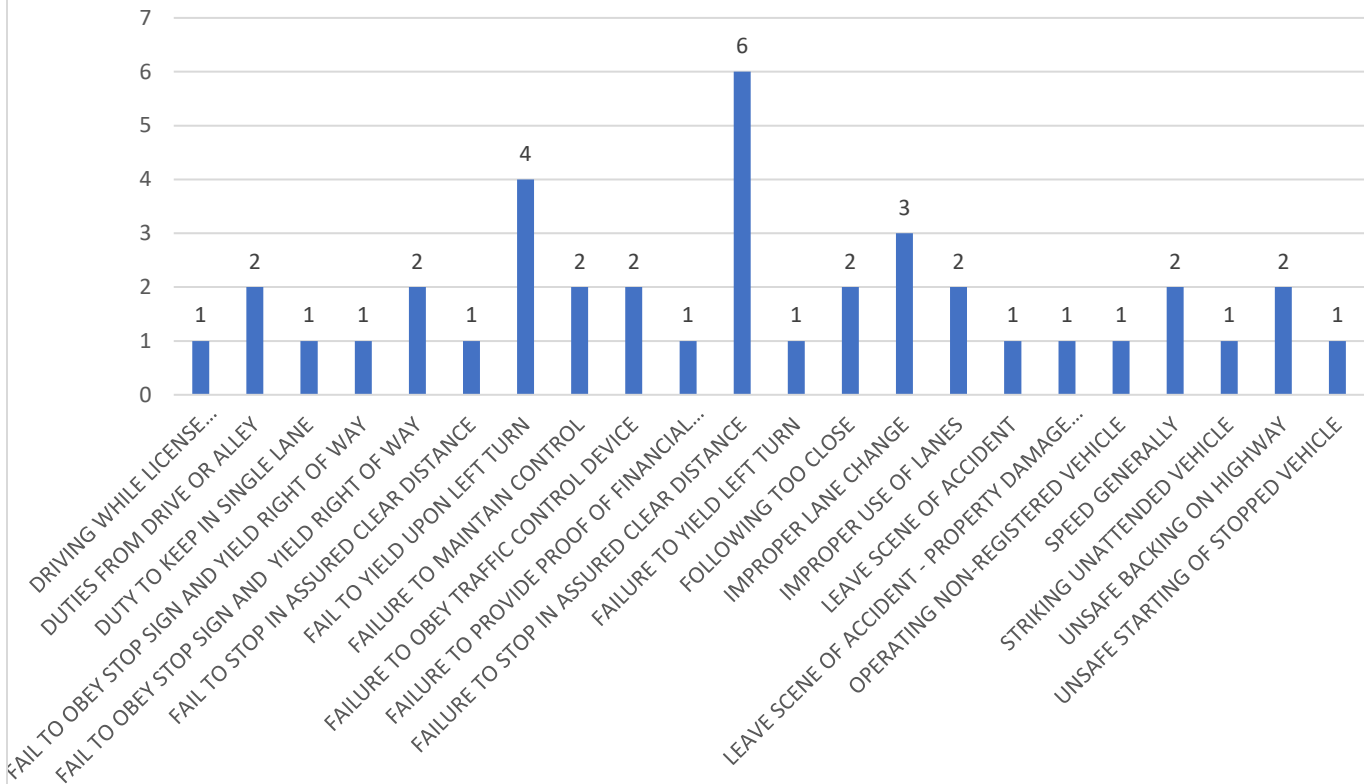

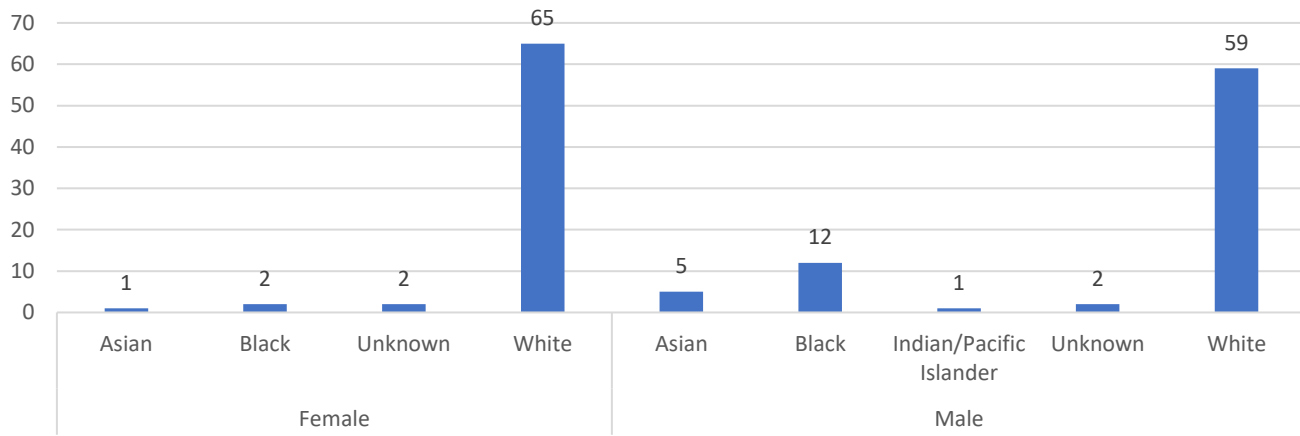
