



**AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT
SEPTEMBER 2021**



SUMMARY

September Training: Officers attended firearms training and annual certification. Our Peer Support Team attended the Peer Support Training Conference. Individual officers attended the National Tactical Officers Association Training Conference, Field Training Officer Certification, Advanced Crime Scene Investigation Training, and Sexual Assault Response and Investigation Training.

September Outreach and Engagement: In September we returned to Iowa State Football. Our officers worked two ISU Football games, September 4 against UNI and September 11 against Iowa. Both weekends were very busy for our officers, Fire Department personnel, and Emergency Medical Services.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject and took him to the ground.

Date: September 3, 2021, at 23:16

Details: Officers were called for a man trespassing. Officers determined the man had an active warrant. The subject attempted to flee and the officer grabbed him, took him to the ground and placed him in handcuffs. The officer sustained minor injuries, cuts and scrapes.

Charges: Out-of-state warrant, Interference with Official Acts, Possession of a Controlled Substance-Methamphetamine, Possession of Drug Paraphernalia

Demographics: 40-year-old white male.

Incident 2:

Use of Force: Drew chemical spray/did not deploy.

Date: September 6, 2021, at 09:37

Details: Officers were called to investigate a suspected domestic abuse situation. When officers arrived, the suspect was uncooperative and attempted to leave. The officer drew their chemical spray and gained compliance without deploying the chemical spray.

Charges: Domestic Abuse Assault, 1st Offense, Interference with Official Acts, Warrant Arrest.

Demographics: Subject one, 27-year-old white male. Subject two, 23-year-old white female.

Incident 3:

Use of Force: Officer deployed Taser, drive stun mode

Date: September 6, 2021, at 16:02

Details: Officers were called to a private residence where a man had driven a car into a yard. The reporting party said the man was acting erratically and believe he may be impaired. The man resisted and the officer used the Taser in drive stun mode to gain compliance and place him into handcuffs.

Charges: Assault on a Peace Officer

Demographics: 32-year-old white male.

Incident 4:

Use of Force: Restrained person while waiting to place into squad car. Date: September 7, 2021, at 09:09
Details: Officers were called to file charges on a person who was violating a no trespass order. Officers grabbed the man and restrained him while waiting to place him into a squad car.
Charges: Trespass
Demographics: 35-year-old white male.

Incident 5:

Use of Force: Restrained juvenile who was causing damage at a school. Date: September 9, 2021, at 11:35
Details: An officer restrained a juvenile at a local school who was actively damaging school property.
Charges (Juvenile Referrals): Criminal Mischief, 5th Degree, Disorderly Conduct, Possession of Tobacco underage.
Demographics: 15-year old male, unknown race.

Incident 6:

Use of Force: Activation of Emergency Response Team. Date: September 10, 2021
Details: The Ames Police Department activated the Emergency Response Team to capture a suspect in a robbery that occurred on September 1st. There was no other force used.
Charges: Robbery, 2nd Degree
Demographics: 34-year old black male.

Incident 7:

Use of Force: Took subject to ground. Date: September 13, 2021, at 01:55
Details: Officers were called to a local hotel for a report of a domestic violence situation. The suspect attempted to flee the area and an officer took him to the ground to place him into handcuffs.
Charges: Disorderly Conduct, Public Intoxication, Interference with Official Act.
Demographics: 24-year-old white male.

Incident 8:

Use of Force: Restrained person while waiting to place into squad car. Date: September 21, 2021, at 01:09
Details: Officers were called to a local bar for a report of a man saying inappropriate things to female employees and patrons and making them uncomfortable. Officers found the man to be intoxicated and he was grabbed and restrained while being placed under arrest.
Charges: Public Intoxication
Demographics: 53-year-old white male.

Incident 9:

Use of Force: Restrained person and took them to the ground during arrest. Date: September 28, 2021, at 07:25
Details: Officers were called to investigate several burglaries. The suspect was identified. The man resisted arrest and officers took the man to the ground where he was handcuffed.
Charges: Burglary 3rd Degree, Interference with Official Acts, Driving Under Suspension.
Demographics: 41-year-old white male.

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file

charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

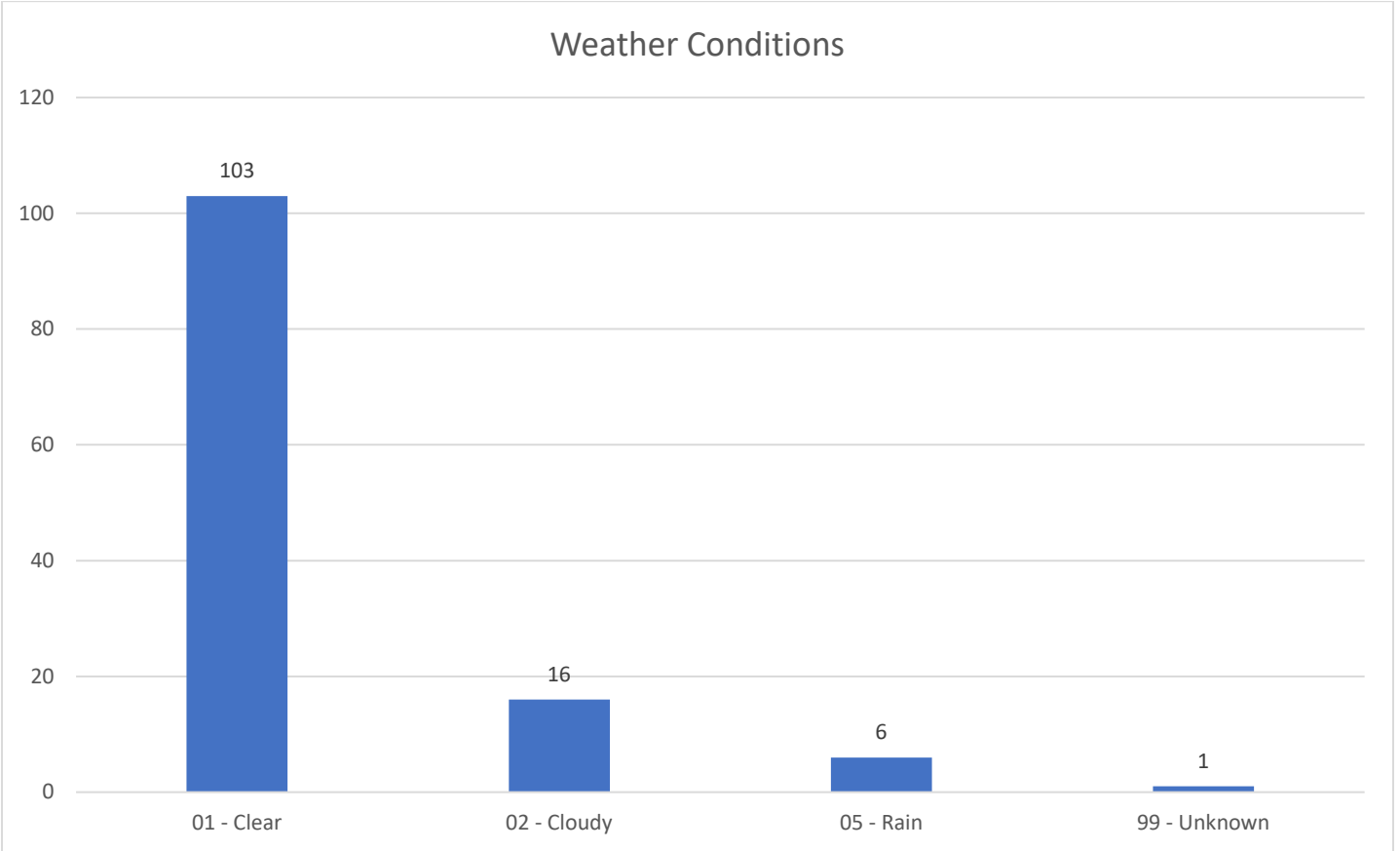
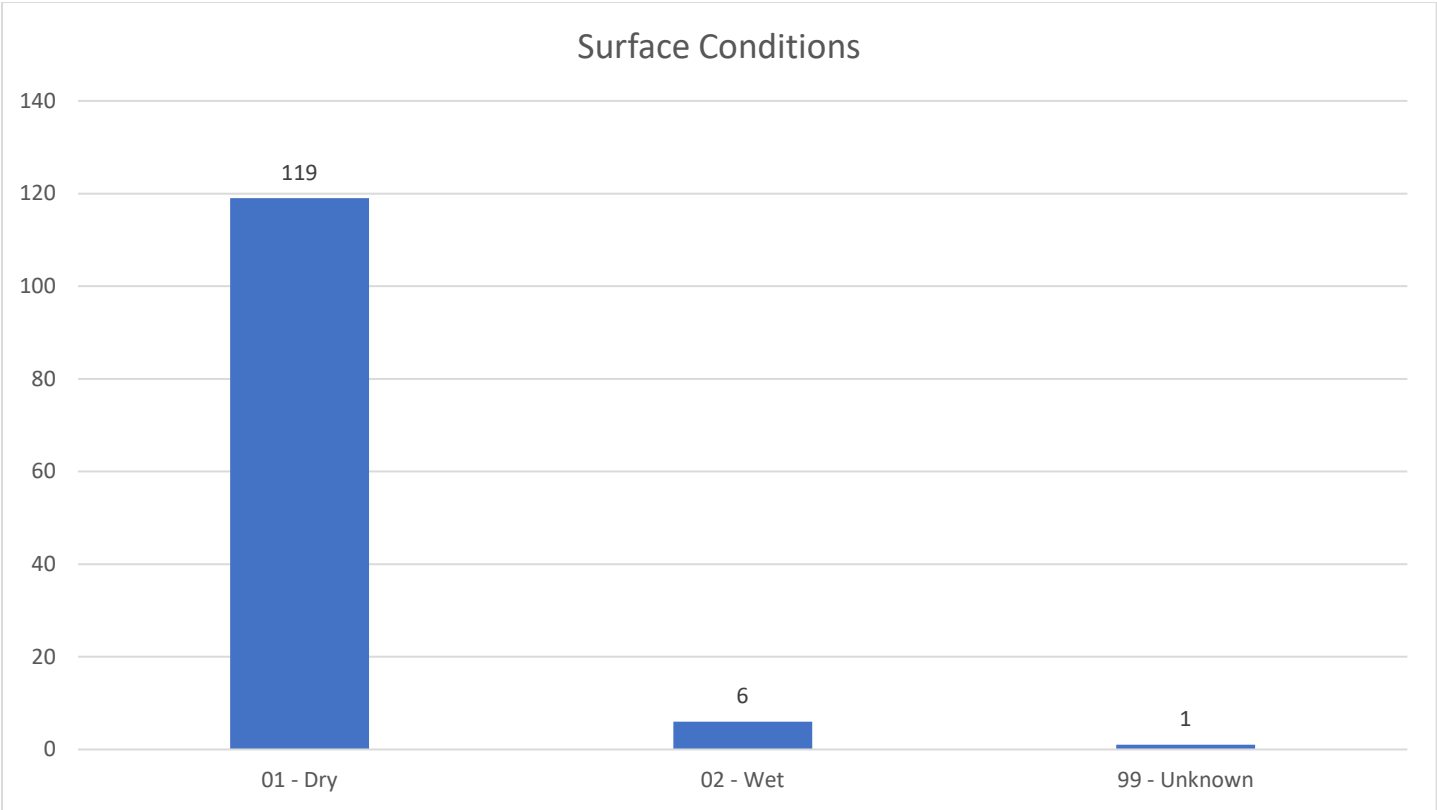


Manner of Crash

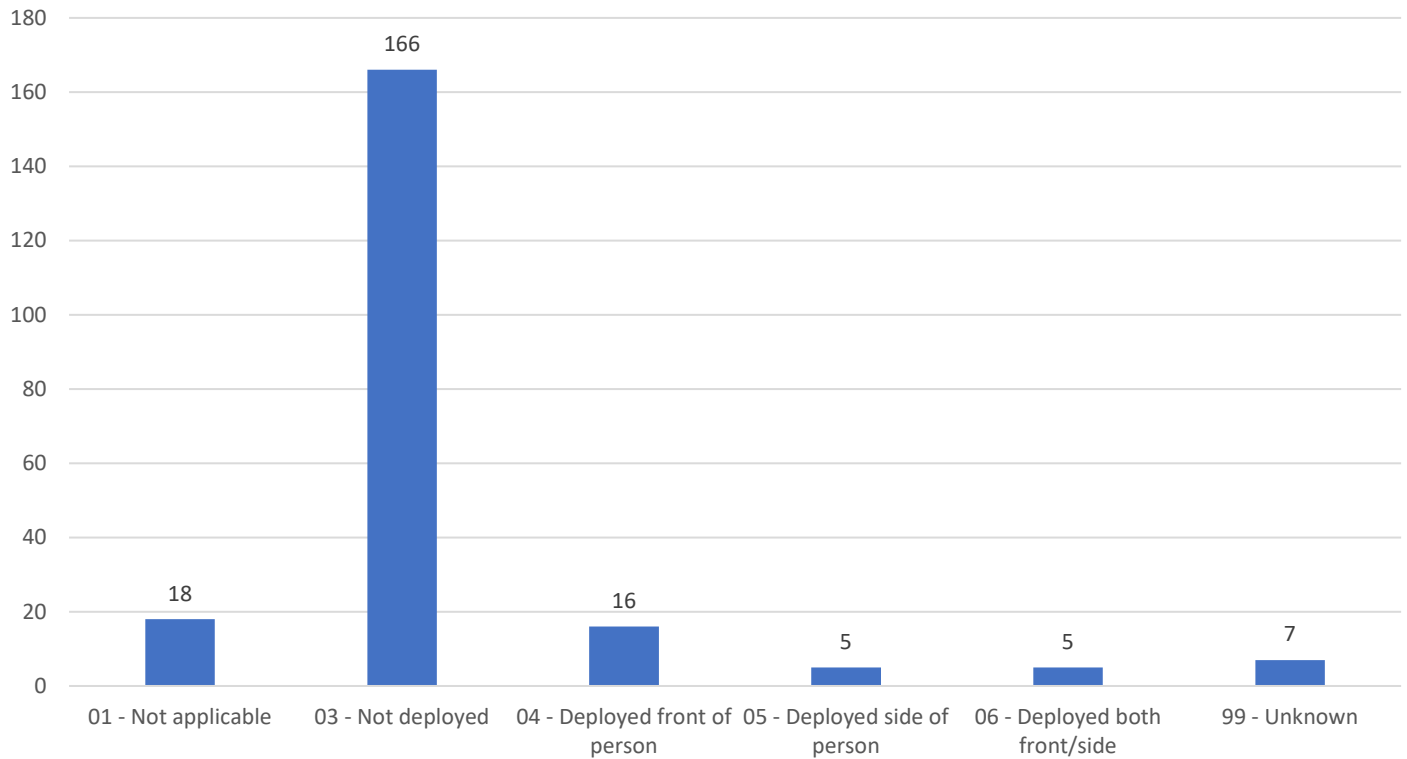
