# AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT October 2021



#### **SUMMARY**

October Training: Two investigators attended an advanced Homicide Investigation School. Officers also attended Response to Mass Casualty Incidents Training.

October Outreach and Engagement: Officers worked two lowa State University football games including the win against #8, Oklahoma State. The Chief of Police participated in a forum at lowa State as a part of their lecture series on October 14. We provided a tour of the Police Department for Ames Community Preschool Center. Officers attended a block party at Webster and Dickenson Streets. Our Community Resource Officer attended an Athletic Career Fair and a Crime Free Housing Event on Lincoln Way. He is also currently running our Citizens Police Academy. Officers attended a vigil for the victim of a crime. An officer conducted robbery response training at a local bank. A number of officers attended Carving With Cops at the Boys and Girls Club. An officer attended a public safety trunk-or-treat event on Mortensen Road.

### **USE OF FORCE DETAIL**

#### **Incident 1:**

Use of Force: Grabbed subject. Date: October 5, 2021, at 13:47

Details: An officer was asked to assist with a juvenile who was destroying property in an office. The officer grabbed the

juvenile to stop the destruction of property and the juvenile stopped and remained cooperative.

Charges: None

Demographics: 15-year-old female, race unknown

#### Incident 2:

Use of Force: Grabbed subject and pressed them against squad car.

Date: October 10, 2021, at 02:30

Details: An officer responded to a report of a man assaulting a female. Security guards had also responded, and the officer witnessed the man tackling one of the security guards. The officer grabbed the person and put him in handcuffs and later pressed him against the car as the man attempted to spit on the officers.

Charges: Disorderly Conduct and Public Intoxication

Demographics: 21-year-old white male

#### Incident 3:

Use of Force: Took subject to ground to make an arrest. Date: October 25, 2021, at 01:26

Details: Officers stopped a man who was knocking on the door of a private residence and the residents did not know who he was and stated he was acting suspiciously. Officers located the subject and questioned him about the incident. The subject appeared to be intoxicated and attempted to run from officers. The officers took the subject to the ground and placed him in handcuffs. The subject refused to get up and officers picked him up and placed him in the squad car.

Charges: Public Intoxication, Interference with Official Acts, Providing False Information.

Demographics: 33-year-old white male.

#### Incident 4:

Use of Force: Multiple officers drew weapons. Date: October 29, 2021, at 23:57

Details: Officers responded to a call of shots fired where it was determined a homicide had occurred. Officers drew their

weapons while clearing the area but did not point them at any specific person.

Charges: None/Under Investigation

Demographics:

#### **Incident 5:**

Use of Force: Took subject to ground for handcuffing.

Date: October 30, 2021, at 03:48

Details: Officers responded to a local convenience store where a subject was refusing to pay for merchandise. Officers attempted to deescalate the subject but were unable to. The subject admitted to being intoxicated and threw items in the store. Officers grabbed the subject and took her to the ground and placed her under arrest. The subject kicked one of the officers. While placing the subject into the squad car, she kicked one of the officers again. While transporting the subject, she slipped her handcuffs to the front and assaulted the officer.

Charges: Assault on Peace Officers or Fire Fighter, Harassment 1<sup>st</sup> Degree – Intimidation, Public Intoxication Demographics: 17-year-old black female.

#### **Incident 6:**

Use of Force: Took subject to ground for handcuffing.

Date: October 31, 2021, at 03:13

Details: Officers were called to a local hotel for a report of a subject passed out in the public area of the hotel. Officers located the subject and woke them up. The subject was uncooperative and intoxicated. The subject refused to answer any questions about if he was a guest and he then attempted to walk away. When officers tried to stop him, he tensed up and continued to try to walk away. He was taken to the ground and placed in handcuffs.

**Charges: Public Intoxication** 

Demographics: 57-year-old white male.

<sup>\*</sup>A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
