SUMMARY

November Training: One officer is attending the Iowa Law Enforcement Academy and will graduate in mid-December. Officers attended department resiliency training.

November Outreach and Engagement: We were invited to Delta Upsilon to speak about alcohol use and abuse and sexual assault prevention. A detective did a presentation on crime scene investigation to an ISU class. An officer did a talk at a local business about safety in the workplace. An officer met with a Girl Scout Troop about policing. Several officers attended the Menorah lighting at City Hall. The Chief attended the November NAACP meeting and met with the County Coordination group about an upcoming community ID program.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Took subject to ground Date: November 15, 2021, at 18:44
 Details: Officers were called to a report of a man who was naked in public and appeared to be under the influence. As officers attempted to help the individual, he became assaultive and injured three officers. He was eventually put into custody and transported to the hospital until he was released to the jail. One officer sustained injuries to his ribs from being kicked and was off work for several days.
 Charges: Assault on Peace Officer
 Demographics: 35-year-old white male

Incident 2:

Use of Force: Taser deployment Date: November 16, 2021, at 15:27
 Details: Officers were called to a domestic situation where they determined the male to be the primary physical aggressor. As officers placed the man under arrest, he head-butted one officer and began to fight. Another officer deployed a Taser to gain control of the suspect. Both officers were injured including a concussion to the officer who was head-butted.
 Charges: Domestic Assault with Injury and Assault on a Peace Officer with Injury
 Demographics: 19-year-old black male

Incident 3:

Use of Force: Took subject to ground to make an arrest Date: November 26, 2021, at 17:49
 Details: Officers were assigned to work the ISU football game. Several patrons pointed out a male who appeared to be intoxicated and causing problems. As officers approached, the man picked up a drink. When the officers asked him to put it down, he refused. The officer took the cup away and the person lunged at the officer and put his hands around the officer's neck. They both went to the ground. The other officers assisted in getting the man into custody.
 Charges: Public Intoxication and Assault on a Peace Officer
 Demographics: 39-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
