SUMMARY

December Training: One officer graduated from the Iowa Law Enforcement Academy. Three new officers will be attending the January Academy. The department received annual Use of Force training on Tasers. Officers continue to attend department resiliency training.

December Outreach and Engagement: We took care packages for the homeless provided by First United Methodist Youth Group. We spoke to the staff at a local business about alcohol laws. We were invited to speak about SCAMS and how to identify them. The Chief attended the December NAACP meeting and met with the County Coordination group about an upcoming community ID program. Our officers were joined by other law enforcement and community partners in Shop with a Cop 2021. Our Mental Health Advocate continues to teach Mental Health First Aid to community members. Communications staff presented on Emergency Medical Dispatch (EMD) procedures at Hach Chemical to their employees.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Use of wristlock on an uncooperative arrestee

Date: December 1, 2021, at 10:10

Details: Officers were called to reports of a male who had stolen a can of air duster and entered a delivery truck. As officers came into the area, the suspect was called in as being intoxicated at a local convenience store. The subject appeared to be intoxicated and was placed under arrest. The subject was uncooperative and went limp at which time an officer used a wristlock to place the subject into the patrol car.

Charges: Public Intoxication

Demographics: 33-year-old white male

Incident 2:

Use of Force: Taser deployment/Took subject to ground

Date: December 5, 2021, at 16:35

Details: While an officer was performing routine traffic control, the officer witnessed a bicyclist ride out in front of vehicles almost causing an accident. The officer stopped the subject and requested identification for violation of a traffic ordinance. The subject was uncooperative from the start of the interaction. He refused to show identification as required and eventually tried to walk away. The officer attempted to stop the subject and the subject pulled away and pushed the officer. The officer deployed a Taser; however, it was ineffective. Once another officer arrived, both officers took the subject to the ground and were able to take him into custody.

Charges: Interference with Official Acts, Possessing Contraband, Failure to Obey Stop Sign

Demographics: 47-year-old white male

Incident 3:

Use of Force: Pointed firearm at subject

Date: December 19, 2021, at 01:00

Details: Officers located a stolen vehicle and attempted to stop the vehicle. The driver refused to stop, and officers continued to follow it until it eventually stopped in a parking garage after the short pursuit. The driver exited the vehicle and started to walk towards the officers. Officers ordered the man to stop at gunpoint which he did. He was placed into custody without further incident.

Charges: Theft 1st (Theft of a Motor Vehicle), Eluding, OWI 3rd Offense, Driving While Revoked, Providing False Information and 3 Warrants.

Demographics: 34-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

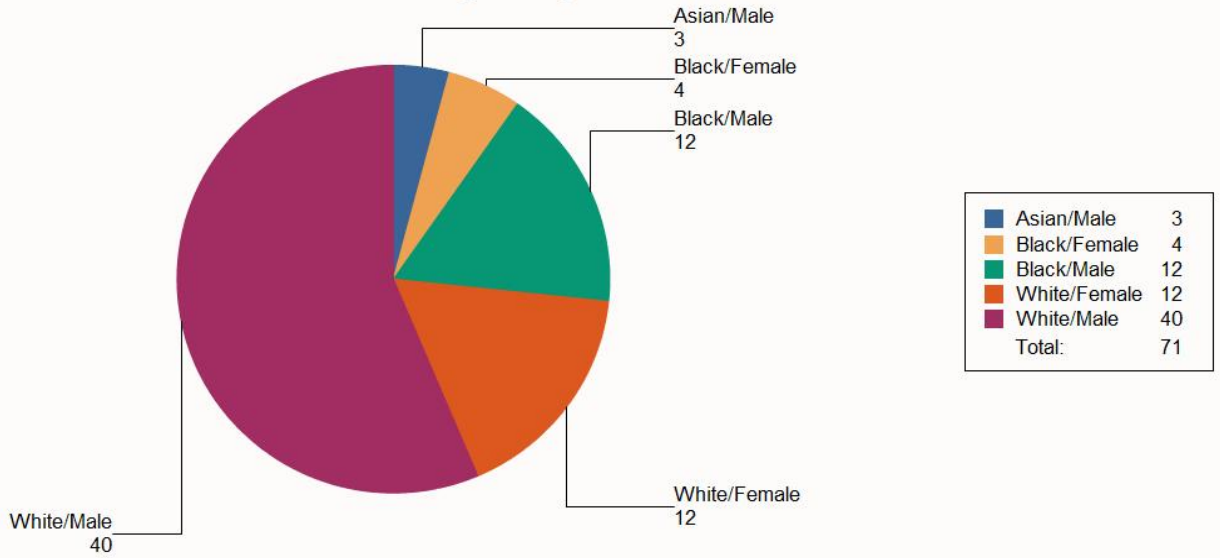

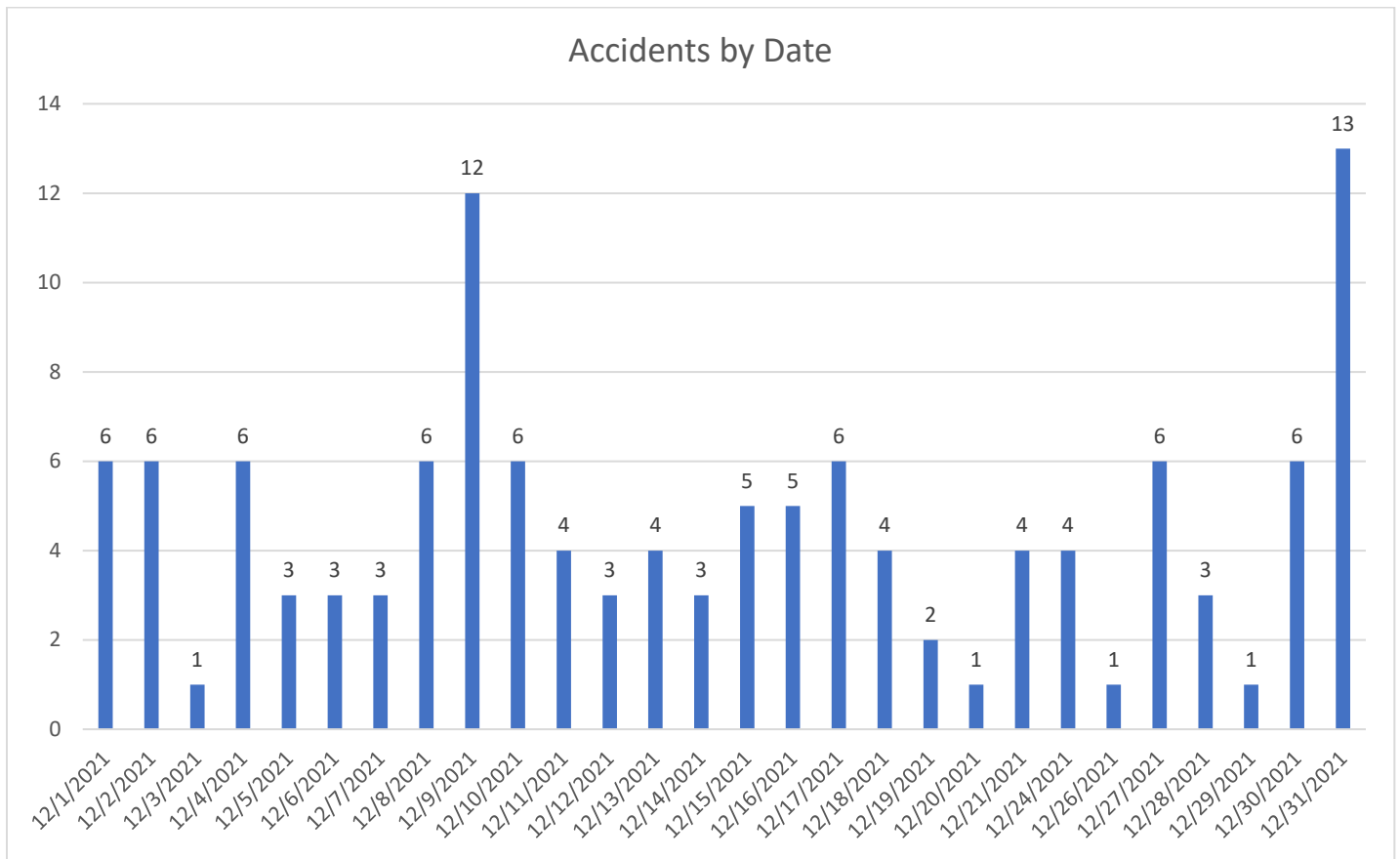

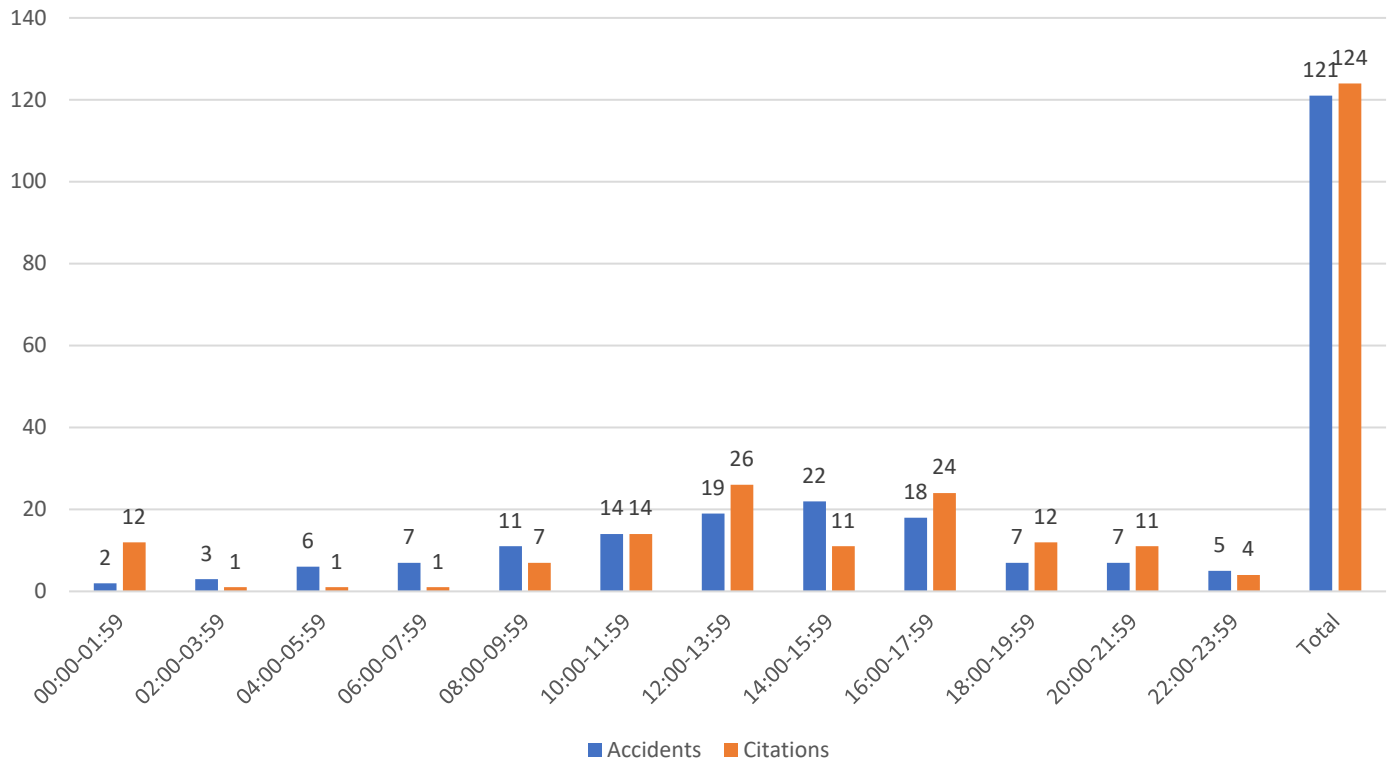
Arrests/Charges by Race/Gender



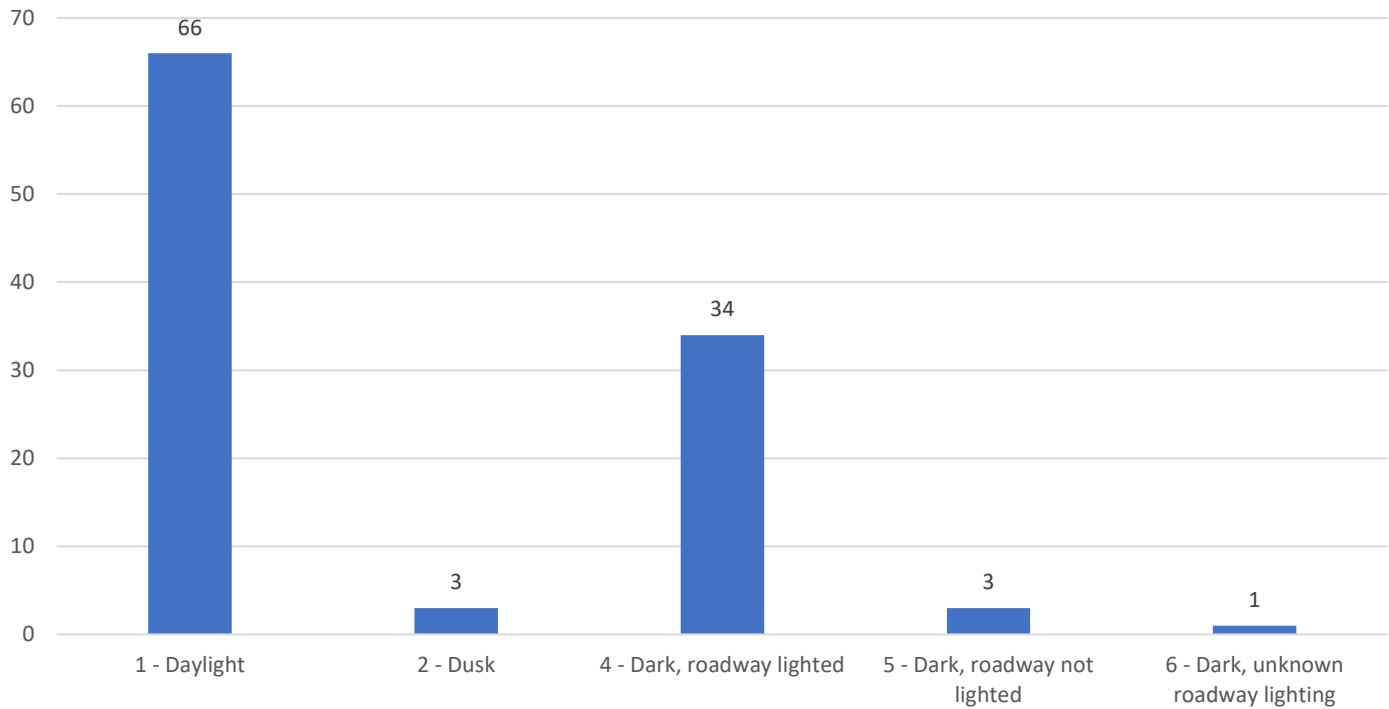

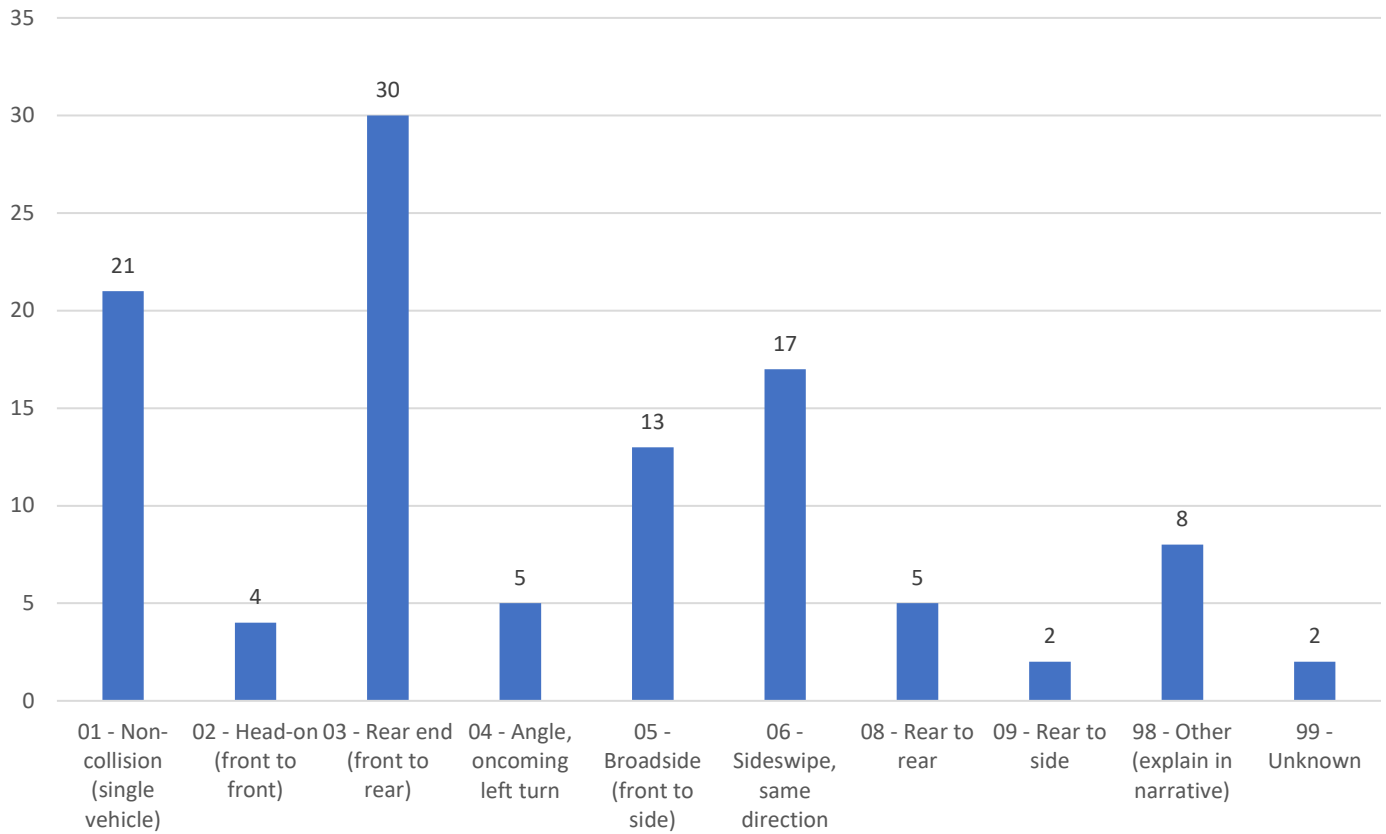
Time/Accidents and Citations



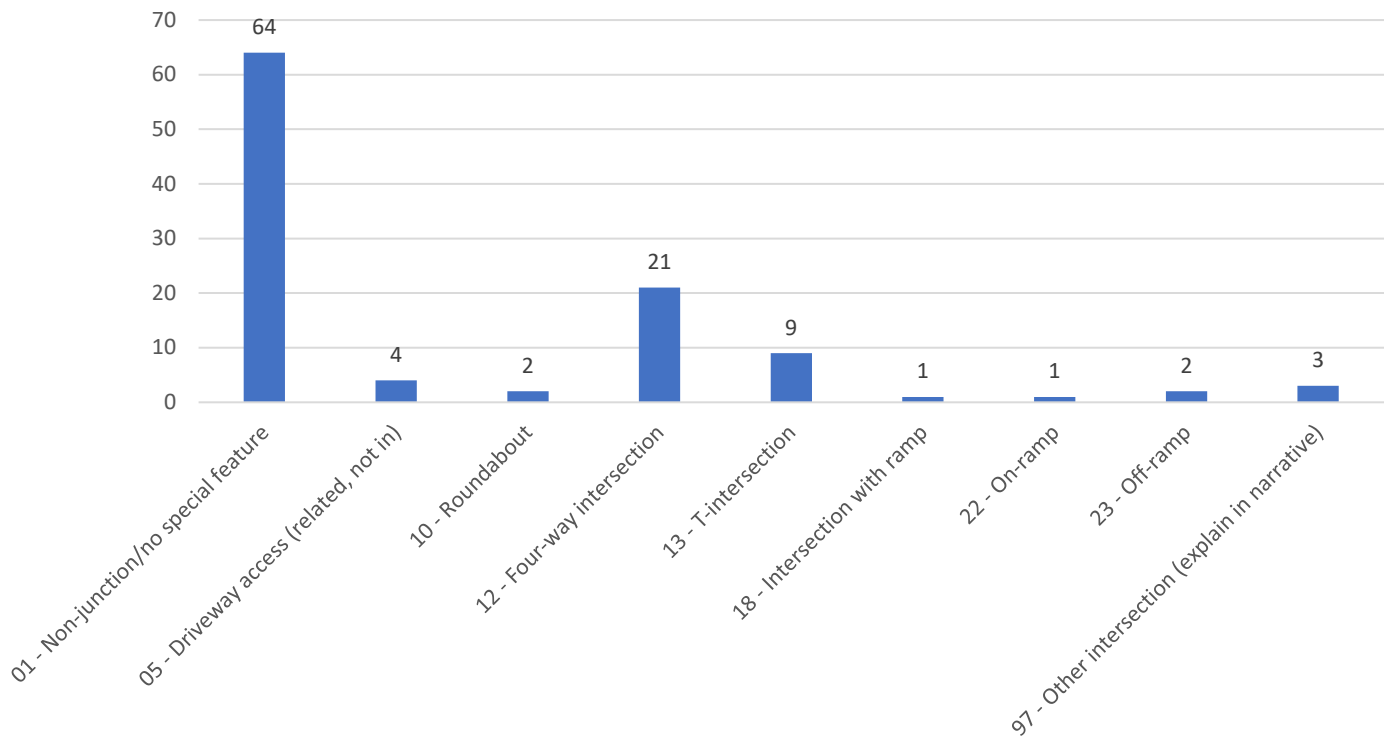
Light Conditions



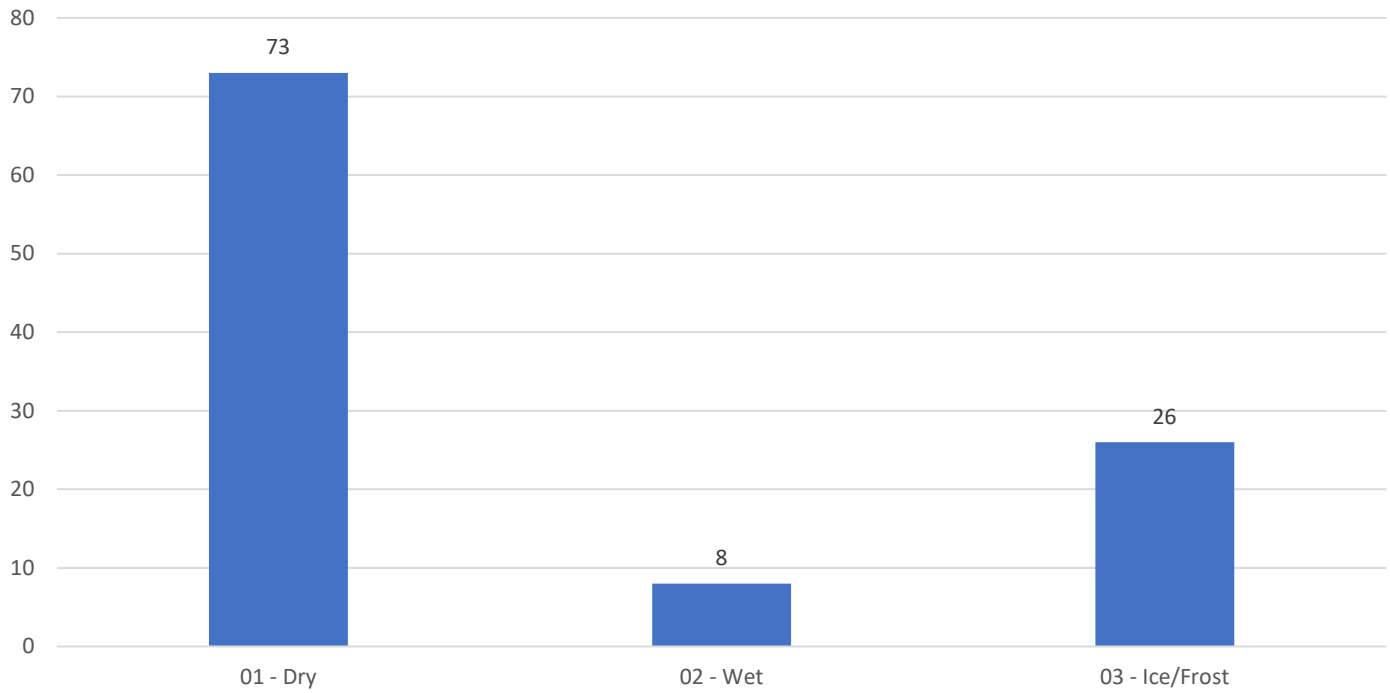
Manner of Crash



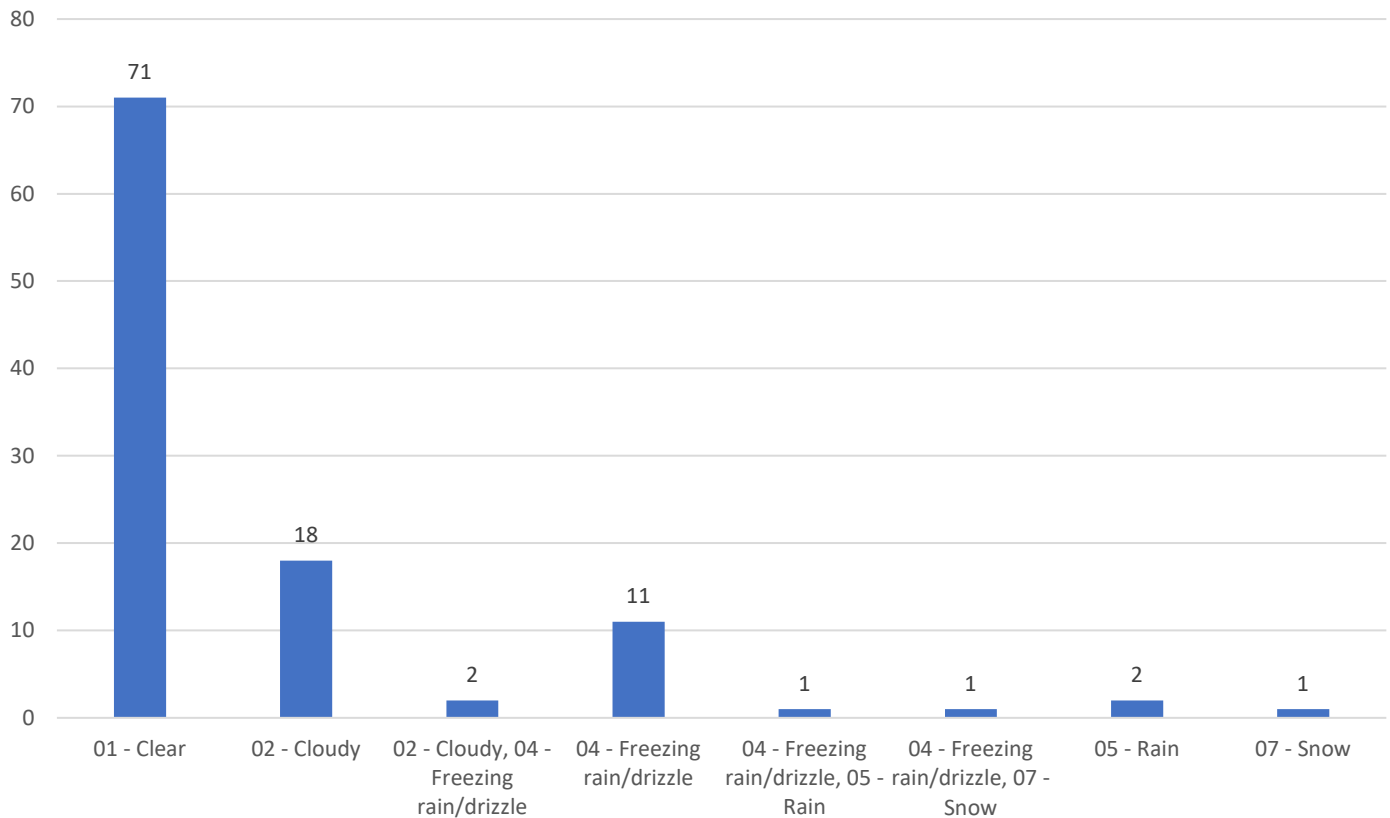
