January Training: Three new officers are attending the Iowa Law Enforcement Academy. Two new officers are completing the field training program. Officers attended the Heartland Tactical Officers Conference. An officer attended a narcotics investigation class. Officers continue to attend department resiliency training.

January Outreach and Engagement: An officer conducted outreach to homeless persons with Bridge Home staff. An officer attended a neighborhood meeting for a town home community. The Chief attended the January NAACP meeting and met with the County Coordination group about an upcoming community ID program. Our Mental Health Advocate continues to teach Mental Health First Aid and Resiliency to community members.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Taser display/Took subject to the ground Date: January 1, 2022, at 02:52

Details: Officers were called to reports of a naked male who was banging on doors and screaming in the hallways of an apartment building. Friends of the subject told dispatchers he consumed psilocybin mushrooms and LSD. An officer contacted the subject and noted he was walking thru broken glass on the floor. The officer attempted to speak with the subject, but he charged at the officer. The officer displayed his Taser and gave the subject verbal commands to stop. The subject failed to stop and eventually grabbed the officer's body camera. The officer holstered his Taser and grabbed the subject's arm to place him in handcuffs. The subject attempted to pull away and was taken to the ground. The subject was handcuffed and transported to the hospital for a medical evaluation.

Charges: None

Demographics: 20-year-old white male

Incident 2:

Use of Force: Grabbed subject Date: January 1, 2022, at 08:48

Details: A convenience store clerk reported a female subject was being disruptive and refused to leave the store. Officers contacted the female who was not wearing shoes and was speaking incoherently. The officers had the female sit in a chair as they spoke with her. The female stood up, grabbed an officer, and pulled the officer toward her. The female was pushed away and placed in handcuffs. She was transported to the hospital for a medical evaluation. The female was released from the hospital later in the day. She refused to walk to the squad car therefore she was carried to the car. She was transported to the jail.

Charges: Assault on a police officer and four warrants

Demographics: 19-year-old black female

Incident 3:

Use of Force: Grabbed subject

Date: January 2, 2022, at 14:14

Details: A citizen reported a female entered their apartment without permission. Officers located the subject inside the apartment. The female displayed signs of intoxication. She admitted that she drove to the apartment. She was arrested and transported to the police department. She slipped a restraint cuff and charged at an officer in the booking room. Officers grabbed the subject and handcuffed her behind her back. She was transported to the jail.

Charges: Public intoxication and interference with official acts

Demographics: 32-year-old white female

Incident 4:

Use of Force: Grabbed subject/Took subject to ground

Date: January 4, 2022, at 14:47

A property owner reported there were several homeless individuals who were trespassing inside his unoccupied house. Officers approached the house and knocked on the door. A male and female exited the residence. Both admitted they moved into the residence several days earlier to get out of the cold. They were arrested for burglary. As officers attempted to handcuff the female subject, she pulled away, flailed her arms, and refused to comply with officers. Officers took her to the ground and attempted to place her hands behind her back. She kicked an officer and was finally handcuffed behind her back. An officer suffered scrapes and abrasions due to her actions.

Charges: Burglary 3rd degree, interference with official acts causing bodily injury

Demographics: 32-year-old white female

Incident 5:

Use of Force: Grabbed subject/Took subject to ground

Date: January 4, 2022, at 23:40

An officer conducted a traffic stop. There were two occupants in the vehicle. The male driver provided a false name. Officers asked him to step out of the vehicle. The male exited the vehicle and ran from officers. An officer ran after him and grabbed his shirt. The male hit the officer's arm in an attempt to get away. The officer wrapped his arms around the male, and they fell to the ground with the male on top of the officer. The male elbowed another officer in the face as he continued to resist arrest. As officers were struggling to take the male into custody, the female passenger approached them and tried pull the male away from the officers. Officers gave her verbal commands to stay away but she failed to comply. An officer pushed her away, but she continued to interfere with the arrest of the male. An officer struck the female. The female finally walked away and got into the vehicle. She fled in the vehicle. The officers gained control of the male and handcuffed him behind his back. Both officers were injured. A short time later the female called in reports of shots fired to divert officers from the arrest of her friend.

Charges: Interference with official acts causing injury (two counts), assault on a police officer, providing false information, driving under suspension, false report to police officers

Demographics: 23-year-old white male and 21-year-old white female

Incident 6:

Use of Force: Pointed patrol rifle at subject

Date: January 28, 2022, at 15:22

A citizen reported a female family was causing damage and trying to break into their house. The citizen reported the female was carrying a firearm. Officers located the female outside the residence. The female was holding an AR style rifle in her hand. Officers asked her to drop her weapon multiple times, but she refused. She told officers to shoot her. The female racked the slide on the gun and walked towards officers. An officer pointed his patrol rifle and told her stop. The female stopped but continued to yell. The female eventually dropped the firearm, and she was handcuffed. The firearm was determined to be a BB gun. The female was transported to the hospital for a medical evaluation.

Charges: None

Demographics: 28-year-old white female

Incident 7:

Use of Force: Grabbed subject

Date: January 29, 2022, at 01:40

An officer conducted a traffic stop. When contacting the male driver, the officer noted the smell of burnt marijuana coming from the vehicle. The officer also noticed a glass pipe in the rear seat of the vehicle. The officer told the driver he smelled burnt marijuana and asked the driver to step out. The driver refused to get out. The officer opened the door and the driver stepped out. The officer told the driver to put his hands behind his back because he was being detained for an investigation. The driver tensed his arm and put it in front of his body. The driver continued to resist but was finally handcuffed behind his back.

Charges: Interference with official acts, possession of drug paraphernalia, possession of controlled substance

Demographics: 18-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

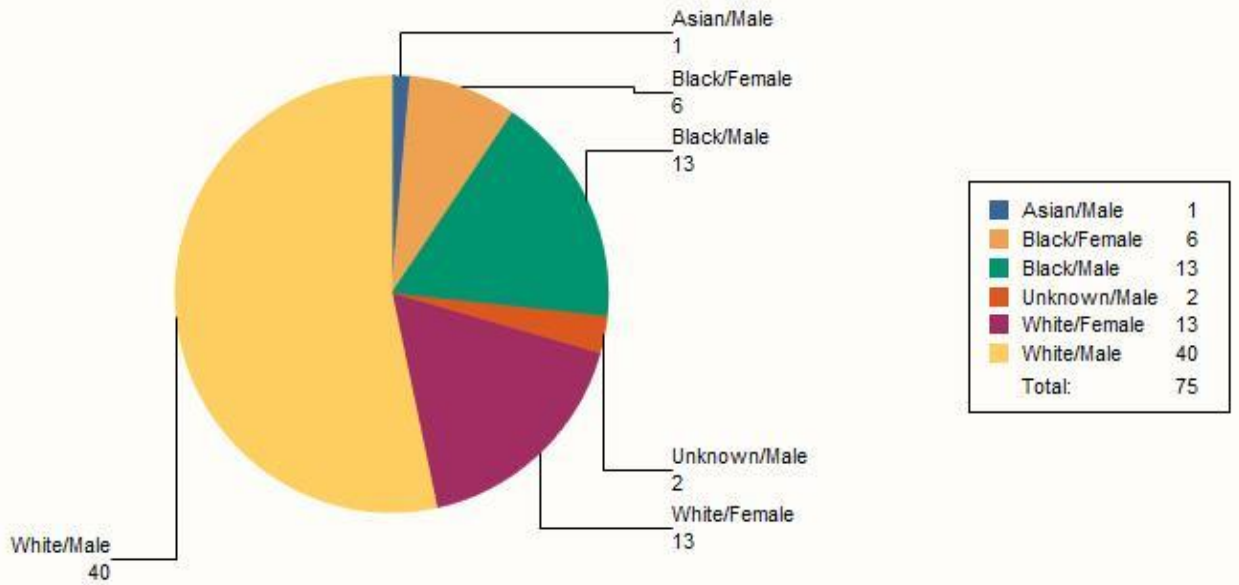

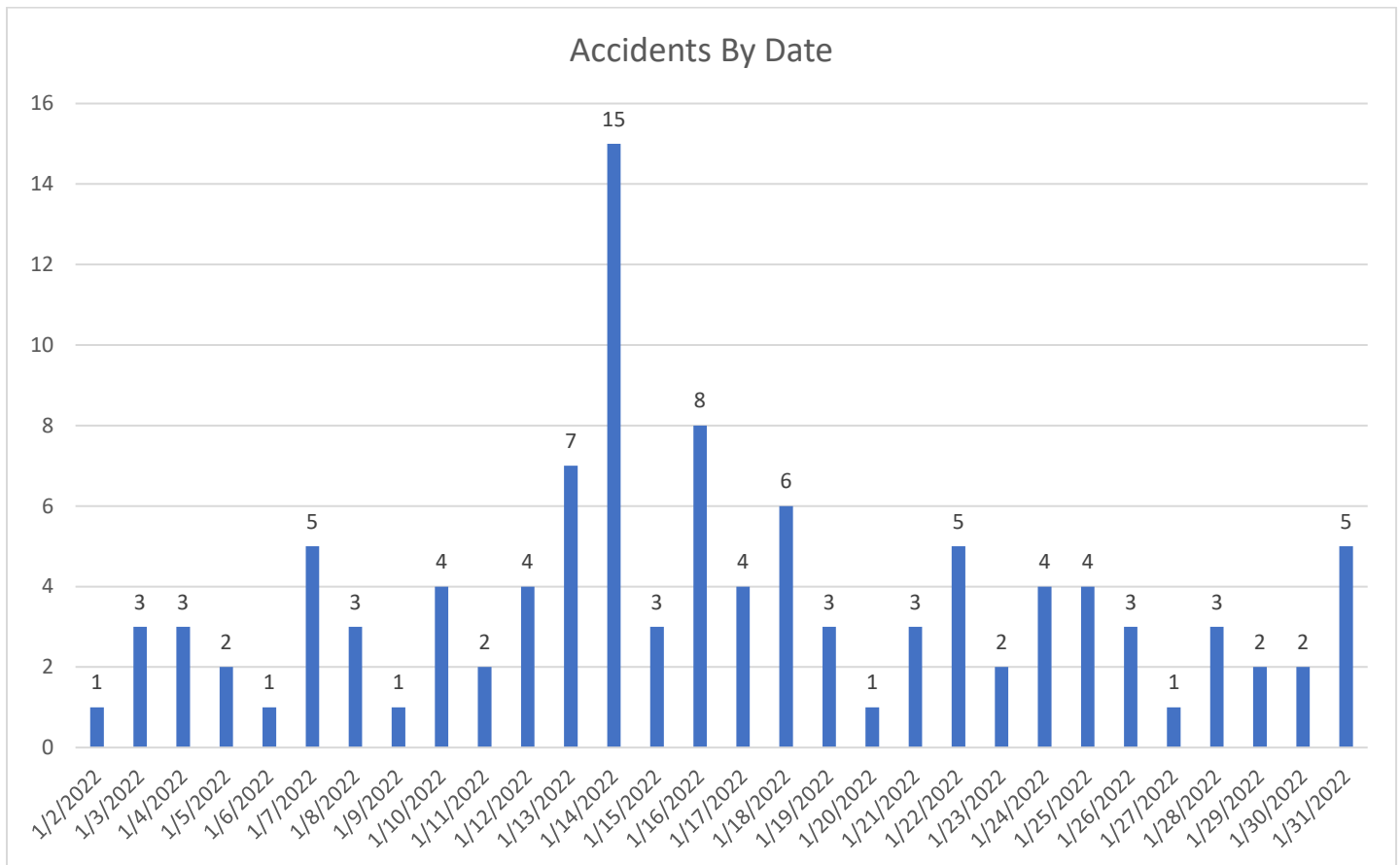

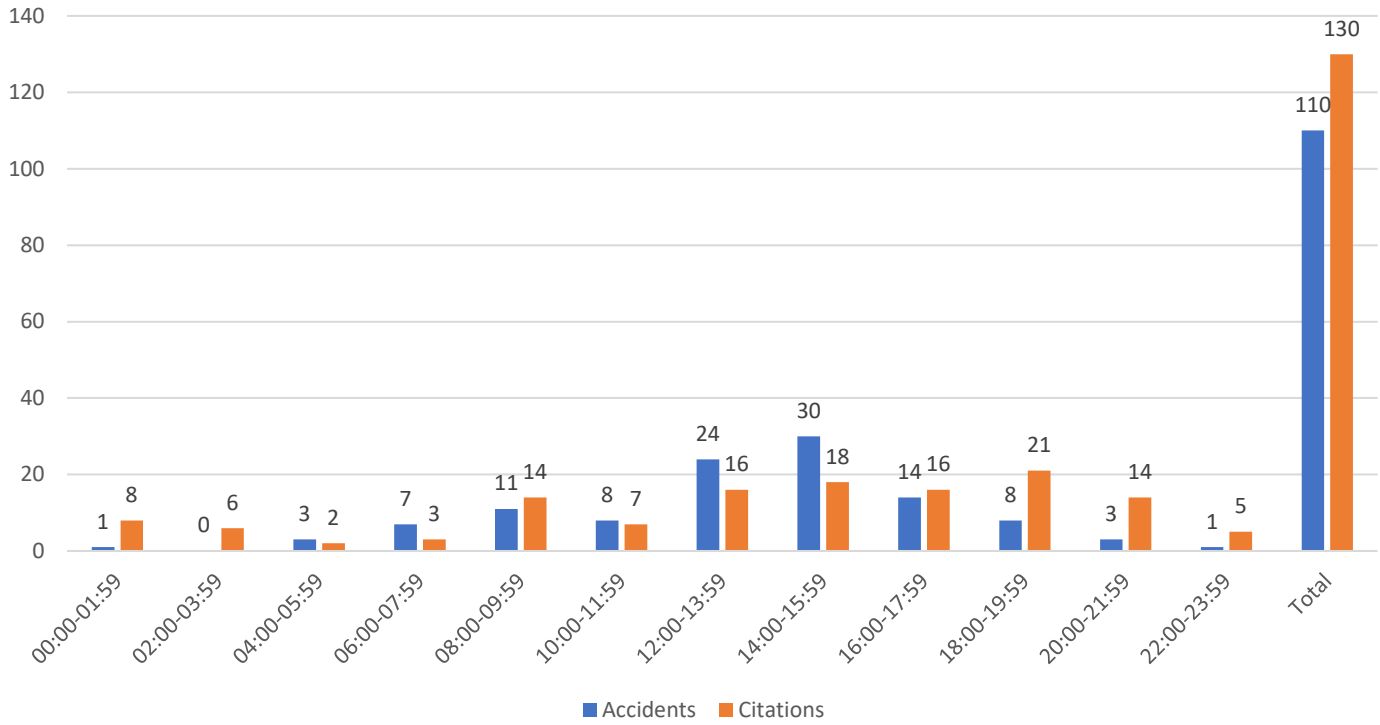
Arrests/Charges by Race/Gender



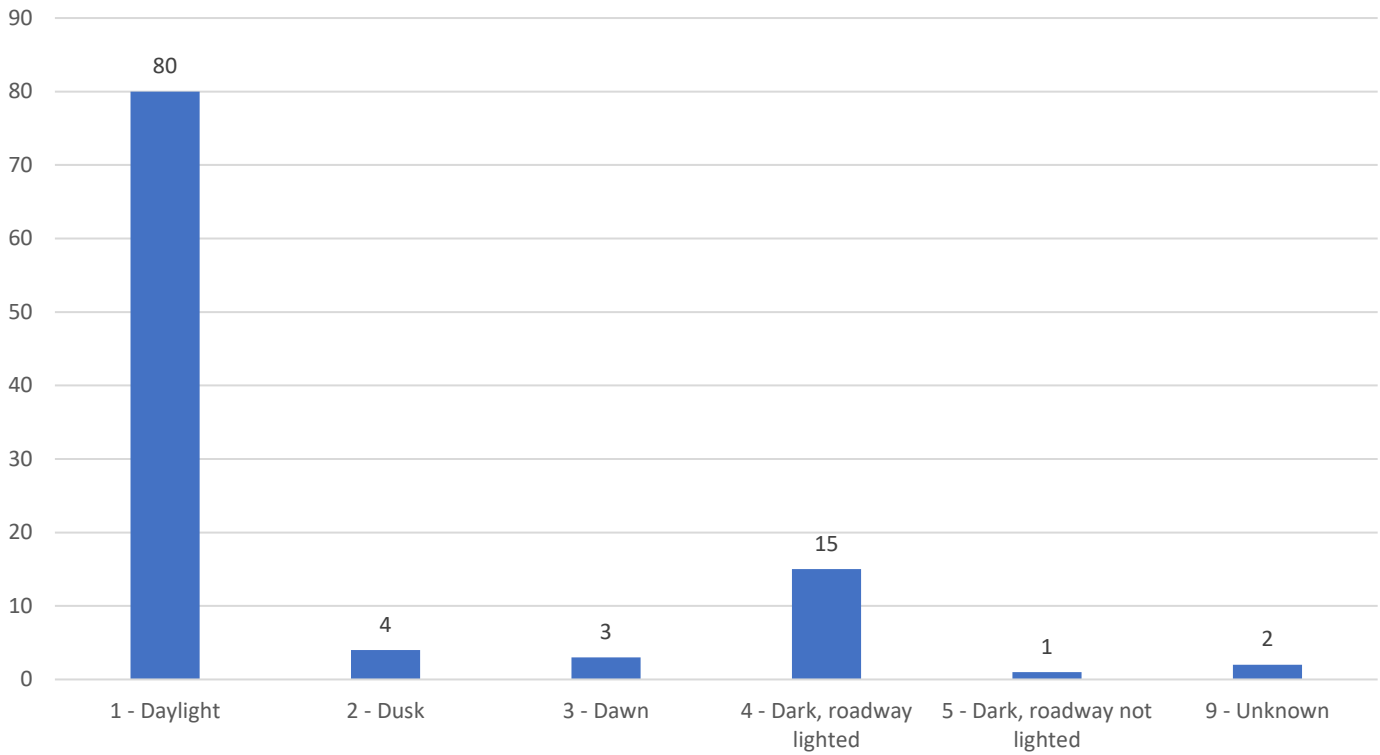
