# AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT February 2022



#### **SUMMARY**

February Training: Three new officers are attending the Iowa Law Enforcement Academy. Two new officers are completing the field training program. Officers attended realistic de-escalation and Hazmat training. Several officers attended the Iowa Police Officers Association conference. Detectives and several patrol officers attended a death investigation on-line seminar.

February Outreach and Engagement: Officers conducted tours for high school students in DMAAC criminal justice classes. Command staff attended the NAACP banquet. A supervisor conducted situational awareness training for city employees. A supervisor attended the Opioid Task Force meeting. Officers attended the Boys and Girls Club gala. Our Mental Health Advocate continues to teach Mental Health First Aid and Resiliency to community members.

### **USE OF FORCE DETAIL**

# **Incident 1:**

Use of Force: Grabbed subject/Took subject to the ground Date: February 6, 2022, at 03:02 Details: Officers were called to an apartment building for a male who was banging on doors and looking through cars. When officers arrived, a witness told the officers the male was passed out in the hallway of the building. Officers contacted the man, who displayed signs of intoxication. He stated he did not know where he was. Officers attempted to handcuff him, but he pulled away and ran from the officers. Officers grabbed him again and he continued to try to flee. Officers took him to the ground and handcuffed him behind his back. He was transported to the police department and evaluated by medical personnel. He was cleared and transported to the jail. He also had an outstanding arrest warrant for driving while suspended.

Charges: Public intoxication and interference with official acts

Demographics: 20-year-old Black male

### **Incident 2:**

Use of Force: Pointed firearm and Taser at subject Date: February 7, 2022, at 14:56

Details: Officers conducted a traffic stop on a subject who had an outstanding arrest warrant and was reported to be armed with a rifle, which he was prohibited from possessing. Officers drew their department handguns and pointed them at the driver as they gave him commands to safely exit the vehicle. The driver failed to obey their commands. Another officer pointed a Taser at the driver. The driver complied with officers and was taken into custody without further incident. Methamphetamine was located in his pocket. He was transported to the jail.

Charges: Warrant arrest and possession of a controlled substance

Demographics: 40-year-old White male

# Incident 3:

Use of Force: Pointed firearm at suspect

Details: A clerk reported an armed robbery at a convenience store. The clerk reported the suspect displayed a knife and stole items from the store. An officer located a vehicle containing the suspect on S. Duff Avenue a short time later. Officers pointed their department handguns at him as he exited the vehicle with a knife in his hand. The suspect dropped the knife and was handcuffed.

Date: February 9, 2022, at 04:35

Charges: Robbery 1st degree, trespass, possession of controlled substance-3rd offense

Demographics: 28-year-old Black male

# Incident 4:

Use of Force: Grabbed subject Date: February 12, 2022, at 23:06

A parent reported their adult son was destroying their home and acting in an irrational way. When officers arrived, a parent was holding their son down to avoid further damage. Officers attempted to communicate with him, but he continued to respond incoherently. Paramedics attempted to assess him, but he was physically uncooperative. Officers grabbed his arms and he attempted to pull away from them. He was handcuffed for his safety while the paramedics provided medical care. An officer rode in the ambulance during transport. The handcuffs were removed at the hospital.

Charges: None

Demographics: 25-year-old White male

# **Incident 5:**

Use of Force: Grabbed subject Date: February 20, 2022, at 23:48

An officer responded to a medical call involving an intoxicated female who threatened to harm herself. The officer was summoned into the residence by a paramedic because she was attempting to ingest medication. The officer and paramedics grabbed her arms, but she continued to be physically combative. Officers and paramedics carried her to the stretcher where she was transported by ambulance to the hospital. During transport, an officer handcuffed her due to self-harm actions. The handcuffs were removed at the hospital.

Charges: None

Demographics: 60-year-old White female

# **Incident 6:**

Use of Force: Grabbed subject/Directed subject to ground Date: February 22, 2022, at 18:40

A citizen reported a male was screaming in the backseat of his vehicle. Officers located the male and determined he was displaying signs of intoxication. He climbed into the driver's seat and opened his door. He attempted to start the vehicle to drive away. An officer grabbed the keys from him and attempted to find out where he lived. He was unable to provide this information due to his level of intoxication. While attempting to find a family member to pick him up, he exited his vehicle and stood in the street while only wearing one shoe. He was arrested for public intoxication. While at the police department, he slipped his wrist out of a handcuff on the holding area bench. The officer grabbed his arm and he tried to pull away from the officer, as he told him to comply. The officer was unable to control him, therefore he was directed to the ground. He continued to resist until additional officers arrived. He was handcuffed behind his back and then transported to the jail.

Charges: Public intoxication and interference with official acts

Demographics: 41-year-old Hispanic male

# Incident 7:

Use of Force: Grabbed subject Date: February 23, 2022, at 11:08

Citizens reported a female was preparing to jump off a bridge. When officers arrived, she had been pulled from the bridge by several individuals and was being held down for her safety. An officer attempted to grab her arm, but she continued to pull away. She was handcuffed for her safety. She continued to try to pull away from officers. She was transported to the hospital for a medical evaluation.

Charges: None

Demographics: 15-year-old Hispanic female

# Incident 8:

Use of Force: Grabbed subject Date: February 26, 2022, at 20:06

Officers responded to a construction site where an intoxicated female had attempted to jump from a moving car and locked herself inside a porta potty. She exited and was taken to the hospital for a medical evaluation. She refused to be evaluated and was arrested for public intoxication. While being transported, she intentionally hit her head on the prisoner cage several times. The officer removed her from the squad car and placed her into a transport van. She continued to try to hit her head on the walls of the van. An officer rode in the van with her and held her so she would not continue to hit her head.

Charges: Public intoxication and interference with official acts

Demographics: 41-year-old White female

### Incident 9:

Use of Force: Grabbed subject Date: February 27, 2022, at 00:42

Officers located a female on the ground in front a bar. She had blood on her face and exhibited signs of intoxication. Paramedics responded and she became more agitated and belligerent. She kicked a paramedic several times as medical care was provided on the sidewalk. An officer rode in the ambulance due to the assaultive behavior. She was handcuffed as she continued to flail her arms and legs. Once at the hospital, she had to be held down by officers and medical staff to provide medical care. She was eventually cleared for jail, and she was transported.

Charges: Public intoxication and assault on paramedic

Demographics: 22-year-old White female

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
