March Training: Two new officers are attending the Iowa Law Enforcement Academy and will graduate next week. Three new officers are completing the field training program. All officers attended realistic de-escalation and defensive tactics training. Two officers attended the National Lifesavers Conference. Several officers attended an implicit bias webinar. An officer attended Taser instructor training. An officer and police chaplain attended peer support training.

March Outreach and Engagement: Two officers conducted alcohol compliance checks with Iowa Alcoholic Beverage Division inspectors. An officer presented on alcohol safety to a sorority. An officer attended a Community ID program at St. Cecilia Church. Officers attended the Greek Olympics and Fun Run in the Greek area. Ames officers escorted the state champion, Ames High School basketball team for the state tournament. An officer gave a career presentation to the Scouts at the Izaak Walton League. Citizen Police Academy students are doing ride-along with officers.

#### USE OF FORCE DETAIL

##### Incident 1:

Use of Force: Grabbed subject

Date: March 2, 2022, at 19:01

Details: Officers were called to an apartment building for a verbal fight in the lobby. When officers arrived, a witness said a man was intoxicated and yelling at people. Officers contacted the man, who displayed signs of intoxication and admitted he was drunk. Officers arrested the man for public intoxication. While walking to the squad car, the man attempted to pull away from the officers while screaming at other people nearby. An officer applied a wrist lock to the man to gain control of him until he was placed in the squad car. He was transported to the jail without further incident.

Charges: Public Intoxication

Demographics: 27-year-old White male

##### Incident 2:

Use of Force: Grabbed subject

Date: March 2, 2022, at 12:07

Details: Officers were asked to conduct a welfare check on a female at a motel. Officers discovered the female had two active arrest warrants. An officer saw the female walking in the motel parking lot. She walked away from the officer as he approached her on foot. The female claimed she was not the wanted person and she continued to walk away as the officer gave her commands to stop. The officer caught up to the female after following her on foot for two blocks. The female continued to deny she was the wanted person. The officer grabbed her arm after she failed to comply with his verbal commands. The female attempted to pry the officer's fingers off her arm. Two more officers arrived, and the female was handcuffed behind her back. She finally admitted she was the wanted person. She was transported to the jail.

Charges: Warrant arrest for Voluntary Absence from Custody and OWI-3<sup>rd</sup> offense

Demographics: 45-year-old Black female

**Incident 3:**

Use of Force: Grabbed subject/Held down

Date: March 4, 2022, at 19:56

Details: A shelter reported a female juvenile ran from their facility. ISU police officers located the juvenile on campus. The juvenile said she was trying to find a roof to jump off so she could commit suicide. The juvenile attempted to pull away from officers so they grabbed her arms so she would not run. The juvenile calmed down as officers continued to try to speak with her about her feelings. While waiting for an ambulance, the juvenile attempted to walk away again. An officer grabbed her arm to prevent her from walking away. An officer rode in the ambulance with the juvenile. An officer and a paramedic had to hold her arms down so she would not escape from the safety belts in the ambulance.

Charges: None

Demographics: 15-year-old White female

**Incident 4:**

Use of Force: Pointed duty firearm at subject

Date: March 4, 2022, at 00:31

Marshalltown police asked us to check a local motel for a wanted person with violent tendencies. Officers determined the subject checked into the motel earlier in the night. Officers knocked and announced at the door of the motel room after they heard someone moving around inside the room. The subject would not answer the door. An officer obtained a search warrant to enter the motel room. Officers again knocked and announced their presence, but no one answered the door. The subject attempted to open motel room window to flee the area. Officers entered the room and gave the subject verbal commands while pointing their duty handguns at him. The subject complied and was taken into custody without further incident.

Charges: Warrants x 6 for Probation Violation, Identity Theft and Theft 5th

Demographics: 26-year-old White male

**Incident 5:**

Use of Force: Grabbed subject

Date: March 4, 2022, at 23:59

A taxi driver reported an intoxicated male and female ran from his taxi and failed to pay for their fare on Lynn Avenue. When officers arrived, the male and female subjects were speaking with the taxi driver. The female refused to identify herself or show identification. The female started yelling and threatening the officer. The female showed signs of intoxication, therefore the officer told her she was going to be arrested. The officer grabbed the female's arm, but she tensed up and pulled away. Officers handcuffed the female, but she continued to yell and threaten officers. The female refused to put her feet into the patrol car after several verbal commands to cooperate. Officers pushed her feet into the car and closed the door. The female was transported to the hospital where she continued to yell at officers and medical staff. The female was cleared by medical staff and transported to the jail.

Charges: Public Intoxication

Demographics: 27-year-old White female

**Incident 6:**

Use of Force: Grabbed subject

Date: March 12, 2022, at 00:36

An officer stopped a vehicle for a traffic violation. The driver displayed signs of intoxication. The driver performed poorly on field sobriety tests. The driver was arrested for operating while intoxicated. At the police department, the driver refused to get into a patrol car for transport to the jail. The officers gave him several verbal commands to sit in the patrol car, but he refused. Officers grabbed him by his chest and pushed him into the rear seat of the patrol car. The driver began yelling and thrashing around in the back of the car. He was transported to the jail.

Charges: Operating While Intoxicated  
Demographics: 22-year-old White male

**Incident 7:**

Use of Force: Pointed duty firearm at three subjects Date: March 13, 2022, at 17:57  
Story County deputies requested our assistance with a pursuit that entered north Ames on Hwy 69. An Ames officer located the abandon suspect vehicle on Top O Hollow Road. A short time later, another Ames officer spotted three subjects running through backyards. Dispatch notified the officers that the registered owner of the vehicle was known to be in possession of a firearm. Two officers pursued the subjects on foot while giving them verbal commands to stop and get on the ground. When two officers caught up with the subjects, they drew their duty handguns and continued to tell them to stop. The subjects complied and got on the ground. The two officers waited for additional officers to arrive before handcuffing the subjects.

Charges: Eluding, Reckless Driving, Unlawful Possession of Prescription Pills  
Demographics: 22-year-old Black male, 22-year-old Black male and 18-year-old Black male

**Incident 8:**

Use of Force: Wanted subject taken to ground Date: March 16, 2022, at 17:34  
An officer received a report of a suspicious male waving a knife around. The officer responded to the area and found a man matching the description but did not appear to have a knife. However, the officer did know the person by sight, and he was identified, and the information given to the communications center. The communications center advised the male had active warrants for his arrest. When the officers approached and informed the subject of his warrants and attempted to place him in handcuffs. The man pulled away and struggled to get away. Officers took the man to the ground where they gained control and placed him in handcuffs.

Charges: Warrant – Failure to Appear, Interference with Official Acts  
Demographics: 55-year-old Black Male

**Incident 9:**

Use of Force: Pointed duty firearm at two subjects Date: March 20, 2022, at 01:48  
While on routine patrol, an officer found a vehicle that belonged to person with a warrant. The driver of the vehicle refused to stop when the officer activated his emergency lights. A short distance later after the short pursuit, the vehicle stopped, and the officers pointed their service weapons at the occupants while performing a high risk stop. Both individuals were placed into custody.

Charges: Multiple Warrants (Driving While Suspended X 2, Driving While Barred, Interference with Official Acts, and a No Bond Warrant pending placement in a Residential Facility)  
Demographics: 28-year-old White Male and a 33-year-old White Female

**Incident 10:**

Use of Force: Grabbed subject Date: March 26, 2022, at 01:55  
Officers were alerted to a fight occurring on Welch Avenue at Chamberlain. Officers went to the area and located individuals actively fighting. Officers separated the individuals involved. One of the individuals pulled away as the officer attempted to arrest him. Another officer assisted as the male was pushed the male into a fence to gain control and handcuff the individual.

Charges: Public Intoxication

Demographics: 22-year-old White Male

**Incident 11:**

Use of Force: Grabbed subject

Date: March 26, 2022, at 23:59

Officers responded to a domestic situation. The male half entered the residence of the female half without permission and threatened her. Officers investigated and made an arrest on the male. While in the process of the arrest, the male pulled away and the officer grabbed him to place him into handcuffs.

Charges: Burglary 3<sup>rd</sup> Degree, Theft 5<sup>th</sup> Degree, Warrant Arrest

Demographics: 27-year-old Black Male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

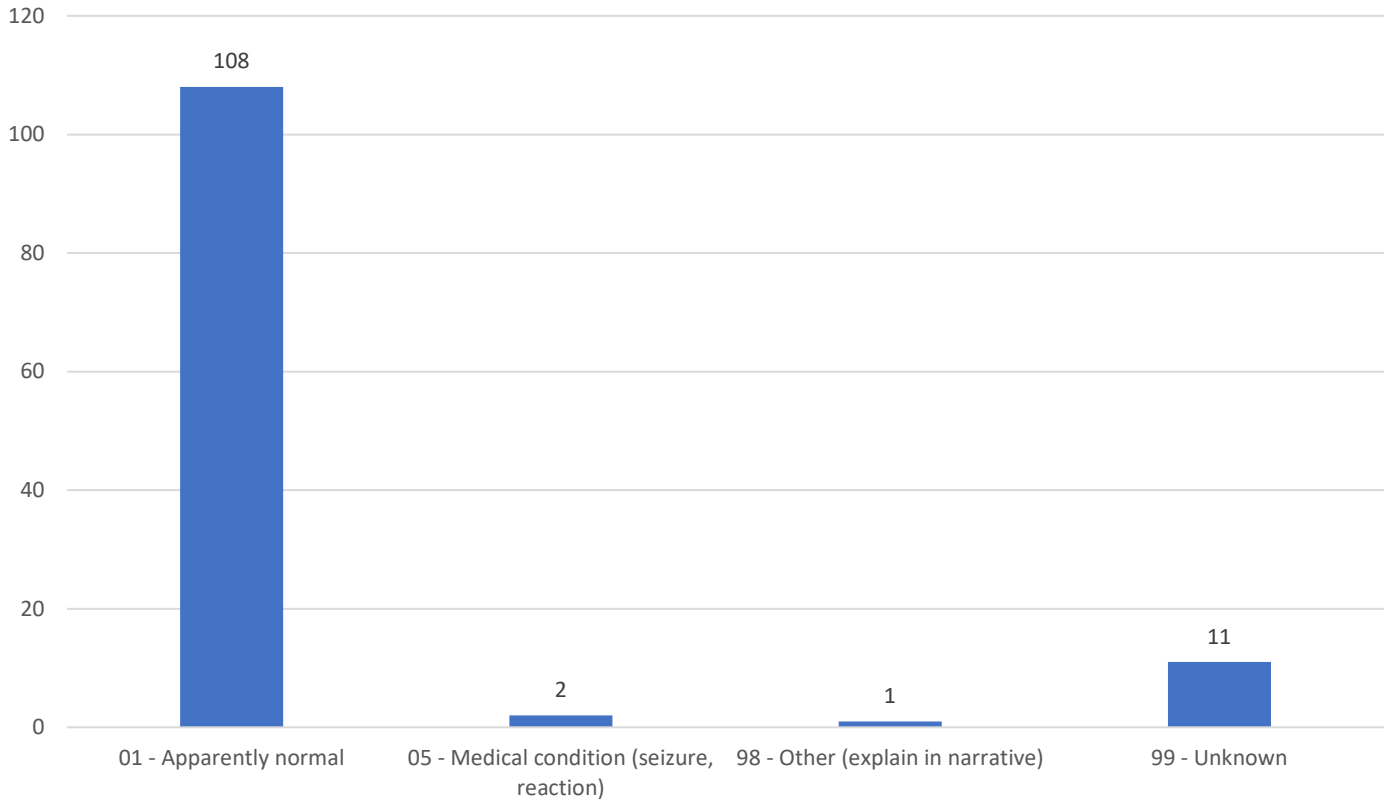
### Manner of Crash



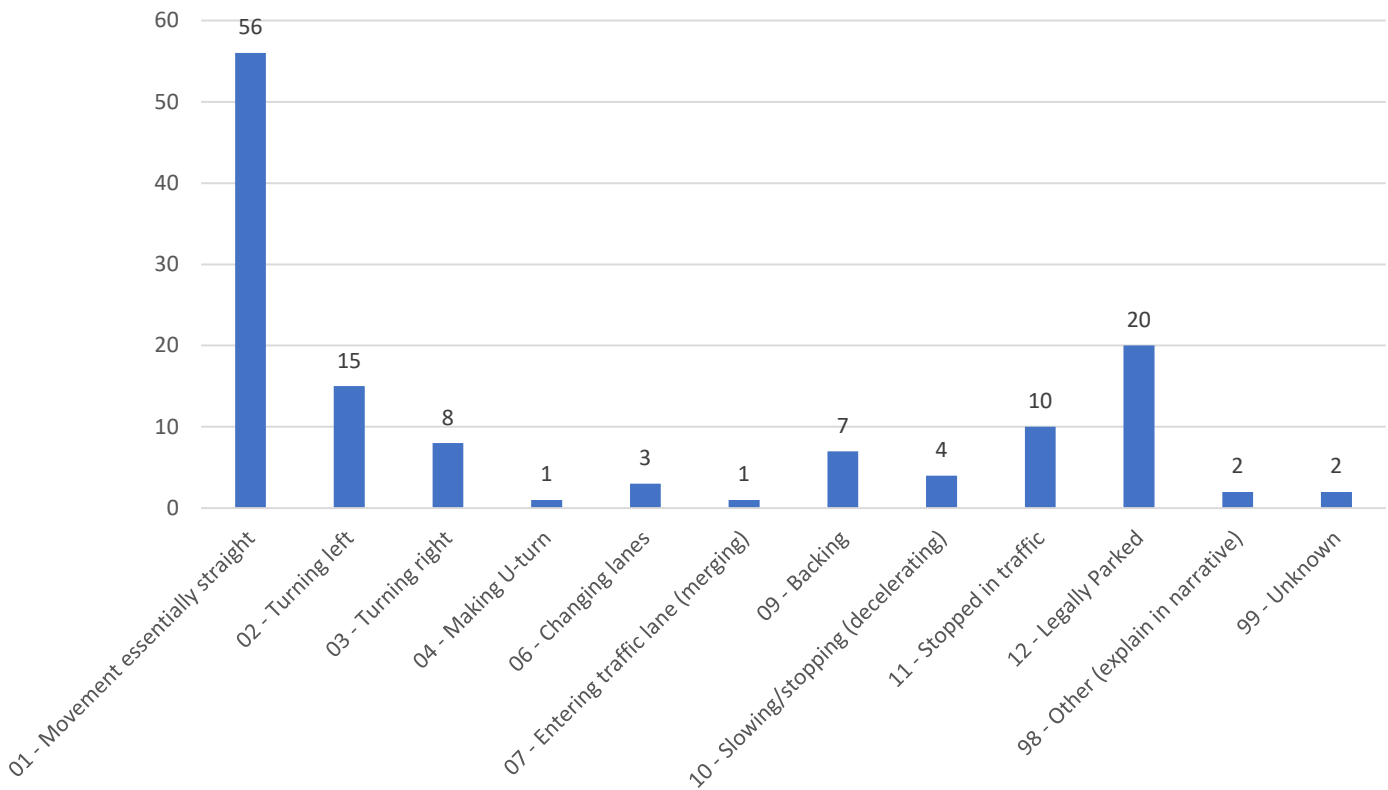




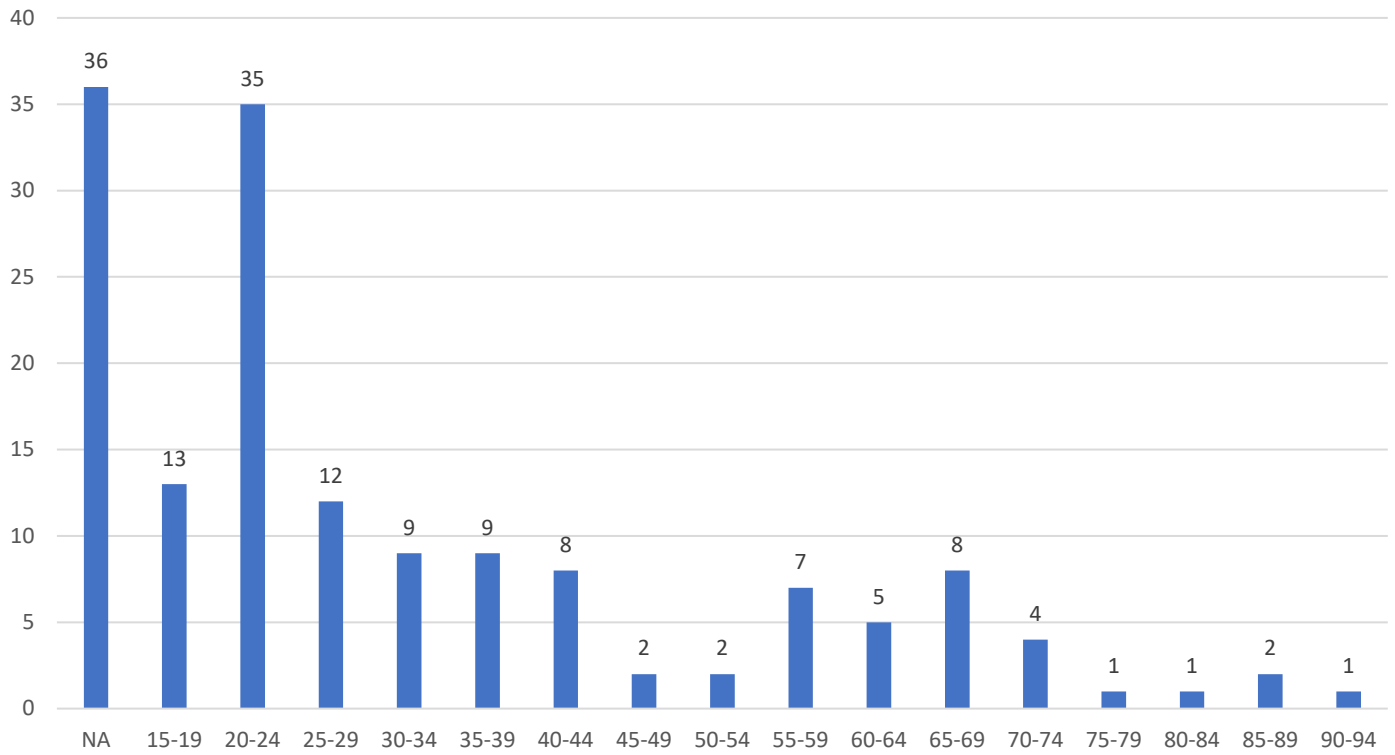
