April Training: Two officers graduated from the Iowa Law Enforcement Academy and will now complete 12 weeks of field training. An officer completed field training and was assigned to the 3-11 shift. All officers attended realistic deescalation and defensive tactics training. Several officers attended sexual assault investigation training at the Iowa Law Enforcement Academy. Crisis Negotiators hosted and attended the state spring training conference. An officer attended storm spotter training. An officer attended emergency response to aviation disaster training. An officer was recertified as a field sobriety test instructor. An officer attended a field training officer seminar. An officer attended FBI-LEEDA national conference. An officer attended recertification training as a chemical munitions instructor. An officer attended the FBI National Academy spring training conference.

April Outreach and Engagement: Officers assisted with Iowa Special Olympics fundraiser at Texas Roadhouse. An officer attended the Spring Carnival on Welch Avenue. Officers served breakfast for Fly In fundraiser for Boys and Girls Club and the police association. Officers took pizza and pancakes to YSS houses to build relationships with youth. Citizen police academy students are doing ride-along with officers. The Chief attended the NAACP General Assembly meeting and the County Coordination meeting about the next Community ID event.

# **USE OF FORCE DETAIL**

# Incident 1:

Use of Force: Pointed duty firearm at subject

Date: April 3, 2022, at 21:32 Details: Officer noticed a subject with several outstanding warrants and the subject ran into a building trying to hide from the officer. The officer drew their firearm and pointed it towards the wanted subject while giving commands and the subject complied. The officer was followed into the building by the wanted subject's significant other. The officer was alone at the time and pointed their firearm towards that subject as well and the person complied.

Charges: Warrants X 3 – Probation Violation, Failure to Appear, and Theft 5th degree Demographics: 37-year-old white female (arrested) and 52-year-old white male

# Incident 2:

Use of Force: Pointed taser at subject

Details: Officers had numerous contacts with the subject throughout the shift who claimed to be an armed deputy from another county. The subject was following officers, showing up at calls for service, and interfering with officer's duties. The subject came to the Ames Police Department to confront officers and was holding a flashlight. At that time officers made the decision to arrest the subject and pointed the taser at the subject while ordering him to drop the flashlight. The subject complied and was placed under arrest. The subject was transported to jail.

Charges: Harassment of Public Official, False Reports, Reckless Driving, Failure to Stop at a Stop Sign and Stopping on Paved Part of Highway. Demographics: 21-year-old white male

# Date: April 7, 2022, at 03:29

#### Incident 3:

Use of Force: Grabbed subject and directed them to the ground Date: April 10, 2022, at 01:51 Details: An officer observed a subject that had been kicked out of a bar and attempted to fight bar staff. The officer attempted to pull the subject away from bar staff. The subject resisted. The officer then directed the subject to the ground and placed the subject under arrest. The subject was transported to jail.

Charges: Public Intoxication Demographics: 29-year-old Hispanic male

#### Incident 4:

Use of Force: Grabbed subject, covered subject's mouth Date: April 10, 2022, at 03:00 Details: The subject was arrested for public intoxication and transported to the Ames Police Department. At the department, the subject needed to be medically evaluated due to his level of intoxication. Paramedics arrived to evaluate the subject, and the subject attempted to kick the paramedic. Officers had to restrain the subject to prevent him from assaulting the paramedics. The subject was then transported to the hospital for further evaluation. While at the hospital, the subject attempted to spit on officers, and an officer placed their hand over the subject's mouth to avoid being spit on. The subject was transported to jail.

Charges: Public Intoxication Demographics: 21-year-old white male

#### Incident 5:

Use of Force: Taser shown, grabbed subject

Details: An officer was investigating a domestic violence incident. The subject was refusing to comply with officer's requests and continued to walk towards him in a non-compliant manner. The officer unholstered the taser and turned it on all while the officer continued to give the subject commands to sit down. The officer used their hand to direct the subject to the chair to sit down and the subject complied. The subject was intoxicated, and no arrests were made.

Charges: None Demographics: 37-year-old black male

# Incident 6:

Use of Force: Pointed duty firearm and less lethal weapon at subject Date: April 14, 2022, at 12:18 Details: A subject entered a family member's home and barricaded himself with the intent to harm himself. Crisis Negotiators, our Mental Health Advocate and mental health professionals spoke with the subject throughout the incident. As the night went on, the subject made threats to harm himself and others while displaying weapons. Officers contained the area. The subject exited the residence and attempted to get into a car. Emergency Response Team members approached him with their duty weapons and less lethal weapons pointed at him. The subject complied and was safely taken into custody. He was transported to the hospital for a medical evaluation.

Charges: None Demographics: 20-year-old white male

# Incident 7:

Use of Force: Grabbed subject

#### Date: April 25, 2022, at 18:27

Details: Officers were investigating subject who was driving while revoked and possibly intoxicated. The subject failed to stop for officers and eventually stopped the car after a few blocks when officers used the vehicle intercept to stop the vehicle. The subject refused to voluntarily get out of the vehicle. The subject continued to hold onto the steering wheel and a dog that was inside of the vehicle. The officers talked calmly to the subject attempting voluntary compliance.

# Date: April 13, 2022, at 21:05

Eventually the subject was forcefully removed from the vehicle after the subject attempted to bite officers twice. The subject showed signs of intoxication.

Charges: Eluding, Interference with Official Acts, Driving While Revoked, and Fail to Yield to Emergency Vehicle Demographics: 54-year-old white female

#### Incident 8:

Use of Force: Grabbed subject Date: April 29, 2022, at 03:40 Details: Officers conducted a traffic stop on a suspected impaired driver. Officers asked the subject for identification. The driver refused to provide identification. Officers asked the subject to step out of the car. He refused and locked the car door. Officers grabbed the subject, pulled him from the car and placed him on his stomach placing him under arrest. The subject was transported to jail.

Charges: OWI 2nd offense, Interference with Official Acts Demographics: 26-year-old white male

# Incident 9:

Use of Force: Pointed duty firearm at subject Date: April 29,2022, at 18:42 Details: Officers were investigating a stolen vehicle report. Officers located the subject after witnesses reported a gun shot. When officers located the subject, he was ordered to the ground at gun point and the subject was handcuffed without incident. A BB gun was recovered along with drug paraphernalia and the subject was driving while barred.

Charges: Theft 1st, Possession of Drug Paraphernalia, and Driving while barred. Demographics: 25-year-old white male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Nondiscretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
