Two officers attended internal affairs investigations training. Officers attended a Drivers of Meth Use presentation. An officer instructed new recruits in defensive tactics at the academy. The Chief attended Incident Command System Level 400 training.

**May Outreach and Engagement**: Officers participated in the Iowa Special Olympics Torch Run and opening ceremonies. Officers attended the Citizens Police Academy graduation. Officers attended a demonstration for Sri Lanka at city hall. Officers attended the 515 Festival in downtown Ames. Officers attended the Bike to Work Week breakfast at city hall. Officers attended the MGMC Safety Event on campus. Officers attended the Mayor's Bike Ride. Officers provided traffic control for the Memorial Day parade. Officers attended the city council meeting to accept the Peace Officer Memorial Proclamation. Detective Adi Johnson received the Terry Bird Outstanding Investigation Award at the council meeting, as well. Officers attended various block parties in the community. Officer Celena Rohland received the City's Customer Service Award for her kind and compassionate response to a lemonade stand theft. The Chief attended the NAACP General Assembly meeting to discuss the results of the traffic stop study.

## **USE OF FORCE DETAIL**

## Incident 1:

Use of Force: Pointed duty firearm at subject Date: May 3, 2022, at 03:12 Details: Ames officers were assisting another jurisdiction with a pursuit that entered our jurisdiction. The pursuit was related to a stolen vehicle. Eventually, the vehicle was stopped and two Ames officers pointed their firearms at the driver. Officers from the other jurisdiction took the driver and passenger into custody and our officers returned to duty.

Charges: Operation of Motor Vehicle without Owner's Consent, Driving while Barred Demographics: 41-year-old black male

#### Incident 2:

Use of Force: Grabbed subject

#### Date: May 4, 2022, at 00:48

Details: Officers were dispatched to a motor vehicle crash. The driver was located and arrested for Operating While Intoxicated. The officer transported the driver to the police department for processing. As the officer secured the driver, the driver pushed the officer and attempted to get up. Another officer arrived and they were able to secure him to finish processing the male for transport to jail.

#### Incident 3:

Use of Force: Grabbed subject and pointed Taser

Details: While officers were investigating a vandalism case, they found a man who had a warrant for his arrest. When officers attempted to arrest the man, he pulled away and the officers pushed him against a car. An officer also pointed a Taser at the man but did not deploy it. He was handcuffed without further incident. An officer sustained a cut on his finger and other officers suffered from sore lower backs due to the man's actions.

Charges: Warrant and Interference with Official Acts Demographics: 41-year-old White male

#### Incident 4:

Use of Force: Grabbed subject Date: May 7, 2022, at 17:13 Details: Officers were called to a local social service agency for a report of a person refusing to leave. It was determined that she was refusing to leave, and a charge of Criminal Trespass was requested. The female stiffened her arms in attempt to keep from being handcuffed. Officers were able to get her arms behind her back for handcuffing. The female attempted to kick officers as she was being handcuffed.

Charges: Criminal Trespass and Interference with Official Acts Demographics: 31-year-old Hispanic female

## Incident 5:

Use of Force: Grabbed subject while handcuffing

Date: May 24, 2022, at 14:56 Details: Officers were called to a local social service agency for a client refusing to leave. Staff reported the female was uncooperative and yelling at staff. She was asked to leave by the officers. She left while yelling and threatening staff and officers. As officers went to the parking lot, the female continued to yell and threaten the officers. She was told to leave the area, or she would be arrested for Disorderly Conduct. She then approached the officers. At that time, the officers advised her she was under arrest. The officers grabbed her and directed her to the ground. She began to resist, kicking the officers. She was eventually handcuffed and taken into custody.

Charges: Disorderly Conduct and Interference with Official Acts Demographics: 33-year-old White Female

## **Incident 6:**

Use of Force: Grabbed subject while handcuffing Date: May 27, 2022, at 00:27 Details: As an officer was on routine patrol, he observed a group of people in front of a local bar. As he drove by, he saw a male punch a female. The officer recognized the male from previous encounters. As the officer approached, the male ran from the area. He was located a short time later hiding behind a wall. Officers grabbed the male's arm. The male pulled away from the officer and they fell to the ground. The male tucked his arms underneath his body and continued to resist. Officers forced his arms behind his back for handcuffing as the male attempted to pull away.

Charges: Assault, Disorderly Conduct, Public Intoxication, and Interference with Official Acts Demographics: 25-year-old Hispanic male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Nondiscretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused

investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
