South branch of the Chicago & North Western Railway, and running west a distance of seven hundred and sixteen and 2/10 (716 2/10) feet. That said land is subdivided as shown by the plat hereto attached into the following Subdivision, to wit: Blocks 1, 2, and

3 and Outlot "A" and the streets to wit: Chautauqua Avenue, Chautauqua Roulevard and Lee Street therein shown and described on said plat are dedicated to public use, and R. E. Stevens, Alice G. Rowe, Hattie E. McCarthy and Emma M. Lee hereby release and

An ordinance accepting and approving plat of Chautauqua Park addition

to the City of Ames, Iowa.

Be it ordained by the City Council of the City of Ames, Iowa.

Section 1. That the plat embracing blocks numbered one, two and three (1, 2, and 3) and out lot "A" with the streets and alleys adjacent thereto situated on that part of the

with the streets and alleys adjacent thereto situated on that part of the southeast quarter (S. E. ½) of section three (3) township eighty three (83) north, range twenty four (24) west of the 5th P. M. lying north of Sixth street, and the north line of the right

of way of the main line of the right of way of the main line of the Chicago and Northwestern railway, and west of the right of way of the north and south branch line of said Chicago and Northwestern railway, and executed by R. H. McCarthy, Hattie E. Mc-

Carthy, C. G. Lee, Emma M. Lee, R. E. Stevens, J. L. Stevens, G. H. Rowe and Alice G. Rowe, is hereby approved and accepted by the City of Ames, and shall be known as Chautauqua
