Charges: Criminal Trespass

Demographics: 25-year-old Asian male

Incident 4:

Use of Force: Pointed duty firearm at subject

Date: June 5, 2022, at 03:17

Details: Officers were dispatched to a parking lot of an apartment complex for the report of a male threatening another male. This was the second time officers responded to this same issue. The reporting party said the male threatened to “shoot up the apartment” and “shoot at the cops so they had to shoot him back.” The reporting party believed the male had a handgun. An officer pointed a firearm at the subject who complied with orders and was taken into custody. The man was not armed at the time. Officers located a firearm in the man’s apartment and secured it as it was laying on a dresser, loaded.

Charges: Harassment 1st Degree - Intimidation

Demographics: 22-year-old Black male

Incident 5:

Use of Force: Grabbed subject and pointed Taser

Date: June 9, 2022, at 09:00

Details: Officers were called on a report of a man trespassing who appeared to be “on something.” The reporting party had already asked the person to leave but he refused. Officers attempted to take the man into custody, and he resisted. Officers grabbed the man and took him to the ground. The man continued to resist, and an officer pointed a Taser at the subject who then complied and was taken into custody.

Charges: Interference with Official Acts and Trespass

Demographics: 28-year-old White male

Incident 6:

Use of Force: Pointed duty firearm at subject

Date: June 10, 2022, at 00:24

Details: Officers were called by a man who said he was suicidal and had a firearm. After some negotiation, the man was convinced to come outside by an Ames dispatcher. Officers pointed their duty firearms at the man who was compliant. He was taken into custody and transported to the hospital for evaluation.

Charges: None

Demographics: 25-year-old White male

Incident 7:

Use of Force: Pointed duty firearm at subject

Date: June 12, 2022, at 22:45

Details: An officer observed a driver go through a red light. The officer initiated a traffic stop. The driver did not stop after the officer put on the lights and siren. Eventually the driver stopped, and officers conducted a high risk stop, pointing firearms at the car. The driver was taken into custody without incident and was found to be intoxicated.

Charges: OWI 1st Offense, Failure to have Valid License, No Insurance, Failure to Obey Traffic Control Device

Demographics: 40-year-old White male

Incident 8:

Use of Force: Pointed duty firearm at subject

Date: June 13, 2022, at 11:27

Details: An officer observed a vehicle that was reported stolen at a local convenience store. The officer activated emergency lights and siren, but the driver drove away striking a vehicle. The driver then stopped. The officer pointed

their duty firearm at the driver until other officers arrived and she was taken into custody without further incident. She was turned over to another agency who was investigating the theft of the motor vehicle.

Charges: Interference with Official Acts
Demographics: 30-year-old White female

Incident 9:

Use of Force: Pointed duty firearm at subjects Date: June 14, 2022, at 13:33
Details: Officers were dispatched to a fight in progress. The report was several people fighting in the street. The caller advised one of the subjects had a gun. An officer on scene had his duty weapon out while detaining several individuals. Two of the individuals had warrants from other jurisdictions.

Charges: Disorderly Conduct
Demographics: 15-year-old Black male and a 21-year-old Black male

Incident 10:

Use of Force: Pointed Taser and grabbed subject Date: June 18, 2022, at 20:46
Details: Officers were called to a domestic situation. The parties decided to separate for the evening. The female half had to obtain items from the apartment where both lived. The male became belligerent and threatening. The male threatened to harm and kill the officers. He was warned to stop but continued to threaten. An officer pointed a Taser at the man but did not activate it. The officers had to grab the man to get him into custody. He continued to resist and kicked the inside of the patrol car after being placed inside.

Charges: Harassment of Public Official
Demographics: 43-year-old White male

Incident 11:

Use of Force: Pointed Taser Date: June 19, 2022, at 16:08
Details: An officer noticed a driver operating a vehicle who did not have a driver's license and was in the car of a person where there was a valid no contact order. Officers have dealt with both individuals several times. The officer initiated a traffic stop. Once stopped, the driver exited the vehicle and approached the officer. The officer pointed a Taser at the subject and commanded he get back in the car. He complied and the officer holstered the Taser. The driver was arrested on several warrants and the female was arrested for violating the no-contact order.

Charges: Contempt of Court – Violation of No-Contact or Protective Order
Demographics: 26-year-old Black male and 25-year-old Black female

Incident 12:

Use of Force: Pointed duty firearm at subject Date: June 22, 2022, at 00:05
Details: An officer was dispatched to the report of the violation of a protective order. The victim reported the suspect was at her home waiting for her. Officers responded and located the man inside the garage, a violation of the order. The man was uncooperative and refused to show his hands to the officers and began reaching for items in the garage. An officer pointed his duty weapon at the man who then complied. He was taken into custody without further incident.

Charges: Contempt of Court - Violation of No-Contact or Protective Order
Demographics: 30-year-old Black male

Incident 13:

Use of Force: Grabbed subject Date: June 24, 2022, at 14:12
Details: Officers received information of a juvenile runaway at a location. Officers responded and located the juvenile. The juvenile attempted to run, and officers grabbed her to get her into custody. She was transported to the Police Department where a juvenile detention officer took custody of her.

Charges: No criminal charges, Juvenile Missing Person Pick-up Order
Demographics: 16-year-old Asian female

Incident 14:

Use of Force: Grabbed subject

Date: June 25, 2022, at 18:37

Details: An officer made a routine traffic stop and found the driver to be wanted. The subject was informed of the warrant and told she was under arrest. The subject tried to pull away and an officer used a wrist lock and placed her in handcuffs. She was transported to jail without further incident.

Charges: Warrant Arrest – Failure to Appear

Demographics: 53-year-old White female

Incident 15:

Use of Force: Grabbed subject

Date: June 29, 2022, at 16:30

Details: A State Patrol officer called for assistance on Highway 30 after someone ran from them on a traffic stop. An officer from the Ames Police Department located the person and pointed a duty firearm at the person. The person complied with the arrest and was taken into custody on the warrant.

Charges: Warrant Arrest – Probation Violation

Demographics: 21-year-old White male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

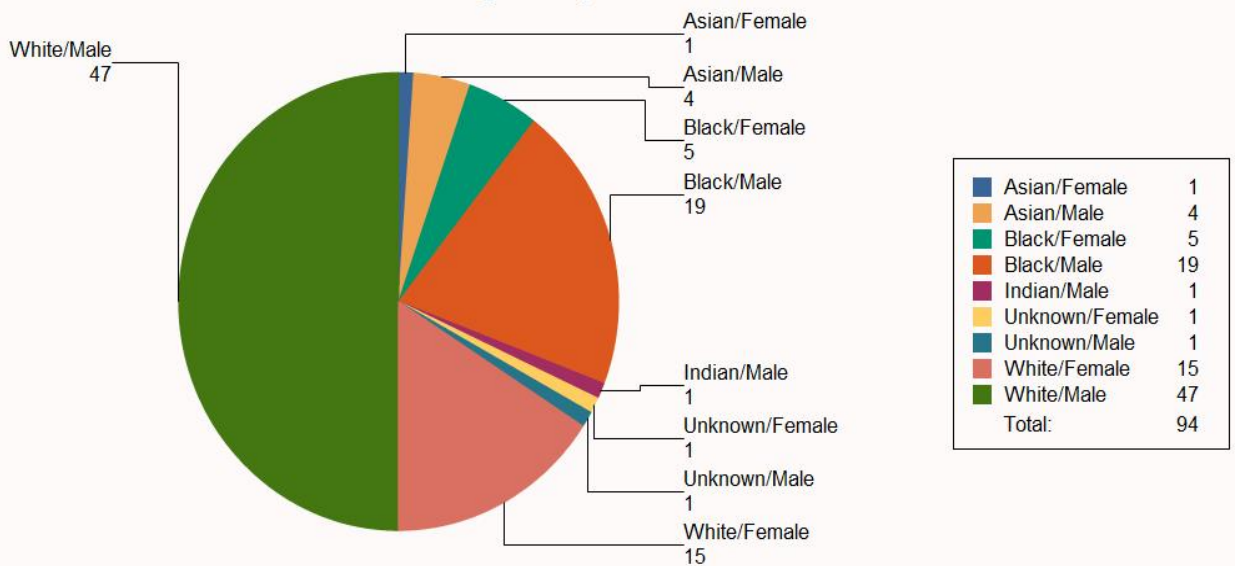

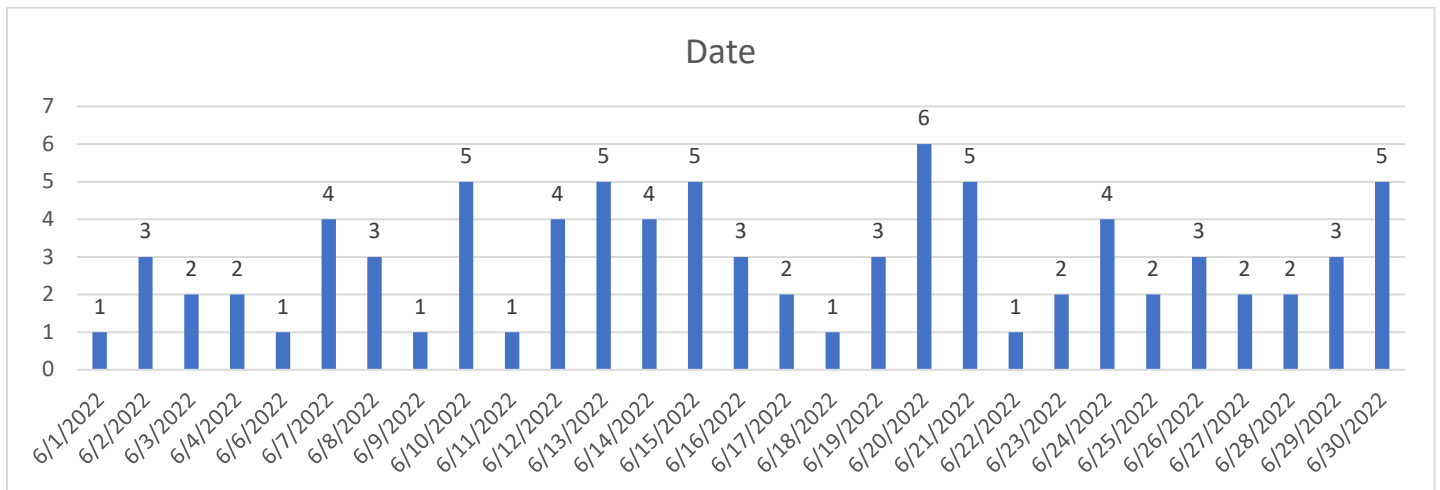

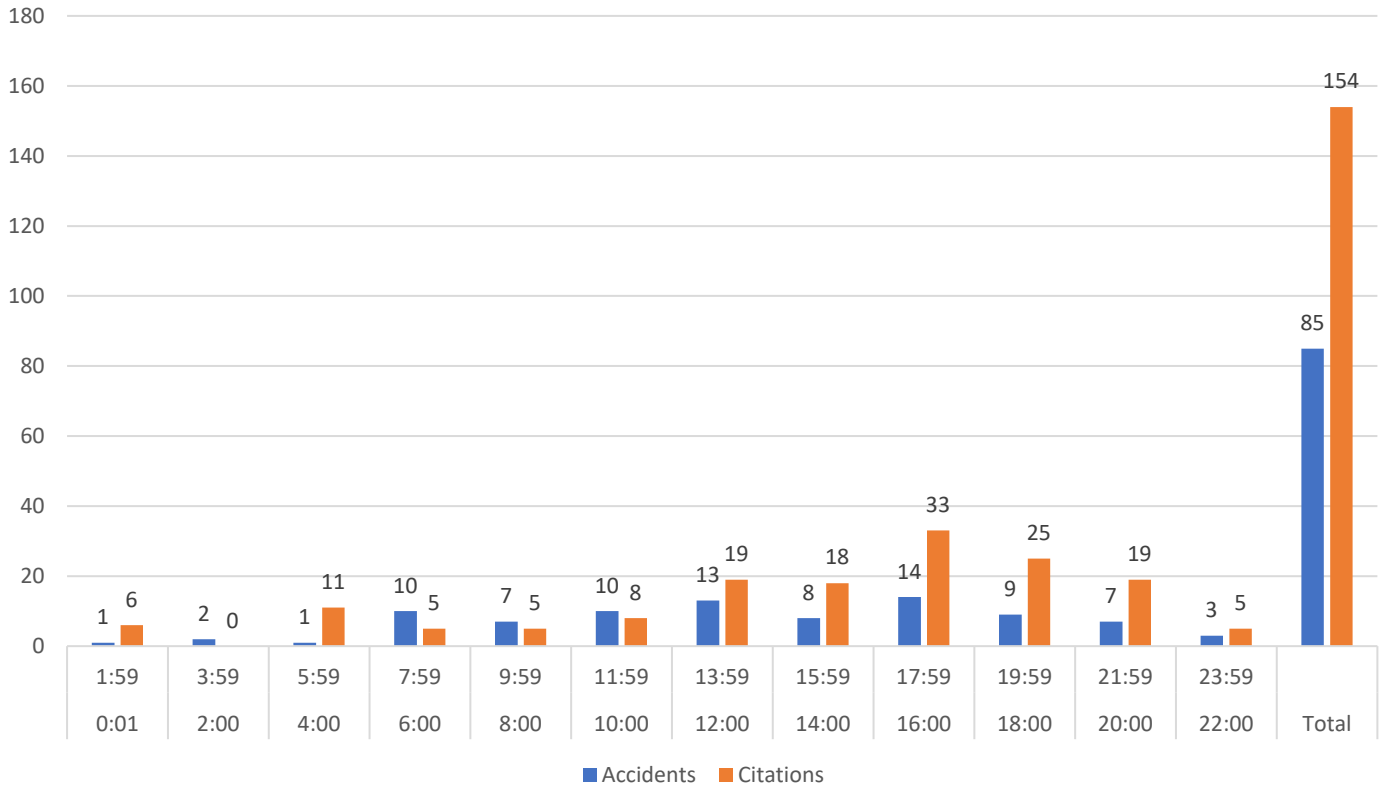
Arrests/Charges by Race/Gender



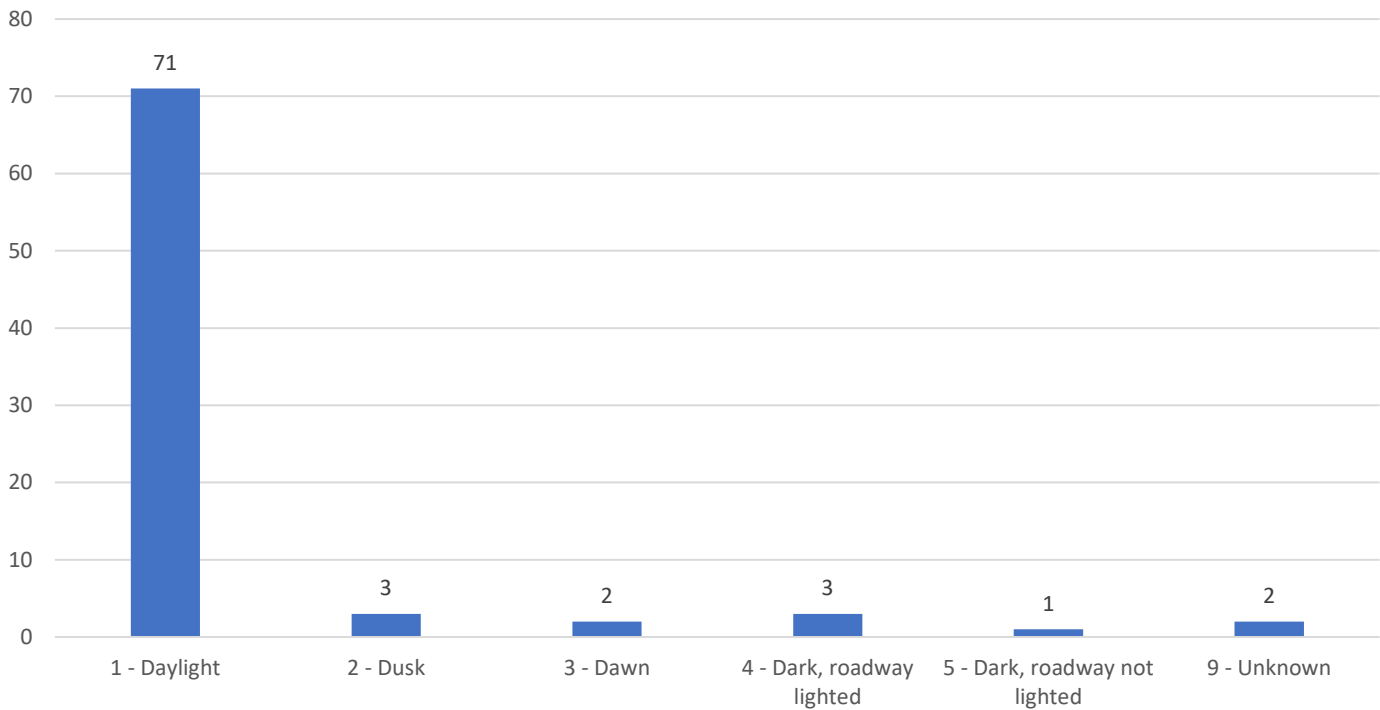

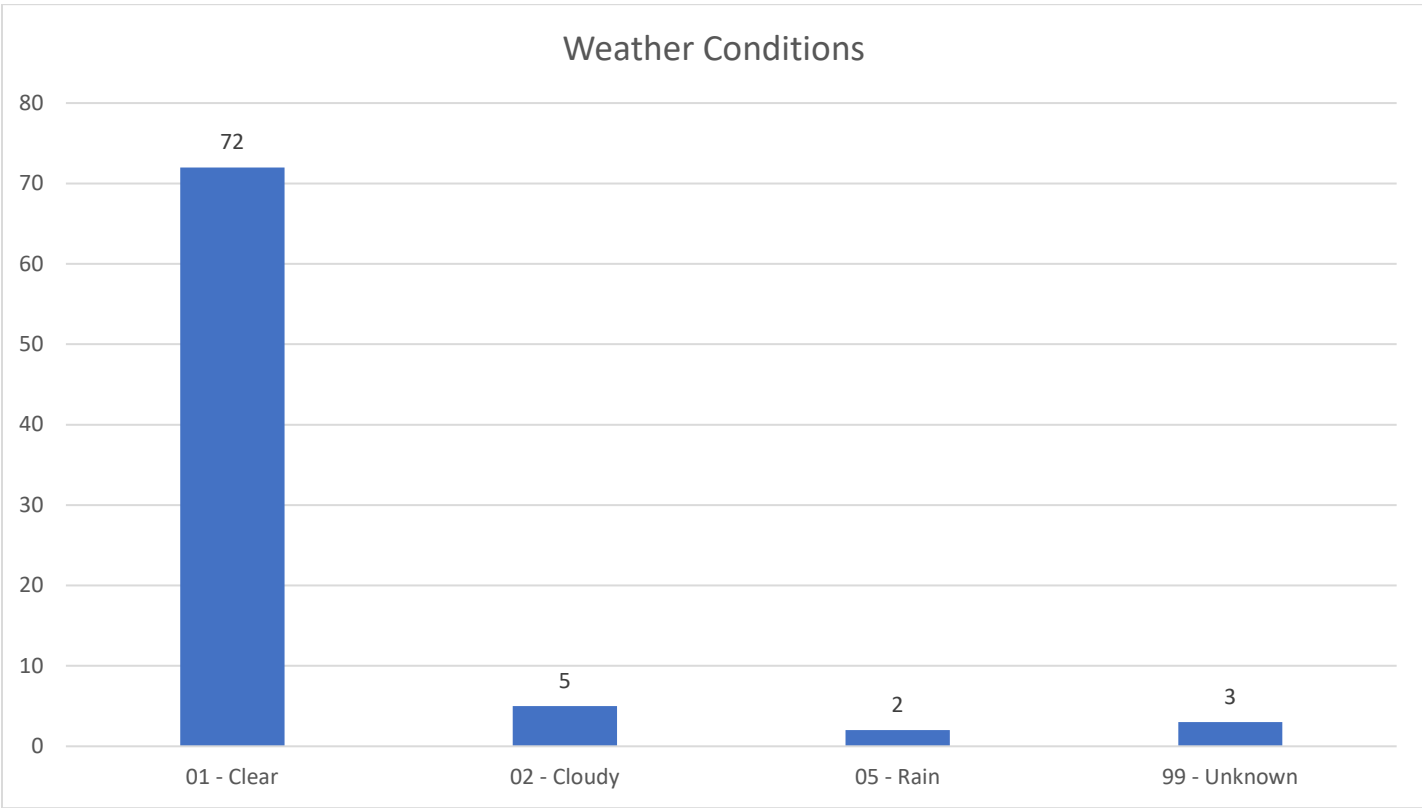
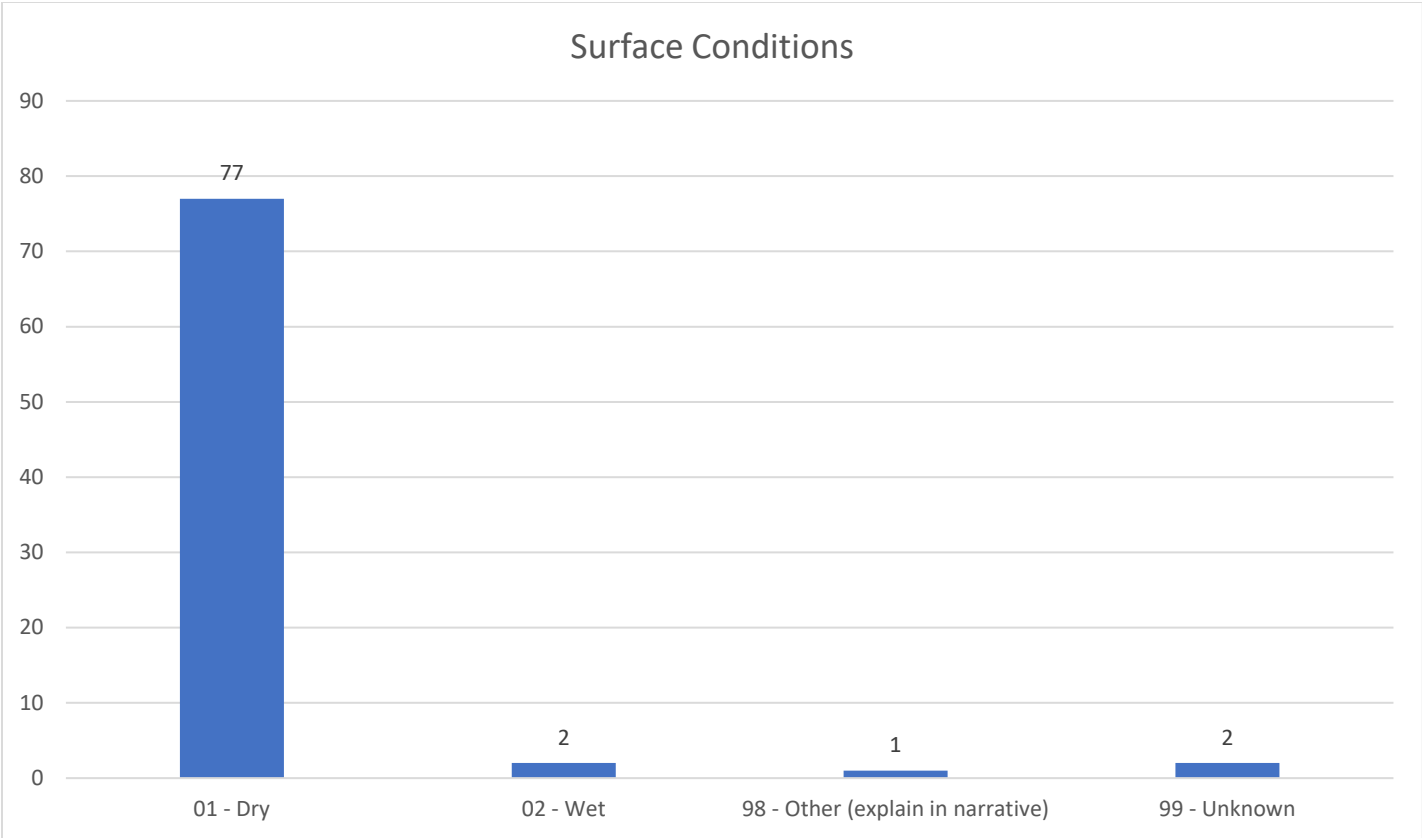


Manner of Crash

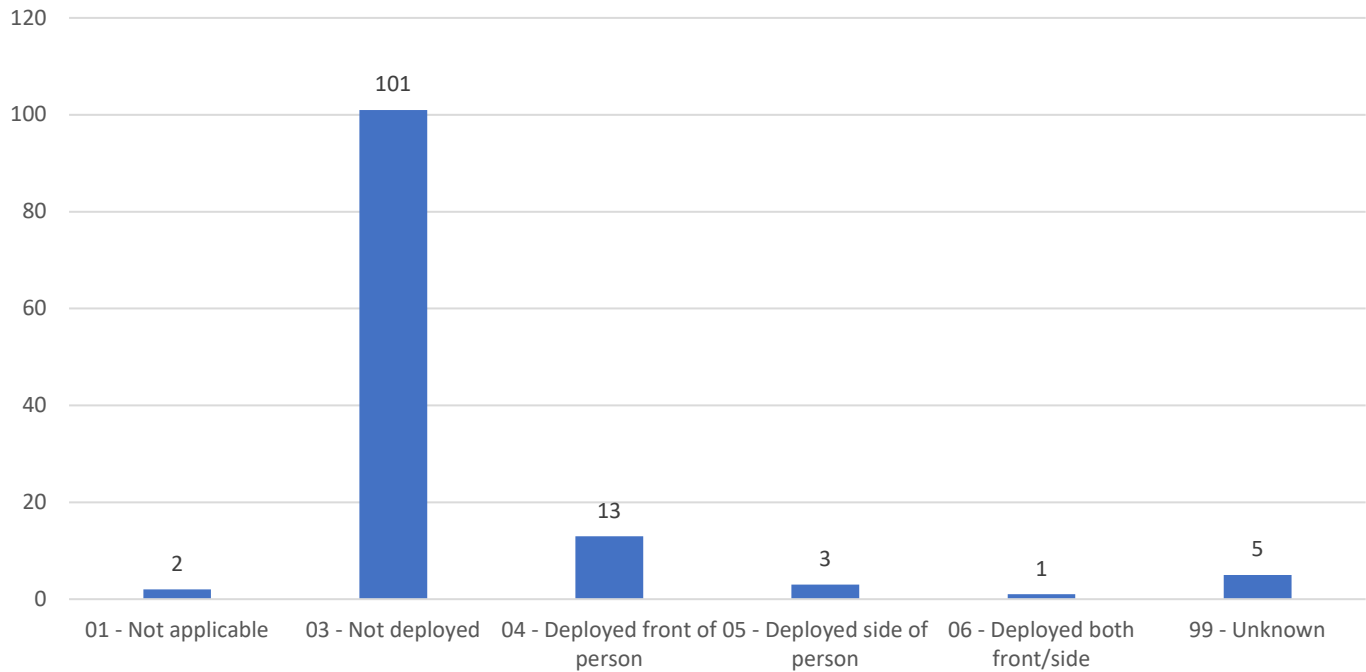

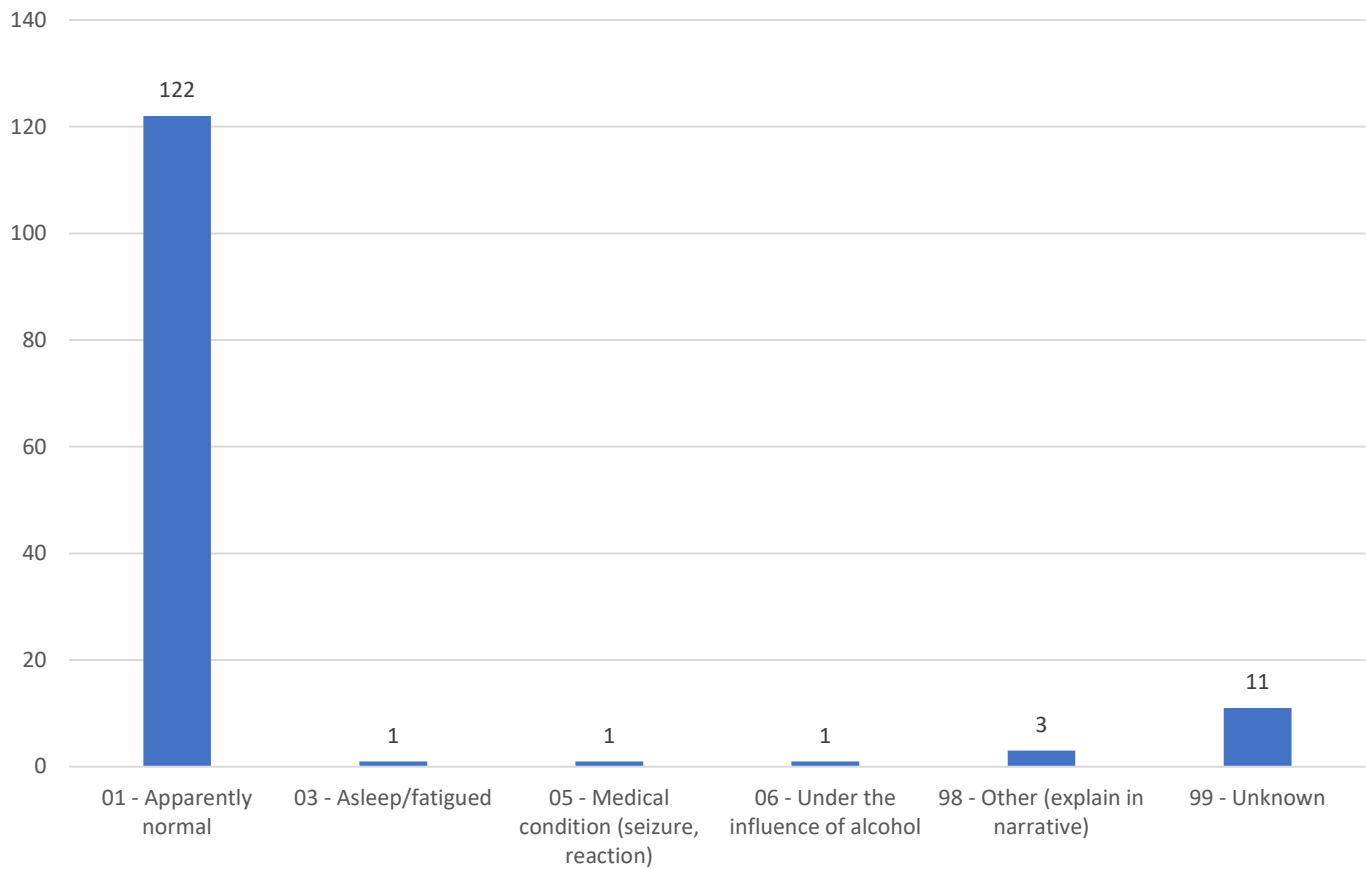




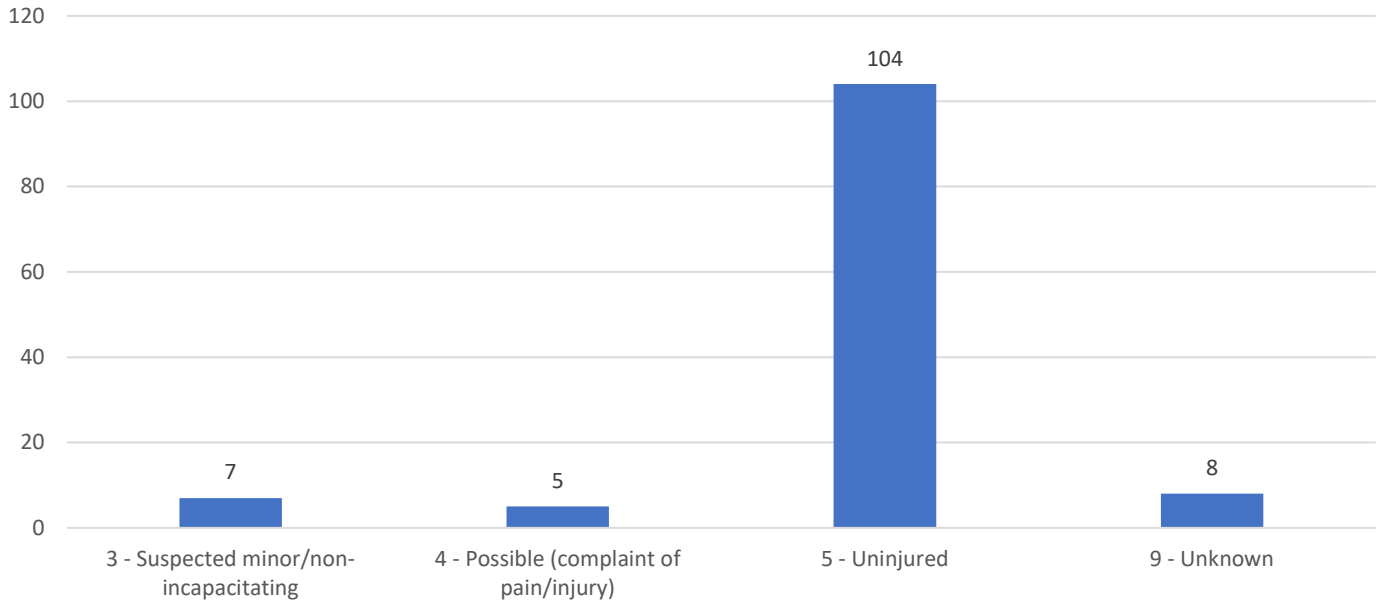
Airbag Deployment



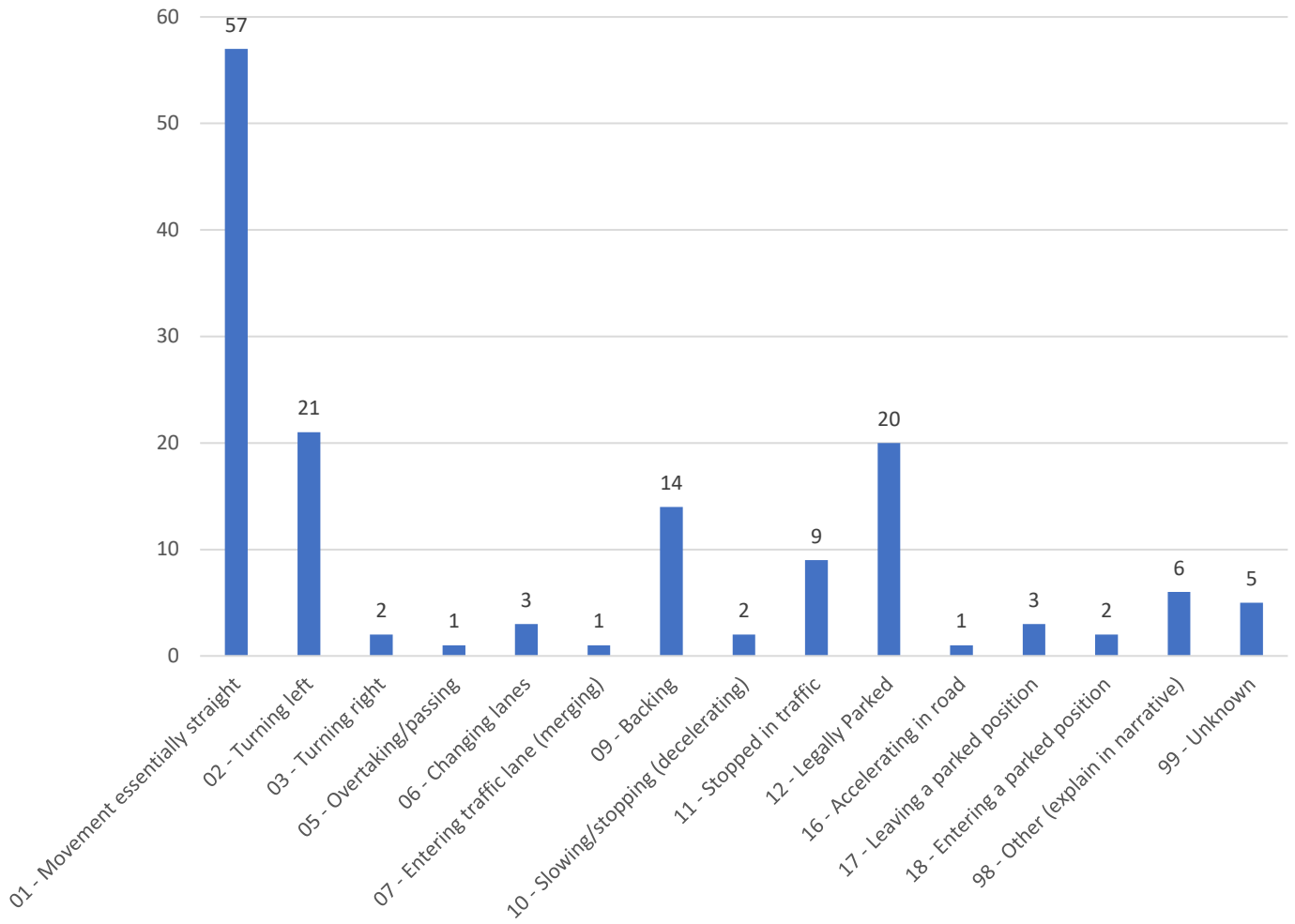

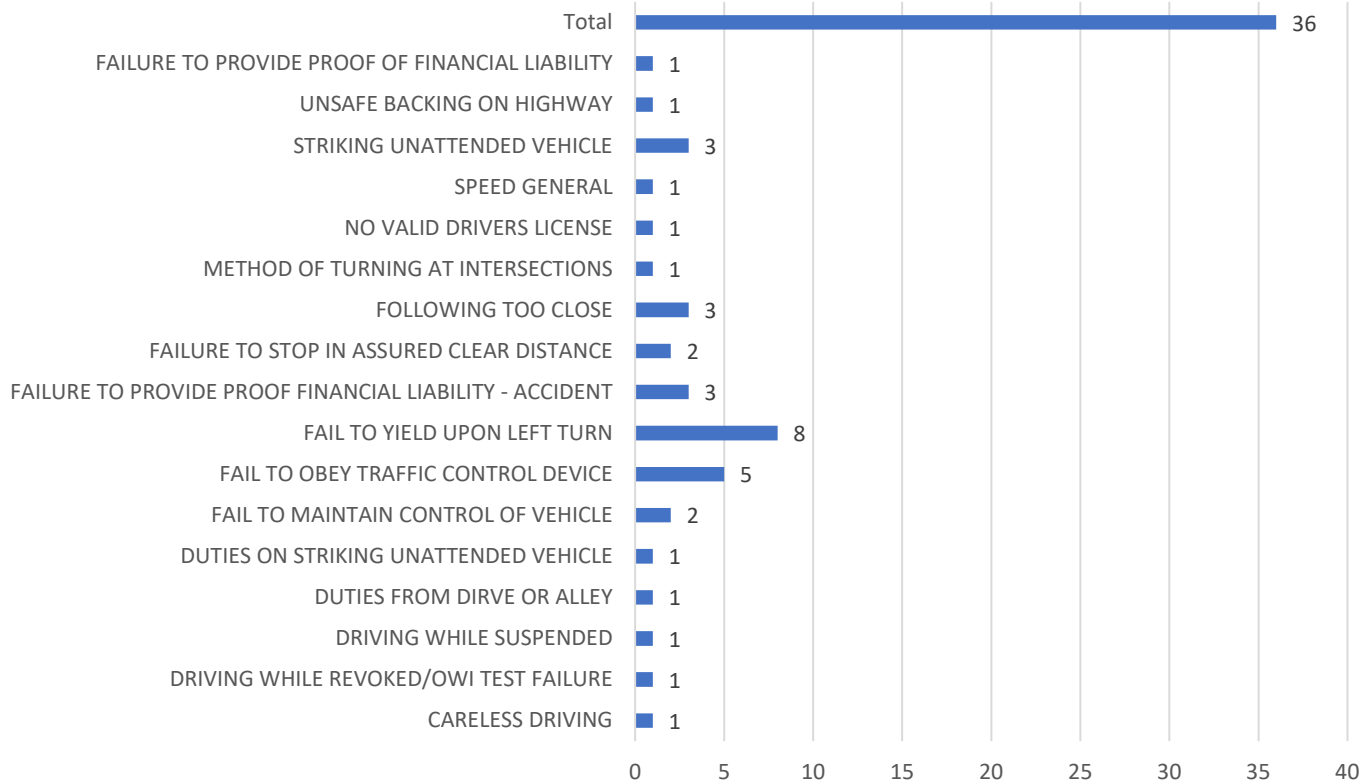
