July Training: Two officers are in field training. Three officers are attending the Iowa Law Enforcement Academy. All officers attended active shooter training at a local elementary school building. All officers participated in annual physical fitness testing. An officer attended Advanced Mental Health Training for Juveniles. A patrol supervisor attended the FBI LEEDA Supervisor Leadership Institute training program. Several patrol supervisors attended Creating the Culture leadership training. An officer attended High Threat Close Quarters Firearms Instructor training. A patrol supervisor attended an Active Shooter Preparedness webinar. Three detectives attended Port-Mortem Fingerprinting and Identification training.

July Outreach and Engagement: Officers attended National Night Out and helped distribute over 800 backpacks and hot dogs. Officers attended the Iowa Games opening ceremonies and tailgate event. Officers attended the 4th of July parade. Officers attended the Good Neighbor event on Clark Avenue. An officer conducted four active shooter trainings for local businesses. An officer gave police car tours to a day camp organization. An officer provided school computer safety training for a back-to-school event. An officer gave tours of the police department to ACPC students. An officer provided de-escalation training to a city department. Officers attended Splash and Bash at the Boys and Girls Club. Officers attended the Amazing Grace Race at Ada Hayden Park. An officer attended the George Niang/Boys and Girls Club golf tournament. An officer attended the Midnight Madness Road Race. An officer attended an event at the Darul Arqum Islamic Center. Officers attended block parties on Roosevelt Avenue, Idaho Street, and Stafford Avenue. Officers delivered pizza and donuts to several local youth shelters. The Ames Resident Police Advisory Committee (ARPAC) held their first meeting.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Pointed duty firearm at subject

Date: July 8, 2022, at 00:27

Details: Officers attempted to stop a vehicle reported as stolen. The occupants of the vehicle fled. Officers located the occupants nearby and pointed their duty firearms at one of the subjects. He was taken into custody.

Charges: Possession of a Controlled Substance, Marijuana 2nd Offense, Possession of Drug Paraphernalia, Interference with Official Acts

Demographics: 18-year-old black male

Incident 2:

Use of Force: Grabbed subject

Date: July 16, 2022, at 02:20

Details: Officers were called to Main Street to investigate a report of a man passed out laying on the sidewalk. Officers located the man and began to evaluate his level of intoxication. A female approached and began to ask the officers questions who also appeared highly intoxicated. The female admitted to being intoxicated. While arresting the female, she pulled away and the officers grabbed her arms to place her into custody.

Charges: Public Intoxication
Demographics: 39-year-old white female

Incident 3:

Use of Force: Pointed duty firearm towards subject Date: July 16, 2022, at 03:05
Officers responded to a call of a domestic situation where witnesses reported seeing a man punching a woman in the head. Upon arrival, officers spoke with witnesses who reported both subjects went into a residence. Officers attempted contact but no one would answer the door. Officers made entry and had their weapons drawn while searching. Both parties were located. Officers took the man into custody without further incident.

Charges: Aggravated Domestic Assault, 2nd offense
Demographics: 52-year-old white male

Incident 4:

Use of Force: Pointed duty firearm at subject Date: July 26, 2022, at 15:21
Details: Officers responded to a call from a female reporting a man who she had a protective order against was at her residence. She reported the man had a razor blade and was threatening to cut his own throat. At the scene, the man was uncooperative, and officers pointed their duty firearms and a Taser at the man to place him under arrest. After being placed in custody, the man was taken to the police department for processing. In the processing area, the man tried to disarm an officer and officers took him to the ground and re-secured him.

Charges: Disarming or Attempting to Disarm Police, Interference with Official Acts, Violation of a Protective Order
Demographics: 33-year-old white male

Incident 5:

Use of Force: Grabbed subject Date: July 31, 2022, at 13:30
Details: Officers responded to a local shelter for a person that was trespassing. The person in charge of the shelter had requested someone leave several times. Officers confirmed this and asked the man to leave the premises. He refused to leave. Officers attempted to reason with the man, but he ultimately refused. Officers told the man he would be arrested if he did not voluntarily comply with the lawful order to leave the premises at the request of the person in charge. Again, he refused. Officers grabbed the man who resisted as they attempted to handcuff him. Eventually officers were able to place the man in handcuffs and escort him out. One officer sustained an injury to their thumb due to the man's resistance.

Charges: Trespass and Interference with Official Acts
Demographics: 41-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

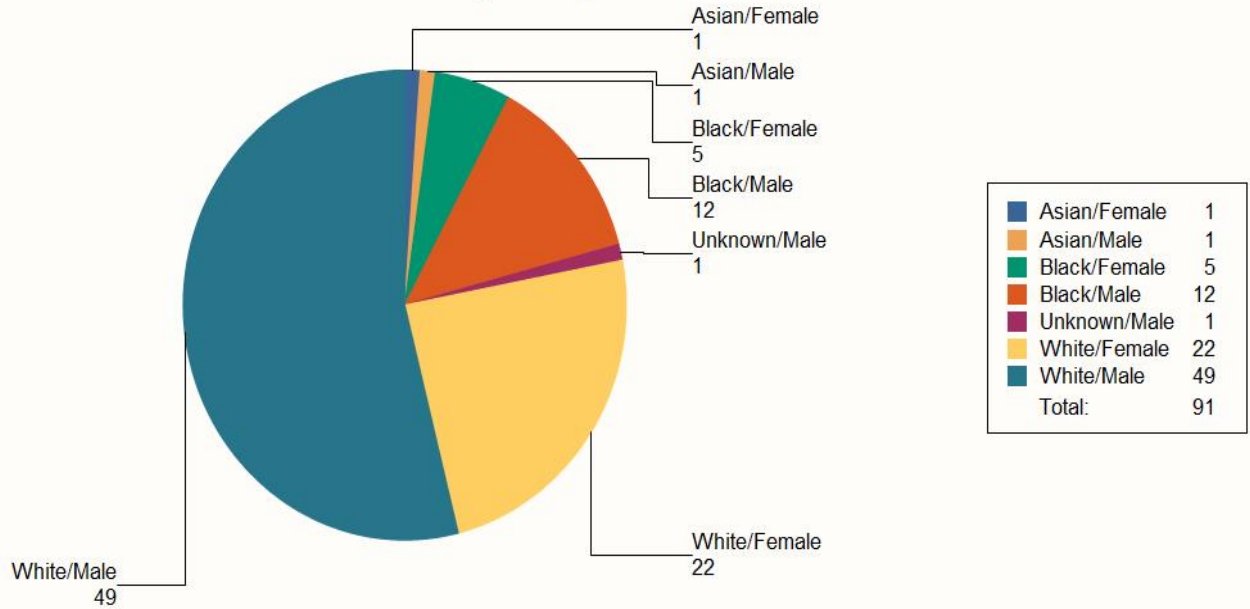

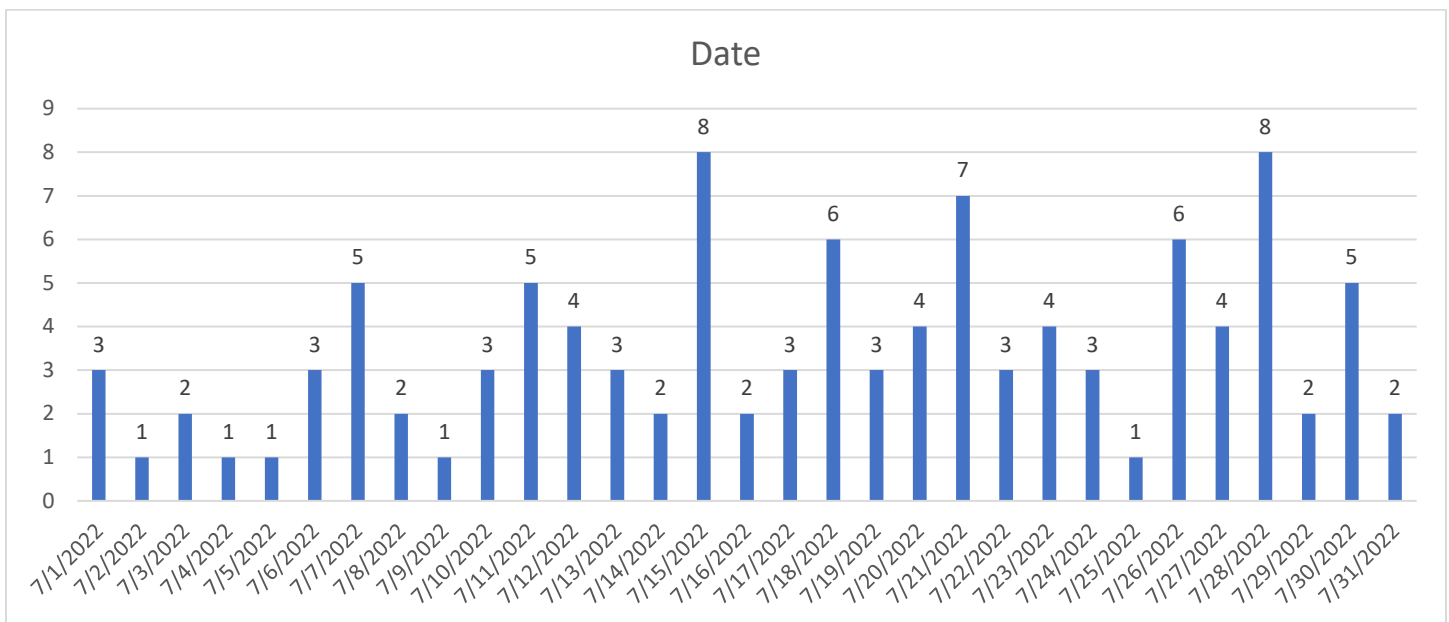

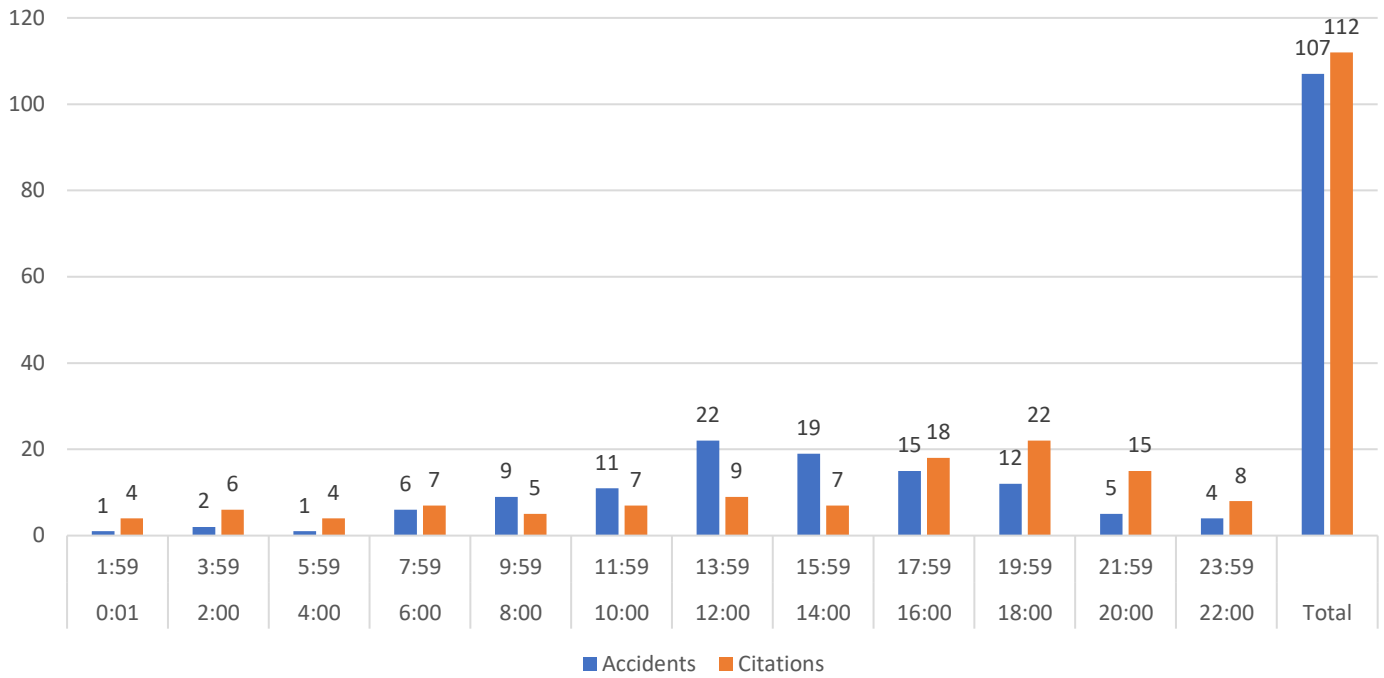
Arrests/Charges by Race/Gender



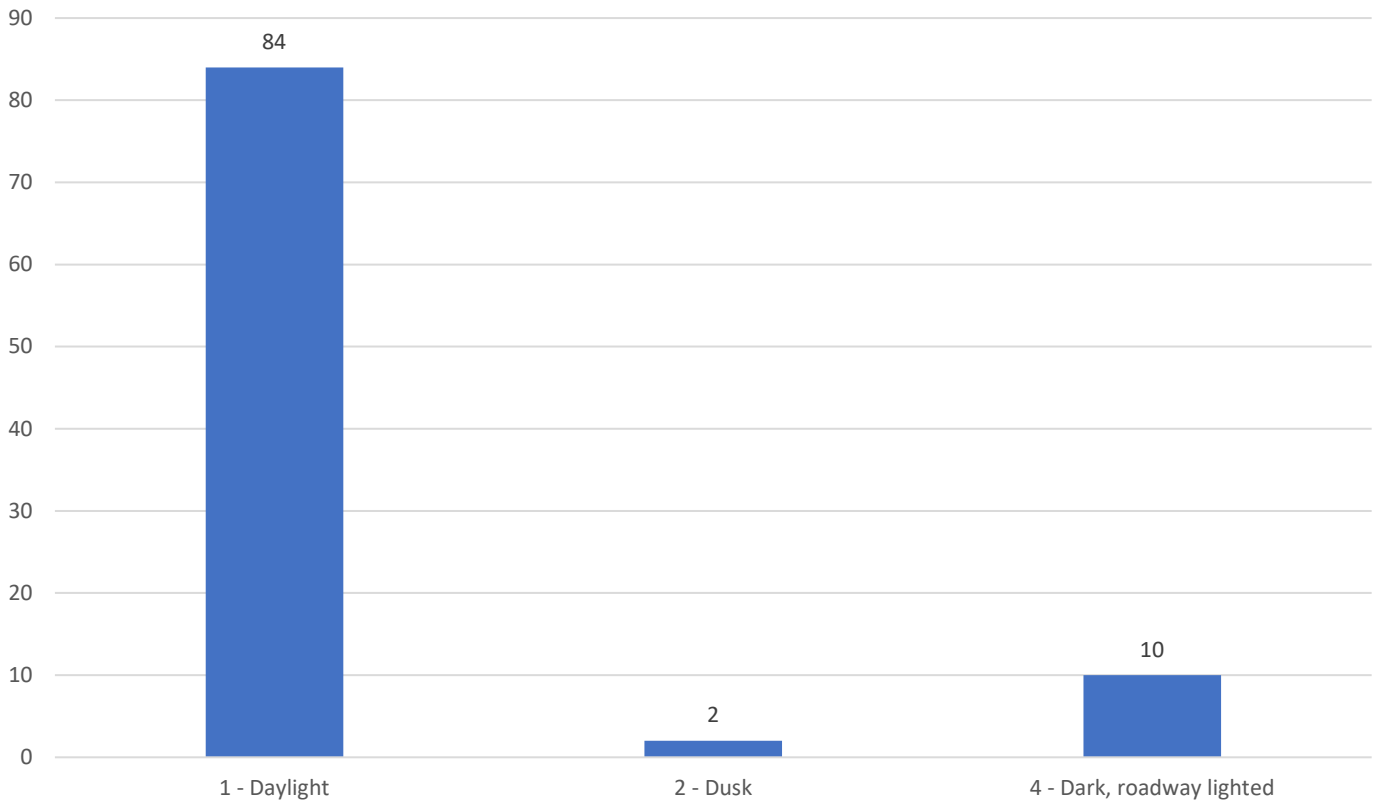

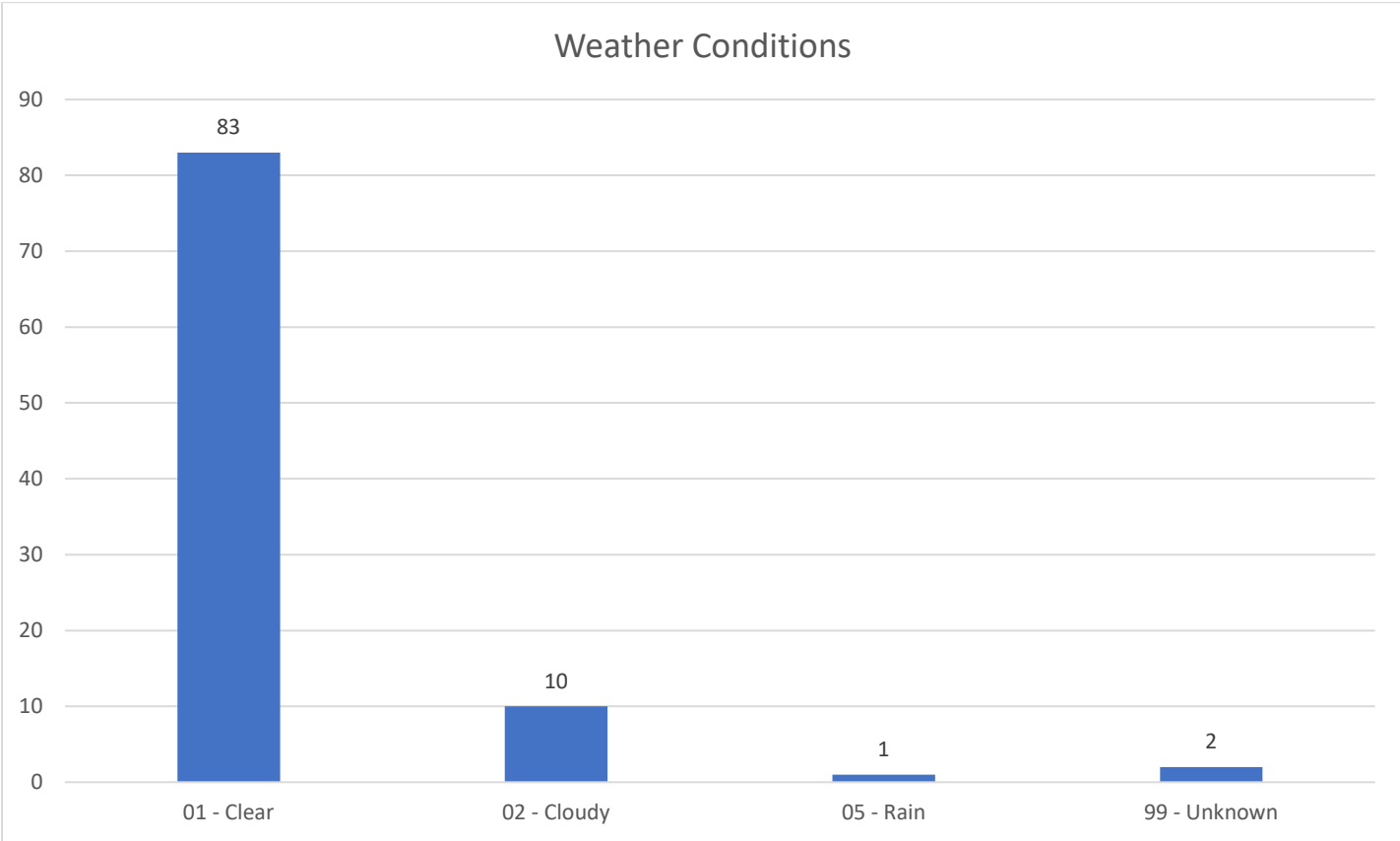
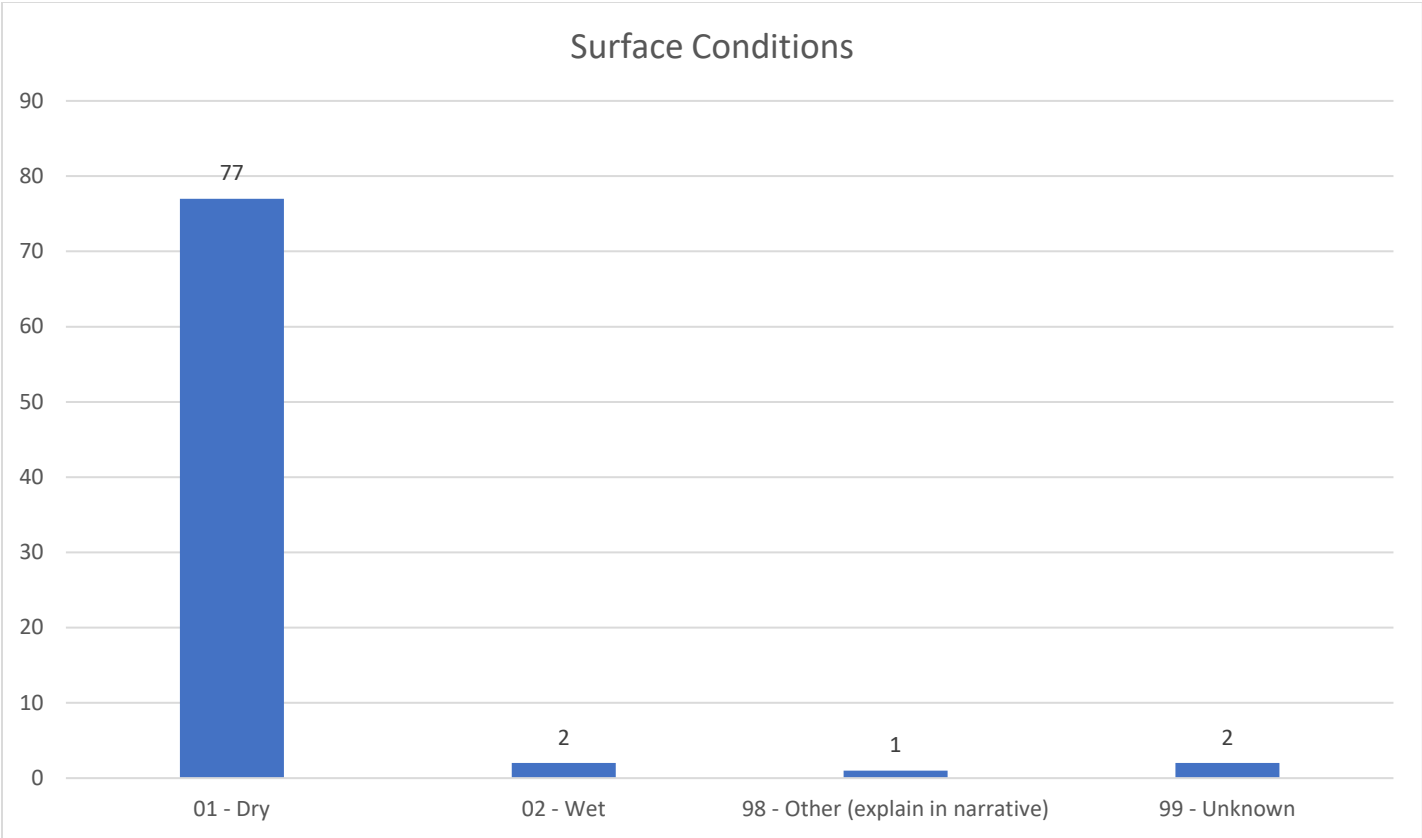


Manner of Crash

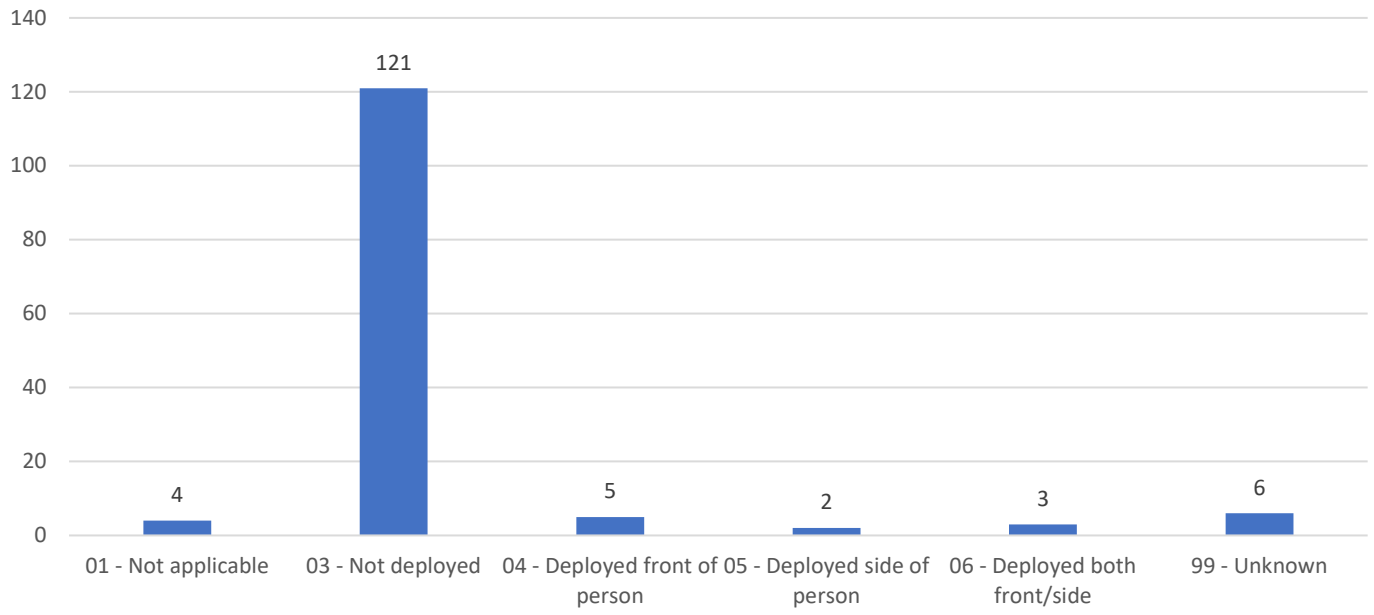

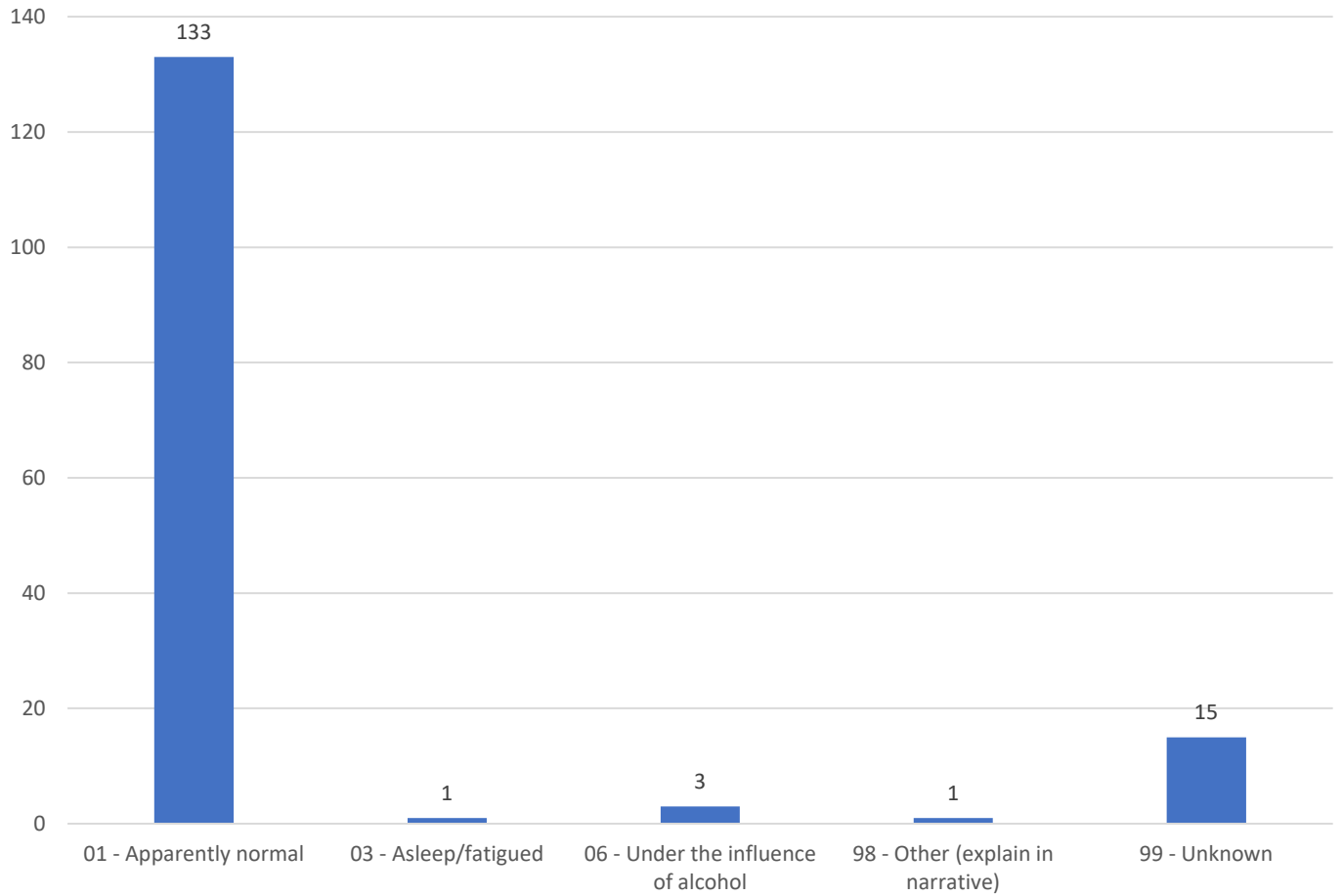




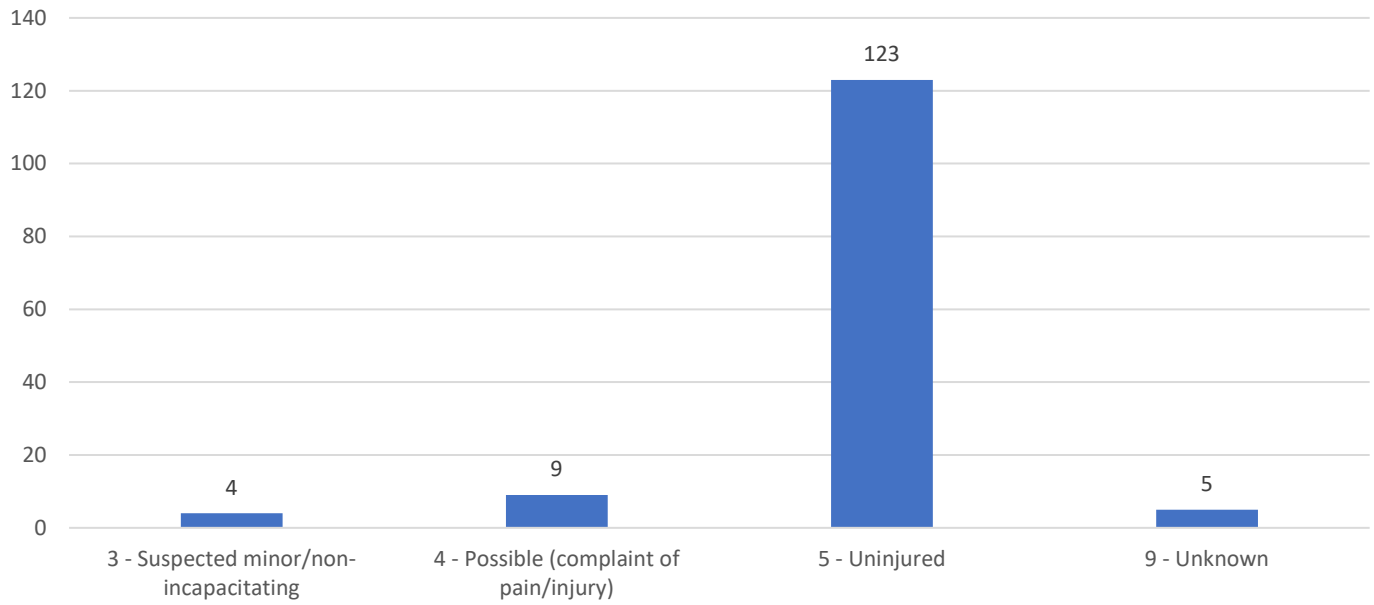
Airbag Deployment



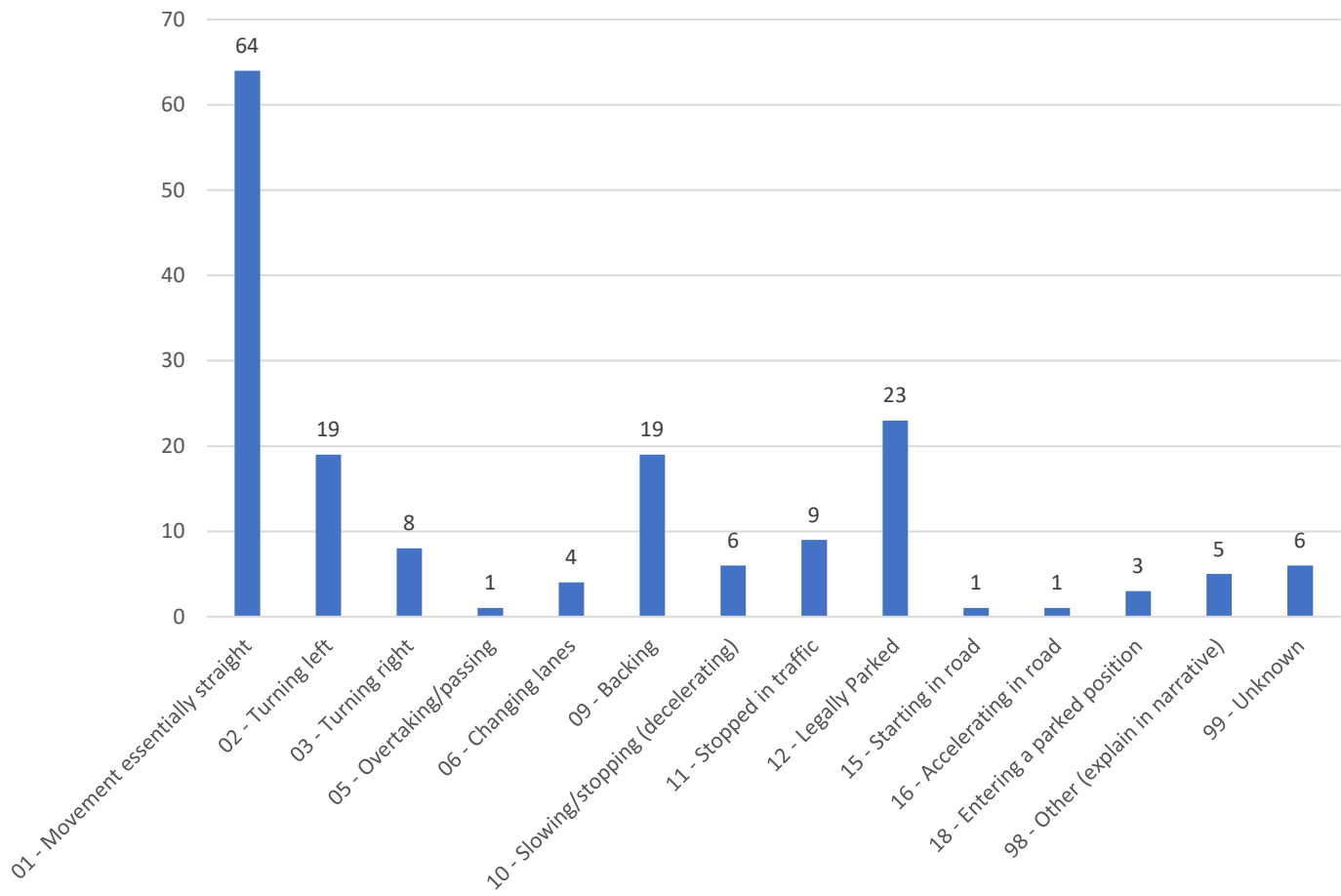

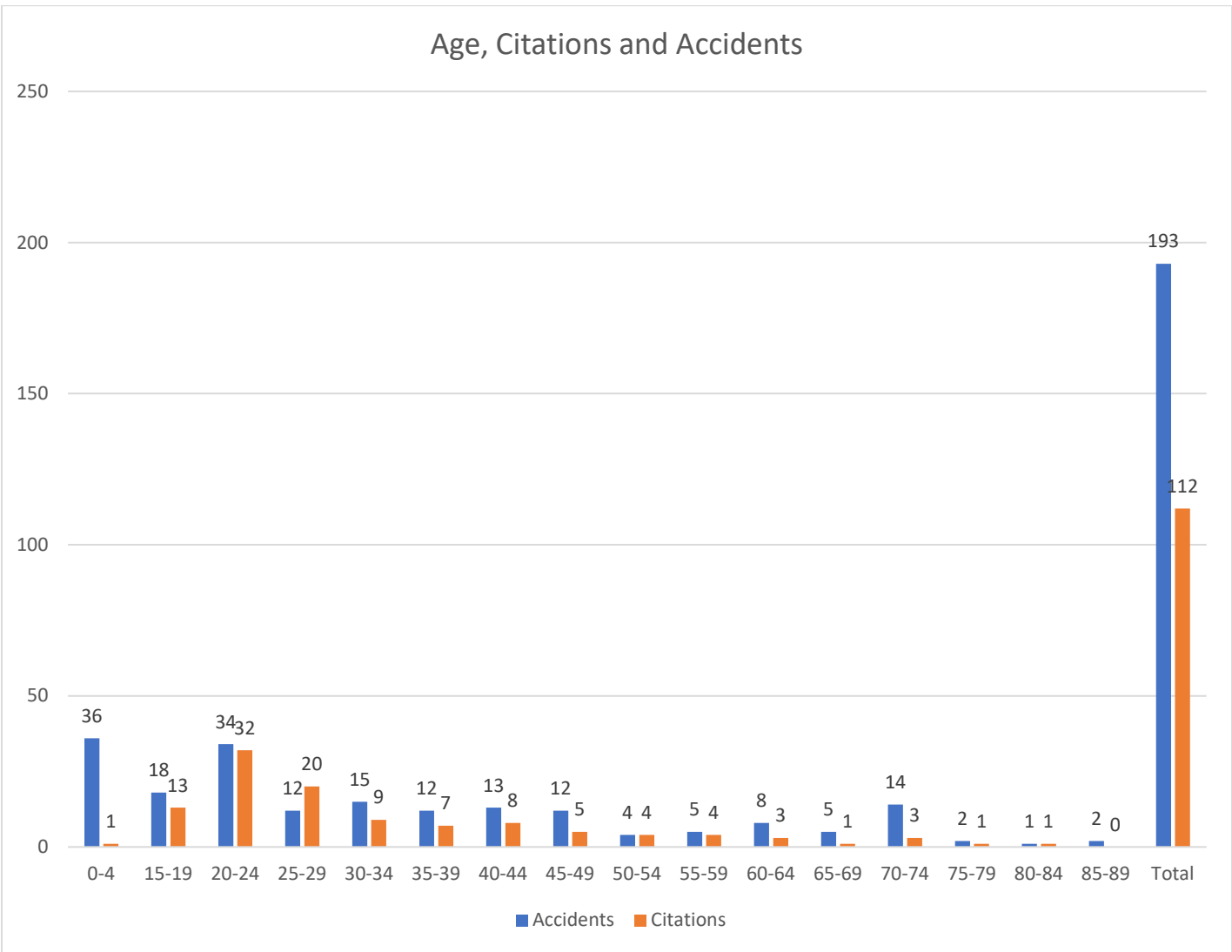
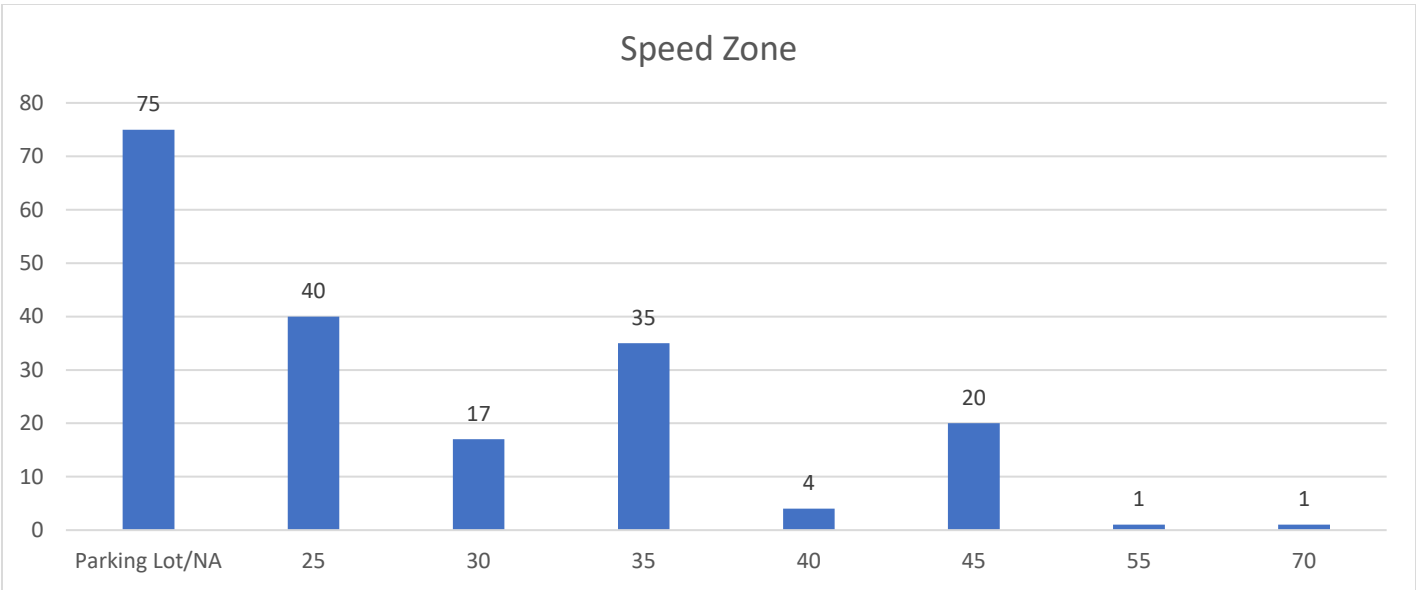


Injury Status

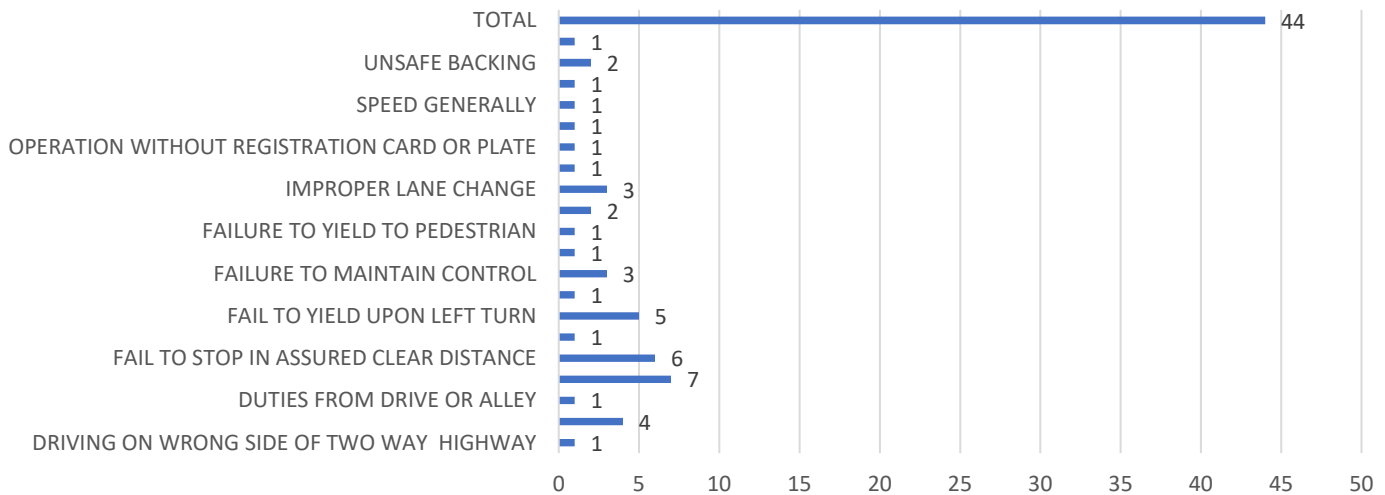
