SUMMARY

August Training: Three officers graduated from ILEA and are in field training. All officers attended crowd management training. Two officers attended rifle instructor training at ILEA. Two officers attended firearms instructor training at ILEA. Two officers attended tactical operations training. Two supervisors attended Creating the Culture training. Three officers and the mental health advocate were certified as trainers for suicide prevention training. Two supervisors participated in a mental health tabletop exercise at MGMC.

August Outreach and Engagement: Officers attended National Night Out and helped distribute over 800 backpacks and hot dogs. Officers assisted in escorting veterans from the Story County Freedom Flight. An officer provided robbery training to a local bank. Officers assisted city and university partners in distributing educational materials concerning hosting responsible parties, enhanced nuisance party fines and updated illegal parking and towing ordinances. A supervisor conducted workplace safety training for a city department. Officers visited a lemonade stand in south Ames. Officers participated in Cop on the Roof at a local coffee shop to benefit Iowa Special Olympics. An officer provided active intruder training at a local church, Sawyer, Fellows, Meeker and Ames Middle School buildings. An officer attended back to school night at Edwards elementary school. Two officers attended WelcomeFest at the Memorial Union. An officer attended a bike rodeo at St. Cecilia School. The Chief spoke at an event at Bandshell park to recognize International Overdose Awareness Day.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Displayed baton Date: August 9, 2022, at 09:41

Details: Officers were called to a residence where a female reported a male had just violated a protective order. Officers were familiar with the man. He ran from the area and was observed by officers fleeing the area. The man was located, and one officer displayed a baton, but did not use it. The man was taken into custody.

Charges: Violation of a Protective Order, Interference with Official Acts, Possession of Drug Paraphernalia

Demographics: 33-year-old white male

Incident 2:

Use of Force: Pointed duty firearm at subject Date: August 12, 2022, at 09:41

Details: Officers received a report of a possible abduction. The report was two white males grabbed a black female and forced her into a vehicle. A vehicle description was given along with a license plate number. Officer located the vehicle, stopped it, and drew their weapons. It was determined that there was no abduction after speaking with all parties and all parties were released.

Charges: None

Demographics: 21-year-old white male

Incident 3:

Use of Force: Grabbed subject and took him to the ground Date: August 14, 2022, at 01:08

Details: While officers were conducting a bar check, they noticed a male in a heated argument with a bouncer that appeared to be escalating. The officer went over to assist. As he spoke to the man, he continued to get more agitated and kept getting closer to the officer. The officer asked the man to step back and put his hand up. The subject pushed the officer's hand away several times while continuing to argue. At this point, the officers could smell the strong odor of an alcoholic beverage coming from the man. Two other males approached and attempted to get in between the officer and the subject. They were removed and officers decided to place the subject under arrest. The man pulled away and officers grabbed the man, took him to the ground, and eventually placed him in handcuffs.

Charges: Disorderly Conduct, Public Intoxication, Interference with Official Acts

Demographics: 23-year-old white male

Incident 4:

Use of Force: Grabbed subject during welfare check Date: August 15, 2022, at 13:26

Details: Officers were called to assist with a juvenile who was having a mental health episode. The male was threatening to kill himself and destroying property. Officers went hands on to put the juvenile into custody to take him to the hospital for evaluation. A charge was requested for some damage done.

Charges: Criminal Mischief, 2nd Offense, Juvenile Referral.

Demographics: 13-year-old white male

Incident 5:

Use of Force: Grabbed subject and took him to the ground Date: August 16, 2022, at 19:59

Details: While officers were conducting an arrest for a warrant, the man became uncooperative, and officers went

hands on and took him to the ground to place him in custody.

Charges: Interference with Official Acts Demographics: 40-year-old white male

Incident 6:

Use of Force: Grabbed subject, took to ground Date: August 18, 2022, at 18:48

Details: Officers were called to a local social service agency because of a reported belligerent individual. When officers located the man, he was still acting disorderly. After an attempt to deescalate the situation, it was clear the man was intoxicated and uncooperative. While placing the man under arrest he attempted to pull away and officers grabbed the subject and eventually took him to the ground to place him in handcuffs.

Charges: Disorderly Conduct, Public Intoxication, Interference with Official Acts

Demographics: 34-year-old white male

Incident 7:

Use of Force: Grabbed subject, took to ground Date: August 26, 2022, at 20:35

Details: Officers were dispatched to a residence where it was reported a wanted subject was staying. The man was located by the officers. The man attempted to flee the officers who took him to the ground to place him in handcuffs.

Charges: Warrant

Demographics: 38-year-old white male

^{*}A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not

limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
