# AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT October 2022



#### **SUMMARY**

October Training: Five officers are in field training. All officers completed low light firearms qualifications and use of force training. An officer attended the Iowa State Police Association conference. A supervisor attended Drug Recognition Expert recertification training. Officers in field training attended precision driver training. Two officers attended field sobriety test instructor recertification training. An officer attended precision driver instructor training. Two officers attended a criminal law update training. Five officers attended de-escalation training. Shift officers received an update from the coordinator of the Alternatives Arrest Diversion Program.

October Outreach and Engagement: A supervisor gave a police department tour to a Girl Scout troop. An officer provided domestic violence training to corrections staff. Two officers conducted alcohol compliance checks with personnel from the Iowa Alcoholic Beverage Division. Police staff participated in Carving with Cops (Halloween jack-olanterns) at the Boys and Girls Club. Four supervisors attended an open house at the Iowa National Guard facility in Boone. The department received two awards for supporting police staff who are in the military. An officer presented on car seat safety at a university childcare center. An officer provided active shooter training for a local clinic. An officer presented on de-escalation and situational awareness at a local church. Two officers visited a local elementary school and donated balls for recreation. Officers attended a first responder appreciation parade at Gilbert High School. Two officers attended the Oak to Riverside neighborhood meeting. Five officers attended block parties throughout the city.

## **USE OF FORCE DETAIL** Incident 1: 22003649

Use of Force: Held down while being handcuffed

Date: October 3, 2022, at 20:11 Details: Officers were called to assist another law enforcement agency in picking up a female on a mental health pick up order. The female was already on the ground and an Ames officer assisted the other agency by holding her down while handcuffs were placed on her. She was taken to a medical facility.

Charges: Assist Other Agency

Demographics: 35-year-old white female

## Incident 2: 22003651

Use of Force: Pointed duty firearm then Taser at a subject Date: October 4, 2022, at 08:18

Details: Officers were dispatched to a local apartment complex where witnesses were reporting a man assaulting a female in the parking lot. They further reported he was pulling her clothing off. She was able to get to her car when officers arrived. She was able to tell officers where the man had gone. The man refused to comply with the orders of the police officers on scene. An officer pointed a duty firearm at the man, then transitioned to a Taser. The man was taken into custody without further resistance.

Charges: Aggravated Domestic Abuse Assault

Demographics: 36-year-old black male

## Incident 3: 22003670

Use of Force: Tackled a subject Date: October 5, 2022, at 12:36

Details: Officers were dispatched to a local convenience store for a report that a man assaulted a female inside the store causing injury. The man threatened several other individuals. The man left in a vehicle. He was located by an officer and his vehicle had a flat tire due to damage he caused fleeing the store. The man attempted to flee on foot from officers. The man was tackled by an officer and two officers had to grab the man to pry his arms from under him to put him in handcuffs. The man admitted to recently using methamphetamines. An officer was injured during the encounter.

Charges: Assault Causing Bodily Injury, OWI 2<sup>nd</sup> Offense, Interference With Official Acts.

Demographics: 50-year-old white male

#### Incident 4: 2200003781

Use of Force: Pointed duty firearm at subject

Details: An officer observed a vehicle fail to stop at a stop sign. As the officer turned to initiate a traffic stop, the vehicle accelerated erratically and struck parked cars. The driver then fled on foot. As officers searched for the driver, the identity of the driver was determined, and he had alerts for assaulting officers and going armed. An officer located the driver hiding in a back yard. An officer pointed their duty firearm at the person and called them out. The man ran, the officer holstered the weapon and followed. The man then tripped and fell, and the officer was able to grab him and put him in handcuffs.

#### Incident 5: 2200003812

Use of Force: Grabbed subject

Details: Officers were conducting routine bar checks. At one establishment, an officer located a man who appeared to too young to be in the establishment. The officer asked for an ID and the man attempted to run towards an exit. The officer grabbed the man and was able to stop him and determined he was underage.

Charges: Possession of a Fake License, Interference with Official Acts

Demographics: 19-year-old white male

#### Incident 6: 2200003814

Use of Force: Grabbed subject, pushed against wall

Details: An officer was flagged down by a security guard working at a local convenience store to assist with a man who was refusing to leave and harassing staff. As officers responded, the man was arguing with the security guard. The man ran from the officers and was later located. While the officer was attempting to get his information for a no trespass order, he again attempted to run, and the officer grabbed him and pushed him against a wall until he could be taken into custody.

Charges: Interference with Official Acts Demographics: 22-year-old white male

## Incident 7: 2200003865

Use of Force: Grabbed subject Date: October 18, 2022, at 18:25

Details: Officers responded to a call of a juvenile assaulting his mother. An officer grabbed the juvenile to stop the

continuing assault.

Charges: Aggravated Assault

Demographics: 14-year-old white male

## Incident 8: 2200004020

Use of Force: Deployed Taser Date: October 27, 2022, at 17:25

Details: An officer recognized an individual at a local convenience store who got into a vehicle. The officer found the man had warrants for his arrest. The man had already entered a car as the passenger and the vehicle drove away. The officer attempted a traffic stop and the driver fled on foot and the wanted subject remained. As the officer approached the man also fled on foot. An officer deployed a Taser after a warning, but the Taser had no effect. Officers continued to pursue on foot and the man eventually gave up and was taken into custody.

Charges: Interference with Official Acts, Possession of Controlled Substance – 3rd or subsequent offense, Possession of

Demographics: 39-year-old black male

#### Incident 9: 2200004029

Use of Force: Pointed Taser Date: October 28, 2022, at 01:38

Details: Officers responded to a fight call. When an officer arrived, he found several males involved in a fight. The officer ordered the males to stop, and they did. Two of the suspects did not want to stay and allow the officer to investigate the assault. As two of the males appeared to be ready to run from the scene, an officer pointed a Taser at them. They ran anyway and the officer did not deploy the Taser or pursue the two. A subject was charged with assault and the two males who fled were described as college age white males.

Charges: None

Demographics: 2 unidentified college age white males.

## Incident 10: 2200004064

Use of Force: Grabbed subject Date: October 29, 2022, at 01:14

Details: Officers responded to a call of individuals with guns threatening others at an apartment complex. As officers arrived on scene there were several individuals attempting to get a subject to leave a party. Officers grabbed the subject to place him in custody. The subject grabbed the officer's holstered weapon and attempted to get it out of the holster. Officers were able to get control and handcuff the man. He continued to resist as they took him to the patrol car to transport him to jail. Two officers sustained injuries.

Charges: Disarming or Attempt to Disarm Police, Disorderly Conduct, Public Intoxication, Interference with Official Acts Demographics: 22-year-old black male

## Incident 11: 2200004064

Use of Force: Grabbed subject and forced her into squad car

Date: October 29, 2022, at 18:40

Details: Officers responded to a call of female passed out in the yard of a private residence. It took officers some time to wake her and she was so grossly intoxicated she was unable to phone a friend or tell officers where she lived. She then began to swear at the officers. Officers placed her under arrest. When officers got to the patrol car with her, she resisted, and officers had to struggle with her to get her into the car resulting in an injury to an officer.

Charges: Assault on Peace Officer or Fire Fighter, Public Intoxication, Interference with Official Acts Demographics: 22-year-old white female

#### Incident 12: 2200004096

Use of Force: Pushed subject's head back Date: October 31, 2022, at 00:27

Details: An officer assisted another law enforcement agency with an arrest. The person was being arrested for public intoxication. As the officers assisted in getting the subject into the squad car, the subject leaned forward and appeared to be possibly trying to bite the officer. The Ames officer pushed the subject's head back.

Charges: No charges/Assist Other Law Enforcement Agency

Demographics: 23-year-old white male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
