**November Training:** Five officers are in field training. All officers attended implicit bias training. A supervisor attended an active shooter and bomb threat training. Five officers attended resiliency training. A supervisor attended FBI LEEDA executive leadership training. Three supervisors attended the Building Inclusive Organizations symposium. Six staff members attended the Iowa International Association of Identification conference. An officer attended an investigator webinar. An officer attended a firearms instructor certification at the academy. Police supervisors attended training on working with challenging employees and an employment law update.

**November Outreach and Engagement:** A detective provided a crime scene investigation presentation to the Ames Resident Police Advisory Committee. A detective provided a homicide investigation presentation at a statewide investigator conference. A supervisor provided drug impaired driver training to prosecutors. An officer provided a tour for Academy Explorers. A supervisor and the Mental Health Advocate provided a presentation at a mental health meeting. An officer provided robbery training to a local bank. An officer installed four car seats for local families. An officer assisted in firearms training for new recruits at the academy. Two officers provided a patrol car tour for children in north Ames. An officer delivered donuts to a local kids shelter.

**USE OF FORCE DETAIL**

**Incident 1: 22004286**

Use of Force: Grabbed subject, took to ground Date: November 10, 2022, at 22:29  
 Details: Officers were conducting routine bar checks when two individuals were found in the establishment underage. An officer began the process of identification to write a ticket when the man tried to run. The officer grabbed him and eventually had to take him to the ground to keep him from fleeing.

Charges: Interference with Official Acts, Unlawful use of a License  
 Demographics: 20-year-old white male

**Incident 2: 22004287**

Use of Force: Pointed duty firearm and Taser at subject Date: November 10, 2022, at 22:48  
 Details: Officers responded to a call of man in the street carrying a bat and threatening people. An officer pointed a Taser while another officer pointed his duty firearm at the individual until he could be restrained by other officers.

Charges: Criminal Mischief, 1<sup>st</sup> Degree, Disorderly Conduct  
 Demographics: 29-year-old white male

**Incident 3: 22004316**

Use of Force: Pointed duty firearm and Taser at subject Date: November 14, 2022, at 02:19  
 Details: Officers responded to a 911 call where a female was asking for help. When officers arrived, they spoke to witnesses and an involved person who was injured. A male locked himself in a bedroom and refused to cooperate with

the investigation. The bedroom door was breached, and duty firearms were pointed at the subject. The subject eventually complied, and he was arrested.

Charges: Interference with Official Acts  
Demographics: 32-year-old American Indian

**Incident 4: 22004341**

Use of Force: Grabbed subject Date: November 15, 2022, at 15:38  
Details: Officers were called to the courtroom at City Hall at the request of a judge. During a hearing, a female made suicidal statements. She left the courtroom and officers located her, attempted to deescalate her, and ultimately had to grab her to get her into custody to be taken to the hospital.

Charges: No Charges, taken to hospital for evaluation  
Demographics: 29-year-old white female

**Incident 5: 22004378**

Use of Force: Pointed duty firearm at subject Date: November 19, 2022, at 00:43  
Details: An officer was called to assist another local agency on a high risk stop where an officer was assaulted. The officer pointed a duty firearm at subjects in the car until they were secured.

Charges: No Ames Police charges  
Demographics: Unknown

**Incident 6: 22004388**

Use of Force: Grabbed subject/Taken to ground Date: November 19, 2022, at 19:24  
Details: An officer, assigned to the Iowa State football game, noticed Security having problems with a man at the gate. Security said he was not allowed in. The officer immediately noticed the man was intoxicated. The man was given options and continued to argue with the officer. Eventually, the officer told the man to leave the gate area or be arrested. The man refused. The officers attempted to place the man in handcuffs, and he resisted, clinching his fists. The officer grabbed the man, wrestled with him, and then took him to the ground. Other officers came to help handcuff the man.

Charges: Public Intoxication, Interference with Official Acts  
Demographics: 20-year-old white male

**Incident 7: 22004466**

Use of Force: Grabbed Subject Date: November 27, 2022, at 00:54  
Details: Officers were dispatched to a local bar to investigate an assault. Upon their arrival, the group of males involved with the altercation was located. One of the individuals attempted to walk away and an officer grabbed his arm to keep him in the area. Ultimately, no charges were filed against anyone.

Charges: None  
Demographics: 23-year-old white male

**Incident 8: 22004496**

Use of Force: Grabbed Subject Date: November 28, 2022, at 21:58  
Details: Officers were called to a local convenience store to a report of a man exposing himself. As officers arrived, the man walked away. Officers approached and immediately noticed the odor of an alcoholic beverage coming from the man. Officers determined the man was intoxicated and attempted to take him into custody. The man refused to put his hands behind his back for handcuffing. Officers grabbed the individual and were able to handcuff him.

Charges: Public Intoxication, Indecent Exposure, Interference with Official Acts

Demographics: 51-year-old white male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
