### SUMMARY

**January Training:** Two officers are attending the Iowa Law Enforcement Academy. An officer completed the field training program. All officers attended the third module of de-escalation training. Three officers attended an interview and interrogation training. A supervisor and an officer attended Constitutional Use of Force training. A supervisor and an officer attended a sex crimes conference. An officer attended a computer forensics training. A supervisor attended emergency alert administrator training.

**January Outreach and Engagement:** Two officers and the Mental Health Advocate provided suicide prevention training to community members. Two officers assisted the Bridge Home with outreach to homeless individuals. Two officers provided traffic management training to fire department recruits. Officers attended the MLK celebration at city hall. An officer worked with city electric employees to identify hazards at electric sites. Two officers hosted an I.D. training for 100 bar employees. An officer conducted a safety talk for city employees. An officer hosted a meeting for local property managers. An officer conducted a Cub Scout tour at the police department. An officer conducted a safety talk at a medical facility.

### USE OF FORCE DETAIL

#### Incident 1: 23000002

Use of Force: Grabbed subject Date: January 1, 2023, at 00:40  
 Details: Officers were dispatched to a report of a possible fight in the parking lot of an apartment complex. Officers arrived and found a man who was reported to be the person causing issues. The man also appeared to be under the influence. The officers attempted to take the man into custody, and he resisted. Officer grabbed the man and got control of him, placing him under arrest.

Charges: Public Intoxication, Possession of a Controlled Substance  
 Demographics: 23-year-old white male

#### Incident 2: 23000008

Use of Force: Grabbed subject/Deployed Pepper Spray Date: January 1, 2023, at 15:47  
 Details: Officers were dispatched to a report a possible domestic situation. When officers arrived, they found a man who was very agitated. The officers attempted to deescalate the situation, but the male continued to yell and threaten. Officers attempted to take the man into custody, and he attempted to pull away. Officers grabbed the man and an officer eventually used pepper spray on the man. Officers were then able to get the man into custody. The man was evaluated to by medics who cleared him for jail.

Charges: Disorderly Conduct, Interference with Official Acts  
 Demographics: 44-year-old white male

#### Incident 3: 23000057

Use of Force: Grabbed subject Date: January 5, 2023, at 17:17

Details: Officers were dispatched to a report of a disorderly male at an apartment building. The man was located, and officers determined he was intoxicated. Officers attempted to take him into custody, and he pulled away. Officers grabbed the man and were able to get him in handcuffs. During a search incident to arrest, a handgun was found in his waistband. An officer sustained an injury to his hand that required a visit to the Emergency Department.

Charges: Public Intoxication, Interference with Official Acts, Possession of/Carrying Firearm While Under the Influence  
Demographics: 42-year-old white male

**Incident 4: 23000066**

Use of Force: Display of Duty Firearm

Date: January 6, 2023, at 13:22

Details: Officers conducted a search of a residence for a wanted person. The man had several warrants for his arrest. Officers had their service weapons drawn during the search. The man was taken into custody without any other use of force beyond display of duty weapons.

Charges: Burglary, 3<sup>rd</sup> Degree

Demographics: 36-year-old white male

**Incident 5: 23000079**

Use of Force: Grabbed subject, took to ground

Date: January 8, 2023, at 01:49

Details: During routine patrol, an officer saw a heated dispute in front of a local bar. The officers stopped to investigate. As the officers were investigating the dispute, a male was located who was continuing to be loud and attempting to get into a fight. Officers gave him a warning to leave the area several times and he did not. Officers noted signs of intoxication and finally decided they needed to get him into custody. At that point, the man tried to pull away and officers took him to the ground where he was handcuffed.

Charges: Public Intoxication, Disorderly Conduct

Demographics: 26-year-old white male

**Incident 6: 23000171**

Use of Force: Display of Duty Firearms

Date: January 14, 2023, at 11:26

Details: During the investigation of a shooting, several officers displayed duty firearms.

Charges: Attempted Murder

Demographics: 27-year-old black male

**Incident 7: 23000201**

Use of Force: Grabbed subject

Date: January 16, 2023, at 18:23

Details: Officers responded to a report of an intoxicated male at an apartment building. He was located by officers and found to be intoxicated. When officers attempted to arrest the man, he resisted, and the officers grabbed the man to place him in handcuffs. He was also found to be violating a protective order.

Charges: Public Intoxication, Contempt – Violation of No-Contact Order

Demographics: 61-year-old white male

**Incident 8: 23000282**

Use of Force: Grabbed subject/Handcuffed subject

Date: January 21, 2023, at 19:04

Details: Officers were dispatched to a report of an out-of-control juvenile at a residence. Officers grabbed the juvenile and handcuffed him to stop self-harm activities and to stop him from hurting family members. Once the scene was de-escalated, the handcuffs were removed, and the juvenile went to a local health care provider for evaluation.

Charges: None

Demographics: 14-year-old white male

**Incident 9: 23000331**

Use of Force: Grabbed subject

Date: January 25, 2023, at 20:29

Details: Officers responded to a report of a disorderly individual at a local apartment. One tenant was attempting to enter the apartment of another tenant during a dispute. Officers arrived and located a woman who was intoxicated. After investigating, officers arrested the woman who pulled away from them. Officers grabbed the woman to get her into handcuffs.

Charges: Public Intoxication, Disorderly Conduct

Demographics: 44-year-old white female

**Incident 10: 23000366**

Use of Force: Grabbed subject

Date: January 28, 2023, at 04:01

Details: Officers responded to a report of an altercation at a local apartment. A female in distress was located and stated she had been in an altercation with her boyfriend. Officers located the male attempting to leave the scene. Officers gave the male commands to stop, but the male continued to attempt to flee. Officers decided to detain the male in handcuffs to keep him from leaving the scene. The male continued to resist so officers grabbed the male and placed him against a wall to secure him in handcuffs. The male was ultimately arrested.

Charges: Simple/Serious Domestic Assault, Child Endangerment

Demographics: 29-year-old black male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
