February Training: Two officers are attending the lowa Law Enforcement Academy. All officers attended mental health training focused on trauma. An officer attended a sextortion investigation webinar. Three officers attended a mental health wellness check webinar. Three supervisors attended a training documentation webinar. An officer assisted with firearms training at the Academy. An officer attended a tactical training conference. Two officers attended defensive tactics recertification training. An officer attended a tactical training management and risk mitigation on-line training. The Story County Attorney's Office provided domestic assault investigation training for all officers.

February Outreach and Engagement: The 44th Citizen Police Academy class kicked off in February. The Community Resource Officer hosted the following tours of the police department: REM Iowa, ISU Women's Club, DMACC Criminal Justice class, and Ames Firefighter recruit class. The Community Resource Officer also attended the ISU People to People Career Fair, property managers luncheon, Fellow's Science Fair, Cub Scout meeting and MOPS (Mothers of Preschoolers) in Story City. Six officers attended the NAACP Freedom Fund banquet. Six officers attended the Boys and Girls Club of Story County Gala. Officers conducted alcohol and tobacco compliance checks. Four officers hosted a quarterly bar manager and owner meeting. Two officers conducted an alcohol safety presentation for a fraternity.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject, took to ground

Date: February 3, 2023, at 19:28

Details: Officers were dispatched to a report of a theft from a local business. An officer arrived and found a man who matched the description of the suspect. The officer attempted to take speak with the man about the theft. The suspect placed his hands in his pockets and refused to comply with the officer. The officer attempted to take the suspect into custody, and he resisted. The officer grabbed the man who then tried to run. At that point, the officer took the suspect to the ground where he was handcuffed.

Charges: Theft 4th Degree, Interference with Official Acts

Demographics: 43-year-old white male

Incident 2:

Use of Force: Display of Duty Firearm/Grabbed subject Date: February 3, 2023, at 21:17

Details: Officers located a wanted subject at a local hotel. When officers attempted to take the subject into custody, he presented a clothes iron and refused to comply with officers' commands. The officers pinned the subject behind the door of the hotel room and continued to give the subject verbal commands to drop the clothes iron. The subject ultimately dropped the clothes iron and was taken into custody without further incident.

Charges: Possession of Controlled Substance, Possession of Drug Paraphernalia, Warrant Arrest

Demographics: 44-year-old white male

Incident 3:

Use of Force: Grabbed subject/Handcuffed subject

Date: February 6, 2023, at 18:39 Details: Officers were dispatched to a report of an out-of-control juvenile who was throwing things and being destructive at a residence. The juvenile left the residence and was located inside a nearby business. The juvenile was rolling around on the floor of the business. Officers attempted to speak with the juvenile who then tried to assault one of the officers and others around him. The juvenile was ultimately secured in handcuffs for his safety and the safety of the officers. The juvenile was transported to MGMC for a mental health evaluation.

Charges (Juvenile Referrals): Simple Assault-2 counts, Theft 5th Degree, Disorderly Conduct

Demographics: 13-year-old white male

Incident 4:

Use of Force: Taser Deployment/Grabbed subject

Date: February 6, 2023, at 21:41 Details: Officers were dispatched to a report of a reckless driver. Officers located the vehicle parked at a local apartment complex with the suspect passed out in the driver's seat of the vehicle. Upon waking the subject, he refused to provide his identity and became verbally aggressive toward officers. Officers attempted multiple times to de-escalate the subject, but he would not comply with their commands. Officers went to place the subject into custody, and he attempted to punch one of the officers in the face. Another officer deployed his Taser, and it was effective. The subject was brought to the ground in a controlled manner by other officers and was placed in handcuffs. The suspect continued threatening officers and was placed in the back of a patrol car with assistance of officers. The subject forcefully kicked the rear door of the squad car causing damage to it while on his way to the Story County Jail.

Charges: OWI 3rd Offense, Striking Unattended Vehicle, Driving While Barred, Driving While Revoked-2 counts, Failure to Provide Security Against Liability-Accident Related, Revocation of License Ignition Interlock Device, Criminal Mischief 2nd Degree, Harassment of Public Official, Interference with Official Acts

Demographics: 35-year-old black male

Incident 5:

Use of Force: Display of firearm

Date: February 10, 2023, at 10:48 Details: During the execution of a search warrant, officers encountered a subject and displayed their firearms as they ordered the subject to comply with lawful orders. The subject complied and no other force was used during the remainder of the investigation.

Charges: Pending

Demographics: 37-year-old white male

Incident 6:

Use of Force: Grabbed subject

Date: February 11, 2023, at 02:01 Details: Officers stopped a vehicle for several traffic violations and found the driver to be intoxicated. During the OWI investigation, the subject became uncooperative. The subject was placed in a transport belt and while the officer attempted to double lock the handcuffs, the subject tensed up and leaned back. The officer placed his hand on the subject's chest and held him against the wall until other officers could assist. The subject was then secured in handcuffs without further incident.

Charges: OWI 2nd Offense, Failure to Maintain Control, Failure to Provide Financial Liability

Demographics: 30-year-old white male

Incident 7:

Use of Force: Grabbed subject Date: February 11, 2023, at 14:38

Details: Officers responded to a report of an erratic driver. Officers located the vehicle as it pulled into a parking lot and contacted the driver. Officers determined the subject was intoxicated. When officers attempted to arrest the female,

she resisted, and the officers grabbed the female to place her in handcuffs.

Charges: OWI 2nd Offense, Interference with Official Acts

Demographics: 30-year-old white female

Incident 8:

Use of Force: Display of Taser Date: February 12, 2023, at 00:23

Details: Officers were doing compliance checks inside a local bar when they located a subject who they believed to be under the legal age. As officers were attempting to get the subject's identity, he took off running from officers. During the foot chase, one of the officers displayed his Taser and gave verbal commands to the subject, who was still running, and ordered the subject to stop. The subject complied and was taken into custody without any further use of force.

Charges: Unlawful Use of License, Minors Prohibited on Certain Premises, Interference with Official Acts

Demographics: 20-year-old white male

Incident 9:

Use of Force: Display of Taser Date: February 12, 2023, at 03:48

Details: Officers located two males engaged in a physical altercation on a public sidewalk. The officer witnessed one of the males being knocked to the ground. As the officer approached the males, he pointed his Taser at the subject who was still standing and ordered him to the ground. The subject complied and the officer was able to detain both subjects in handcuffs without any further use of force. Both subjects were subsequently arrested.

Charges: Disorderly Conduct, Public Intoxication

Demographics: 27-year-old white male and 28-year-old white male

Incident 10:

Use of Force: Grabbed subject/Handcuffed subject

Date: February 14, 2023, at 20:55 Details: An officer made a routine traffic stop and the two occupants fled the vehicle on foot. After a short foot pursuit, officers located one of the subjects nearby. The subject was non-complaint and attempted to flee again. As a result, officers grabbed the subject and directed him to the ground where he was placed in handcuffs. Warrants were issued for the other subject.

Charges: Dark Window or Windshield, Failure to Maintain Registration Plate, Failure to Provide Financial Liability,

Interference with Official Acts

Demographics: 19-year-old white male and 17-year-old black male

Incident 11:

Use of Force: Grabbed subject/Taken to ground Date: February 20, 2023, at 17:39

Details: Officers were dispatched to a local convenience store for a report of a disorderly subject who was yelling, being belligerent and rude. Officers located the subject nearby and found him to be intoxicated. Officers grabbed the subject to keep him from walking away. The subject was taken to the ground to keep him from harming himself and others. He was ultimately secured in handcuffs and arrested.

Charges: Disorderly conduct, Public Intoxication

Demographics: 41-year-old white male

Incident 12:

Use of Force: Grabbed subject/Taken to ground

Date: February 24, 2023, at 14:09 Details: Officers were dispatched to a local residence on a report of an intoxicated subject who was being assaultive and attempting to break into a safe. Officers located the subject outside. Officers attempted to get the subject to comply, but he continued being aggressive. The subject physically resisted officers attempts to place him in handcuffs. Officers grabbed the subject and took him to the ground where he continued resisting until he was ultimately detained in handcuffs. One officer sustained an injury to his back during the altercation.

Charges: Public Intoxication, Interference with Official Acts, Possession of Fake License

Demographics: 18-year-old white male

Incident 13:

Use of Force: Grabbed subject Date: February 28, 2023, at 12:59 Details: Officers were dispatched to a local apartment to assist another law enforcement agency. Upon arrival, officers found a law enforcement officer on the ground in a physical altercation with a subject. Officers assisted the law

enforcement officer in securing the female in handcuffs.

Charges: None

Demographics: 36-year-old white female

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Nondiscretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
