# AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT **March 2023**



#### **SUMMARY**

March Training: Two officers are attending the Iowa Law Enforcement Academy. All officers attended hazardous materials and bloodborne pathogen training. All officers attended defensive tactics training. A supervisor attended a supervisor liability webinar. The Crisis Negotiations Team attended the Iowa Crisis Negotiators Association spring training event. Two officers and the Mental Health Advocate facilitated suicide intervention training. Three officers assisted the law enforcement academy with firearms training and domestic violence training. An officer attended a leadership training at the academy. Two officers attended the Iowa State Police Association Women's Conference. An officer attended an interview and interrogation training. An officer attended a defensive tactics instructor training. A supervisor and the police chaplain attended a Chaplain/Peer Support training. The Emergency Response Team trained twice during the month.

March Outreach and Engagement: The 44<sup>th</sup> Citizen Police Academy completed weeks 3-7, which included use of force overview and scenarios, animal control, active shooter response, mental health response and a mock trial. The Community Resource Officer attended the following: presentation for ISU psychology class, ISU Football Pro Day, presentation at AHS, property manager meeting, violence in workplace presentation for a local grocery store, presentation for Ukrainian refugees, grand opening of a tire store, and a mental health presentation at the library. An officer provided a tour to a Boy Scout troop. An officer conducted bank robbery training at a local bank. A supervisor spoke with children at a local preschool. Three police officers conducted alcohol compliance checks at licensed liquor establishments. Two officers attended local schools to donate sports equipment. Two officers conducted ID card training for a local bar.

#### **USE OF FORCE DETAIL**

## **Incident 1:**

Use of Force: Grabbed subject Date: March 4, 2023, at 12:29

Details: Officers were dispatched to a report of a disorderly juvenile who was being assaultive. An officer arrived and located the juvenile who refused to leave a location where he was not allowed to be. The officer attempted to escort the juvenile from the scene, but he pulled away from the officer. The officer grabbed the juvenile by the arm and escorted him away from the area. The juvenile was taken to MGMC by ambulance for a mental health evaluation.

Charges: No charges

Demographics: 13-year-old white male

#### **Incident 2:**

Use of Force: Display of firearm

Date: March 10, 2023, at 19:06 Details: Officers were dispatched to a report of a female who was being followed and chased by a man. When officers arrived in the area, they located the man who was following the female caller. Officers contacted him, and he told officers he had a gun and proceeded to remove the gun from his jacket. Officers displayed their firearms as they ordered the subject to comply with lawful orders. The subject complied and no other force was used during the remainder of the investigation. It was later determined that the gun was an airsoft gun in a 1911 pistol model replication.

Charges: No charges

Demographics: 53-year-old white male

#### Incident 3:

Use of Force: Grabbed subject Date: March 11, 2023, at 00:49

Details: An officer made a routine traffic stop on a vehicle without headlamps. The driver was found to be intoxicated. The driver refused to exit the vehicle and refused to comply with officers demands. Officers had to grab the subject and physically remove him from the driver's seat of the vehicle. During the arrest, one of the officers sustained minor injuries to one of his hands.

Charges: OWI 2<sup>nd</sup> Offense, Failure to Use Headlamps When Required, Interference with Official Acts Causing Injury

Demographics: 36-year-old white male

### **Incident 4:**

Use of Force: Grabbed subject Date: March 11, 2023, at 02:11

Details: Officers arrested an intoxicated male who was having trouble walking. Once at the PD, the male voluntarily gave up the use of his legs and officers had to carry him inside to be evaluated by paramedics. The male was cleared medically and transported to the Story County Jail without further incident.

Charges: Public intoxication

Demographics: 69-year-old white male

### **Incident 5:**

Use of Force: Grabbed subject/handcuffed subject

Details: Officers were dispatched to a juvenile home reference two clients fighting. Officers separated the two juvenile males and issued them juvenile referrals for disorderly conduct. Officers were later called back inside for one of the juvenile males who was assaulting staff. Officers had to grab the juvenile and detain him in handcuffs for his safety and the safety of others. This juvenile male was issued another juvenile referral for assault with intent to inflict serious injury as he had attempted to strangle a staff member.

Charges (Juvenile Referrals): Disorderly conduct, Assault with intent to inflict serious injury

Demographics: 13-year-old white male, 12-year-old white male

#### **Incident 6:**

Use of Force: Handcuffed subject

Details: Officers responded to a local business reference a disorderly subject who ran from a youth shelter. Officers located the juvenile inside the store. The juvenile was attempting to kick and punch bystanders. Officers handcuffed the juvenile to prevent him from injuring himself and others. The juvenile was taken to Mary Greeley Medical Center for a mental health evaluation.

Charges: None

Demographics: 13-year-old white male

### **Incident 7:**

Use of Force: Grabbed subject

Details: Officers were dispatched to a local business reference a shoplifting case. Officers arrived on scene and observed a store employee chasing the suspect. Officers ran after the suspect and grabbed him by his hooded sweatshirt and pulled him to the ground. The suspect was taken into custody without further incident.

#### **Incident 8:**

Use of Force: Display of firearm/handcuffed subject

Details: An officer made a routine traffic stop. The driver and front seat passenger fled the vehicle and ran to a nearby apartment. The driver ultimately exited the apartment at which point the officer drew his service weapon. Once the officer confirmed the suspect did not have anything in his hands, he re-holstered his weapon and attempted to place the adult suspect in handcuffs. The adult suspect continued to pull his hands away from the officer, but he was ultimately secured in handcuffs. The juvenile then exited the apartment and was also secured in handcuffs. The juvenile was ultimately compliant and was released from handcuffs and turned over to his guardian.

Charges: Interference with official acts, Excessive window tint Demographics: 19-year-old white male, 17-year-old white male

### **Incident 9:**

Use of Force: Display of firearm

Date: March 19, 2023, at 15:38 Details: Officers were requested by another law enforcement agency to assist with a search warrant at a local apartment. Due to the nature of the investigation, officers had their duty weapons drawn when the search warrant was

executed. No other use of force was needed during the remainder of the investigation.

Charges: No local charges

Demographics: 41-year-old black female, 16-year-old black male

### Incident 10:

Use of Force: Grabbed subject

Details: Officers were dispatched to a local business reference a disorderly male. Upon arrival, officers found the suspect to be intoxicated and ultimately placed him under arrest. While the suspect was being transported to the Story County Jail, he began to kick the partition inside the squad car and bang his head on the plexiglass. Upon arrival at the jail, the officer grabbed the subject to prevent him from harming himself any further.

Charges: Public intoxication

Demographics: 19-year-old white male

# Incident 11:

Use of Force: Grabbed subject

Details: Officers were dispatched to assist with a juvenile who was being disorderly and refusing to go back to a local youth shelter. The juvenile had attempted to vandalize passing vehicles and refused to comply with shelter staff. The officer grabbed the juvenile and placed him in a wristlock and directed him to a patrol car. Once inside the patrol car, the juvenile was transported back to the youth shelter and turned over to staff. No charges were filed.

Charges: none

Demographics: 13-year-old white male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Nondiscretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused
