Six officers attended Coffee with Cops at a local coffee shop. An officer attended a Community I.D. event at the library. An officer attended the Farmer’s Market. An officer led the Memorial Day Parade. A supervisor instructed suicide intervention training for community members.

USE OF FORCE DETAIL

Incident 1: 23001638

Use of Force: Handcuffed subject Date: May 4, 2023, at 12:38
 Details: Officers were dispatched to a residence where the female suspect was threatening others with a knife. Upon arrival, officers located the female suspect who refused to allow officers to check on the victims who had locked themselves in a bedroom inside the home. Due to the nature of the call, officers placed the female suspect in handcuffs and seated her in the back of a patrol vehicle while they spoke with the victims and witnesses. The female suspect was ultimately released to a legal guardian and was referred to juvenile court.

Charges (Juvenile Referral): Domestic Assault with Intent or Weapon
 Demographics: 16-year-old white female

Incident 2: 23001671

Use of Force: Grabbed subject Date: May 5, 2023, at 22:05
 Details: Officers were investigating a separate incident when the male suspect approached officers. The male suspect was acting erratically. The male suspect gave officers a fictitious name. One of the officers knew the male suspect from previous encounters. A routine check found he had a warrant for his arrest. The male suspect attempted to pull away

from officers and flee when he was being detained. The male suspect was taken to the ground by officers and secured in handcuffs without further incident.

Charges: Interference with Official Acts, Harassment of Public Officials and Employees, Warrant Arrest

Demographics: 19-year-old black male

Incident 3: 23001788

Use of Force: Grabbed subject

Date: May 12, 2023, at 17:05

Details: Officers located a missing juvenile and attempted to speak with her. The female juvenile ran from the officers and went into a portable outhouse. When officers attempted to speak with the female juvenile again, she attempted to flee. Officers grabbed the female and placed her arms behind her back and escorted her to a patrol vehicle. Officers were able to speak with the female juvenile and convince her to get into the back of the patrol vehicle without further resistance. The female was returned to her residence without incident.

Charges: No local charges

Demographics: 13-year-old white female

Incident 4: 23001873

Use of Force: Display of Taser

Date: May 18, 2023, at 19:23

Details: Officers were dispatched to an intersection for the report of a disorderly male who was pounding on a car and screaming. The male suspect began fighting with the caller and was attempting to get into the caller's vehicle. The first responding officer displayed his Taser and ordered the male suspect to get away from the vehicle. When an additional officer arrived, the officers grabbed the male suspect and placed him under arrest without further incident.

Charges: Disorderly Conduct

Demographics: 21-year-old black male

Incident 5: 23001940

Use of Force: Grabbed subject

Date: May 23, 2023, at 16:44

Details: Officers were dispatched to a local motel for an intoxicated male who was refusing to leave the lobby. When officers arrived, the male was lying on the floor and was incoherent. Officers requested paramedics evaluate the male. It was determined the male needed to be taken via ambulance to MGMC for evaluation. When officers attempted to get the male on the cot, he began flailing his arms around. Officers grabbed the male's wrists to control him and guide him onto the cot. The male was treated at MGMC and subsequently released from their care and arrested.

Charges: Public Intoxication

Demographics: 53-year-old white male

Incident 6: 23001990

Use of Force: Grabbed subject

Date: May 28, 2023, at 0853

Details: Officers were dispatched to a law department assist at a local residence to serve an outstanding arrest warrant. When officers made contact with the wanted male, he leaned back in an attempt to pull away. Officers grabbed the subject and secured him in handcuffs without further incident.

Charges: Arrest warrant

Demographics: 23-year-old white male

Incident 7: 23002007

Use of Force: Grabbed subject

Date: May 29, 2023, at 18:16

Details: Officers were dispatched to a local residence for a female who was damaging a vehicle. Upon further investigation, it was determined the damage to the vehicle was significant. When officers attempted to place the female

into custody, she kicked one of the officers. Officers took the female to the ground to gain control of her and prevent her from injuring herself or the officers. The female continued to be combative and attempted to punch one of the officers in the face. She was ultimately secured in handcuffs and transported to the Story County Jail.

Charges: Assault with Injury on Peace Officer, Assault on Peace Officer, Criminal Mischief 2nd Degree, Interference with Official Acts

Demographics: 18-year-old white female

Incident 8: 23002043

Use of Force: Display of Pepper Spray

Date: May 31, 2023, at 14:28

Details: An officer made a routine traffic stop on a vehicle that failed to stop at a stop sign. The male juvenile was issued citations for stop sign violation and no valid license. Upon issuance of the citations, the male juvenile began cursing at the officer. At one point, the male aggressively walked at the officer at which time the officer pulled out his pepper spray and demanded the male stop and not come any closer. The juvenile complied and no further use of force was needed.

Charges: None

Demographics: 16-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
