June Training: Two officers are in the Field Training program. All officers attended precision driving training and body worn camera training. Three officers attended a shotgun and rifle armorer training. An officer attended a red dot instructor training. Two supervisors attended the Governor’s Traffic Safety Bureau Conference. An officer attended Psychological Trauma and Juvenile Justice conference. Three officers attended the Iowa Acts of Interest conference. An officer conducted chemical exposure training for new Community Safety Officers. The Emergency Response Team trained twice during the month.

June Outreach and Engagement: The Community Resource Officer attended the following: Iowa State Women’s Club Food Group, ChildServe presentation, Coffee with Cops, Eastwood neighborhood meeting, and Donuts in the Park. Four supervisors attended RABGRAI planning meetings. Officers assisted with the RABGRAI pre-route road ride and inspection. Two staff instructed suicide intervention training for community members. An officer conducted active shooter training at the Boys and Girls Club. An officer attended a National Donut Day event at Salvation Army. Three officers attended the Juneteenth celebration at Bandshell Park. An officer attended a DOT Safety event. An officer attended an Amateur Ham Radio event. Two officers attended a lemonade stand event at the Boys and Girls Club. Two officers attended All Aboard for Kids camp at the Ames Middle School. An officer assisted with his fourth baby delivery while on-duty.

USE OF FORCE DETAIL

Incident 1: 23002097

Use of Force: Display of firearm Date: June 5, 2023, at 08:38
 Details: During the execution of a search warrant, officers displayed their firearms as they made entry into the residence. No other force was used during the remainder of the investigation.

Charges: Ongoing investigation
 Demographics: 36-year-old white male

Incident 2: 23002112

Use of Force: Grabbed subject Date: June 6, 2023, at 00:15
 Details: Officers were dispatched to a local convenience store reference a theft of alcohol. When officers arrived, they located a female matching the description getting into a vehicle. The female was identified and found to have a barred driver’s license. Officers attempted to have the female step out of the vehicle, but she resisted. Officers grabbed her by the arm and assisted her in exiting the vehicle. The female was placed under arrest and continued to attempt to pull away from officers. The female also kicked the squad car door open as officers were attempting to secure her inside. The stolen merchandise was located inside the female’s vehicle.

Charges: Driving While Barred, Theft 5th Degree, Interference with Official Acts
 Demographics: 22-year-old white female

Incident 3: 23002164

Use of Force: Display of firearm

Date: June 10, 2023, at 04:47

Details: Officers responded to an area reference a reckless driver complaint. Officers located the vehicle occupied by three adult males. The driver had an open alcoholic beverage in his lap as did the front passenger. The driver was asked to step out of the vehicle to conduct standardized field sobriety tests. The two passengers were agitated and refused to identify themselves. The driver was found to be under the influence of alcohol and was subsequently arrested. As the officers were attempting to place handcuffs on the driver, the two passengers exited the vehicle and approached the officers in an aggressive manner. One officer drew his duty firearm and ordered the passengers to stay back and return to the vehicle. The passengers ultimately complied, and no other use of force was needed.

Charges: OWI 1st Offense

Demographics: 23-year-old white male

Incident 4: 23002238

Use of Force: Display of Taser, handcuffed subject

Date: June 16, 2023, at 06:22

Details: Officers were dispatched to a local residence for a disorderly male juvenile. The male broke the phone of another resident. During the investigation, the male retrieved a large knife from the kitchen and began walking toward the officer and other residents. The officer drew his Taser and instructed the male to place the knife on the counter to which the male complied. The officer ordered the male to the ground due to his unpredictable behavior and proceeded to place the male juvenile in handcuffs for his safety and the safety of others on scene. The male was transported to MGMC for a mental health evaluation.

Charges (Juvenile Referrals): Criminal Mischief 4th Degree, Disorderly Conduct

Demographics: 14-year-old white male

Incident 5: 23002244

Use of Force: Grabbed subject

Date: June 16, 2023, at 19:02

Details: Officers were dispatched to an apartment complex for disorderly conduct. Upon arrival, officers located the male suspect leaving the area on a bicycle. Officers stopped the male and advised him he was not free to leave. Officers made contact with individuals on scene at the apartment complex. Officers were made aware of a door that the suspect had kicked a large hole in. Officers then informed the detained male he was under arrest and attempted to place him in handcuffs. The man resisted the officers and tensed up. Officers had to grab the male by his arms and wrists in order to secure him in handcuffs.

Charges: Criminal Mischief 4th Degree

Demographics: 46-year-old white male

Incident 6: 23002288

Use of Force: Handcuffed subject, grabbed subject

Date: June 20, 2023, at 19:18

Details: Officers located a male juvenile who had an active arrest warrant. When officers attempted to place the male under arrest he began resisting. Officers struggled with the male and ultimately took him to the ground in order to secure him in handcuffs. Once in handcuffs, the male continued to resist officers and would not comply with commands. The male juvenile was ultimately secured in the back of a patrol car and transported to a nearby juvenile detention center per the court order.

Charges (Juvenile Referrals): Arrest warrant for other agency, Interference with Official Acts

Demographics: 17-year-old black male

Incident 7: 23002294

Use of Force: Grabbed subject

Date: June 21, 2023, at 11:02

Details: An officer located a wanted female. As the officer approached the female, she began to quickly walk away from the officer. The officer ordered the female to stop but she refused. When the officer caught up to the female, he grabbed her and instructed her to stop resisting. The officer was able to get the female secured in handcuffs and no other use of force was needed. The officer later located drugs and drug paraphernalia in the female's possession.

Charges: Arrest warrant, Interference with Official Acts, Drug/Narcotics Violation, Drug Equipment Violation

Demographics: 33-year-old white female

Incident 8: 23002305

Use of Force: Display of firearm

Date: June 21, 2023, at 21:13

Details: Officers were dispatched to a local residence for a home invasion where it was reported three black males kicked in the door to the apartment and were armed with firearms. Due to the nature of the call and the unknown location of the suspects, officers approached the residence where the robbery had occurred with their duty weapons drawn. No other use of force was needed.

Charges: Pending

Demographics: 3 black males

Incident 9: 23002320

Use of Force: Grabbed subject

Date: June 23, 2023, at 00:39

Details: Officers were dispatched to a disorderly male who was attempting to get into an UBER that was occupied by two females who were not associated with him. When officers arrived, the male suspect was holding onto the arm of another male near the UBER and would not let him go. Officers ordered the male suspect to let go of the other male, but he refused. Officers grabbed the male suspect's arm and again ordered him to let go of the other male. Eventually, the male suspect released his grip. The male suspect was escorted out of the street and over to the sidewalk where he tensed up and refused to comply with the officers. Officers placed the male up against the wall where they continued to struggle with the male until he was ultimately secured in handcuffs.

Charges: Public Intoxication, Interference with Official Acts

Demographics: 22-year-old white male

Incident 10: 23002323

Use of Force: Grabbed subject

Date: June 23, 2023, at 08:51

Details: Officers were dispatched to a local hotel where a female refused to leave. Upon arrival, officers located the female in the parking lot. Hotel staff requested the female be told to not return. Officers approached the female who continued walking away from them. When officers caught up to the female she turned around and swung at one of the officers. The officer blocked the punch and was able to grab the female's arm. The female was directed to the ground and secured in handcuffs.

Charges: Assault on a Peace Officer

Demographics: 58-year-old white female

Incident 11: 23002347

Use of Force: Display of firearm

Date: June 25, 2023, at 10:13

Details: Officers were assisting a local agency reference several car burglaries. Officers located a suspicious male at a local business near the scene of the car burglaries. When officers approached the male, he took off running from the store and away from officers. Officers pursued the individual in their squad cars. When the officers got close, the male appeared to be reaching for something. One of the officers drew his firearm and ordered the male to the ground. Once

the male showed his hands and the officer knew he was no longer a threat, the officer holstered his duty weapon and placed the male under arrest without further incident.

Charges: Interference with Official Acts, Unauthorized Use of Credit Card >\$1000 <\$10,000

Demographics: 29-year-old black male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
