



# AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT

## July 2023



### SUMMARY

**July Training:** One officer is in the Field Training program. Another officer successfully completed the Field Training program. All officers attended active intruder training. Two officers instructed Traffic Incident Management training for police employees and tow truck companies. A supervisor attended a tactical leadership training. An officer attended a drug investigation training. A supervisor attended training with the 71<sup>st</sup> Civil Support Team. The Emergency Response Team trained twice during the month.

**July Outreach and Engagement:** The Community Resource Officer attended the following: Coffee with Cops, Donuts in the Park, Iowa Games athlete tailgate event, City of Ames Summer Academy, and a workplace violence training for city employees. Three officers escorted the state runner up AHS baseball team to the city limits for the state baseball tournament. Two officers participated in the 4<sup>th</sup> of July parade on Main Street. Two officers completed child safety seat checks throughout the month. Sixteen officers worked at the downtown RAGBRAI concert and beer garden venue. Two officers assisted the Bridge Home with an outreach event. A supervisor assisted Furman Aquatics staff with a red shirt training drill. Two supervisors hosted a quarterly bar meeting for bar employees and managers.

### USE OF FORCE DETAIL

#### Incident 1: 23002438

Use of Force: Taser deployment Date: July 1, 2023, at 09:52

Details: A subject with numerous felony warrants was located by an officer who was on routine patrol. The wanted subject was known to have violent tendencies and be armed and dangerous. When the officer got out with the subject, the subject provided a false name and began acting in a manner that was concerning to the officer. The officer drew his taser and demanded the subject comply with orders. The subject refused to comply. As the subject turned from the officer, the officer deployed his taser and allowed the officer to gain control of the subject. The subject was arrested, and new charges were filed.

Charges: Possession of a Controlled Substance (3<sup>rd</sup> or subsequent), Possession of Drug Paraphernalia, Interference with Official Acts, Providing False Identification Information

Demographics: 24-year-old white male

#### Incident 2: 23002454

Use of Force: Taser deployment, Grabbed subject Date: July 2, 2023, at 18:17

Details: Officers were dispatched to a disorderly conduct call about a male and female physically fighting. Officers located the female in the area, but the male half was gone on arrival. The male was later located at a nearby motel. The male had multiple warrants and refused to comply with officers. The male began physically resisting officers. One officer deployed his taser in an attempt to gain control of the male. The taser was ineffective and the male fled the motel on foot with officers in pursuit. Another officer arrived on scene and took the male to the ground to stop him from running and assaulting officers. The male physically assaulted officers and spit in one officer's face. He was later transported to the hospital for evaluation before being cleared to go to the Story County Jail.

Charges: Interference with Official Acts-Assault, Assault on Persons in Special Occupation-Bodily Injury, Assault on Persons in Special Occupation, Criminal Mischief 5<sup>th</sup> Degree, Public Intoxication

Demographics: 40-year-old black male

**Incident 3: 23002461**

Use of Force: Grabbed subject

Date: July 3, 2023, at 11:34

Details: Officers were dispatched to a disorderly male breaking out several windows in a parking lot. An officer located the male and told him to get on the ground. The male initially complied. As the officer moved in to handcuff the male suspect, he turned on the officer and grabbed the grip of the officer's duty weapon which was secured in the holster. The male attempted to work his hand into the holster toward the trigger area. The officer was able to grab the male and turn him face down on the ground so he could be secured in handcuffs without further incident.

Charges: Disarming or Attempting to Disarm Police Officer, Criminal Mischief 5<sup>th</sup> Degree, Public Intoxication

Demographics: 22-year-old white male

**Incident 4: 23002543**

Use of Force: Grabbed subject, handcuffed subject

Date: July 10, 2023, at 13:28

Details: Officers were dispatched to a fight in progress at a local residence. Officers determined the male juvenile was the physical aggressor and needed to be taken into custody. The male juvenile picked up a rock and attempted to throw it, at which time the officer tried to restrain the male juvenile. The male juvenile turned on the officer and wrapped his arms completely around the officer. The officer and the male juvenile fell backwards into an outdoor grill. The male juvenile yelled for the officer to kill him while reaching for the officer's duty weapon. Another officer arrived and was able to get the juvenile male's hands secured in handcuffs. The juvenile male was later transported to detention.

Charges (Juvenile Referrals): Simple/Serious Domestic Assault, Disorderly Conduct by Abusive Epithets/Threat, Interference with Official Acts

Demographics: 14-year-old black male

**Incident 5: 23002565**

Use of Force: Grabbed subject

Date: July 12, 2023, at 15:25

Details: Officers were dispatched to a fight in progress at a local residence. Officers located an injured victim at the residence. The male suspect was found nearby walking from the scene. When officers attempted to speak with the male suspect, he took off running. After a short foot pursuit, the male stopped and squared up on the officer and got into a fighting stance. The officer grabbed the male and took him to the ground where he continued resisting until he was secured in handcuffs.

Charges: Assault Causing Bodily Injury, Criminal Mischief 4<sup>th</sup> Offense, Interference with Official Acts

Demographics: 34-year-old white male

**Incident 6: 23002654**

Use of Force: Handcuffed subject, grabbed subject

Date: July 18, 2023, at 17:58

Details: Officers were dispatched to a disorderly conduct call for service at a local medical facility. Upon arrival, officers learned the male subject assaulted one staff member. Another staff member was working to try to de-escalate the male. The male then took a swing at that staff member at which time the officer moved in to detain the male. The male was taken to the ground to prevent anyone from being injured. The male was secured in handcuffs and continued scratching the officer causing injury.

Charges: Assault on Persons in Certain Occupation (2 Counts), Interference with Official Acts-Bodily Injury

Demographics: 18-year-old white male

**Incident 7: 23002716**

Use of Force: Grabbed subject

Date: July 23, 2023, at 01:19

Details: Officers were dispatched to a disorderly conduct call at a local medical facility. Upon arrival, officers learned the female subject assaulted multiple staff members and was cleared to be taken into custody. Officers placed the female in handcuffs and escorted her outside to the patrol car. The female refused to sit in the patrol car, so officers had to apply pressure to her shoulders and back in order to get her into a seated position.

Charges: Assault on Persons in Certain Occupations-Bodily Injury (2 Counts)

Demographics: 23-year-old unknown female

**Incident 8: 23002717**

Use of Force: Taser deployment, Grabbed subject

Date: July 23, 2023, at 03:12

Details: Officers were dispatched to a local residence for a disorderly conduct call for service. The reporting party advised the male was intoxicated and got upset while playing video games. The male grabbed his infant from the baby swing and refused to give the infant to the mother. Officers arrived on scene and the male was still holding the infant and was acting aggressively. After some time, the male handed the infant over to the mother before fleeing on foot. After a short foot pursuit, the male asked officers to shoot him. The male was ordered to get on the ground, but he refused. One officer deployed his taser, but it was not effective. Officers grabbed the male and took him to the ground where he was placed in handcuffs.

Charges: Child Endangerment-Minor Injury, Public Intoxication, Interference with Official Acts

Demographics: 34-year-old white male

**Incident 9: 23002723**

Use of Force: Grabbed subject

Date: July 23, 2023, at 15:15

Details: Officers were initially dispatched to a civil matter. The reporting party stated the other involved party left in his truck and was possibly intoxicated. The male suspect also called into dispatch requesting to speak with an officer. Officers located him at his residence, and he was confrontational. The male had a driving status of revoked, so officers placed him under arrest. The male pulled away from officers and attempted to escape custody, but officers were able to get him successfully into the back of the patrol car without further incident.

Charges: Driving While Revoked, Interference with Official Acts

Demographics: 32-year-old white male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
