# AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT August 2023



#### **SUMMARY**

**August Training**: An officer successfully completed the Field Training program. All officers attended crowd management training. An officer attended baton instructor training. An officer attended a tactical officer conference. A supervisor attended command and control training. An officer provided chemical aerosol training to community safety officers. The Emergency Response Team trained twice during the month. An officer provided pat down search training to community safety officers. An officer attended suicide intervention training.

August Outreach and Engagement: The Community Resource Officer attended the following: Ames Community Academy, ACCESS Cake for Breakfast event, two police department tours and Texas Roadhouse Special Olympics fundraiser. Four officers assisted with Good Neighbor outreach prior to Cyclone Welcome Weekend. Two officers attended WelcomeFest at the Memorial Union. A supervisor attended a parent advisory meeting at the Boys and Girls Club. Police staff attended National Night Out and handed out over 800 backpacks. A supervisor attended Rummage Rampage. A supervisor conducted an on-site I.D. training at a local bar. An officer conducted resiliency training with a partner agency. Two supervisors and an officer attended National Overdose Awareness Day at Bandshell Park. An officer gave a presentation to 200 fraternity members. Two officers conducted an I.D. training for bar staff. An officer provided firearms training to law enforcement academy students.

## USE OF FORCE DETAIL Incident 1: 23002848

Use of Force: Display of firearm, Display of pepper spray

Details: Officers were dispatched to a theft of a motor vehicle. Officers located the stolen vehicle and the suspect a short time later. Officers ordered the male suspect to stop but he fled on foot from officers into a local hotel. Once inside the hotel, the suspect entered a room where a female was cleaning. The suspect held the female inside the room and would not allow her to leave. The suspect later exited that room without any injury to the staff member. The male suspect approached officers and one officer drew his duty weapon and pointed it at the male and ordered the male to the ground. The suspect did not comply and continued walking toward officers. Another officer arrived to assist. The officer holstered his duty weapon and displayed his pepper spray and again ordered the suspect to get on the ground. The suspect ultimately complied and was placed into custody. He was in possession of burglar tools and marijuana.

Charges: False Imprisonment, Theft 1st Degree-Motor Vehicle Theft, Possession of a Controlled Substance, Interference

with Official Acts, Possession of Burglary Tools

Demographics: 33-year-old white male

Incident 2: 23002899

Use of Force: Display of taser, Grabbed subject

Details: An officer was on routine patrol when they noticed a physical fight at a local apartment complex. The officer attempted to break up the fight, but none of the participants in the altercation would comply. The officer grabbed a juvenile female who was punching another individual. At one point, an unknown male subject pushed the officer,

causing the officer to release the female juvenile. The officer displayed his Taser and ordered the male to back away from him. The officer attempted to locate the juvenile female but was unable to. Another fight broke out in the parking lot and the officer was able to secure the male suspect in handcuffs. Other officers arrived and assisted them in securing an adult female. The juvenile female suspect was later issued a juvenile referral for disorderly conduct.

Charges: Disorderly Conduct

Demographics: 22-year-old black female, 34-year-old black male, 14-year-old black female

#### Incident 3: 23002908

Use of Force: Grabbed subject

Date: August 5, 2023, at 20:03 Details: Officers were dispatched to a local apartment complex for a male in the hallway with no pants and an unbuttoned shirt. Officers contacted the male suspect who was clothed when officers arrived. The male was found to be intoxicated. Officers attempted to place the male into custody, but he hit one of the officers in the forehead prior to being secured in handcuffs. Once in handcuffs, the male refused to walk to the patrol car. Officers carried the male suspect to the patrol car.

Charges: Assault on a Peace Officer, Public Intoxication

Demographics: 74-year-old white male

#### Incident 4: 23002910

Use of Force: Grabbed subject Date: August 5, 2023, at 23:33

Details: Officers were dispatched to a disorderly conduct at a local residence. Upon arrival, officers located a male and a female. Upon a routine check of the male subject's information, they found he was named as the defendant in a No Contact Order and listed the female as the protected party. As officers attempted to place the male into custody, he pulled away from officers. Officers forced his arms behind his back to secure him in handcuffs.

Charges: Contempt of Court-Violation of No Contact or Protective Order

Demographics: 38-year-old black male

#### Incident 5: 23003015

Use of Force: Grabbed subject

Date: August 14, 2023, at 02:02 Details: Officers were dispatched to a theft of a bicycle. Officers located the male suspect on the stolen bicycle approximately ten minutes after the theft report was taken. Officers found the male to be intoxicated. The male began to physically resist officers upon arrest. Officers held the male against the patrol car to search him without anyone being injured.

Charges: Theft 5<sup>th</sup> Degree, Public Intoxication, Bicycles: Lamps, Reflectors Required

Demographics: 39-year-old white male

#### Incident 6: 23003063

Use of Force: Display of firearm

Date: August 17, 2023, at 01:31

Details: An officer was on routine patrol when they observed a vehicle traveling at a high rate of speed on the wrong side of a two-way highway. The officer initiated a traffic stop. The driver pulled into a local business and exited his vehicle. The male suspect approached the officer in an aggressive manner. The officer displayed his firearm and ordered the male to stop. The male complied and no further use of force was needed.

Charges: Excessive Speed, Driving on Wrong Side of Two-Way Highway

Demographics: 46-year-old white male

#### Incident 7: 23003093

Use of Force: Grabbed subject Date: August 18, 2023, at 18:45

Details: Officers were dispatched to a local business regarding a trespass. Officers located the male suspect inside the business and verified there was a valid no trespass notice on the male. When officers attempted to arrest the male, he began to physically resist. Officers took the male to the ground to secure him in handcuffs. Officers located controlled substances on the male.

Charges: Drug Possession of Controlled Substance, Criminal Trespass, Interference with Official Acts

Demographics: 53-year-old white male

#### Incident 8: 23003098

Use of Force: Grabbed subject

Details: During routine patrol, officers located an intoxicated male being helped to his feet by some of his friends. The male then stumbled away from his friends. When officers stopped the male, he was urinating in a driveway. The male then tried to walk away from officers. The male was instructed to stop but he continued walking away. Officers attempted to place the male against a nearby wall to prevent him from leaving but the male fell to the ground. Officers later secured the male in handcuffs and transported him to the police department. Once there, officers requested an alcohol evaluation from paramedics. Due to the male's level of intoxication, he was taken by ambulance to a medical facility for evaluation. Upon release, the male was taken to the Story County Jail.

Charges: Public Intoxication, Unlawful Use of License

Demographics: 20-year-old white male

#### Incident 9: 23003128

Use of Force: Grabbed subject Date: August 19, 2023, at 21:11

Details: Officers were dispatched to a fight in progress at a local apartment complex. Officers located the male suspect being held down by citizens. The suspect had already bitten two individuals. Officers moved in to secure the male in handcuffs. During the arrest, one officer sustained a minor injury to his hand. The male continued resisting officers and kicked another officer in the head. Due to the male's level of intoxication, paramedics were called in to assist. The male was transported to a medical facility for treatment and was later was taken to the Story County Jail following his release from the hospital.

Charges: Disorderly Conduct, Interference with Official Acts, Assault on Peace Officer

Demographics: 18-year-old white male

#### Incident 10: 23003172

Use of Force: Grabbed subject Date: August 21, 2023, at 19:01

Details: Officers were dispatched to a local medical facility to assist with a court-ordered patient. The patient had left the facility on foot but had a valid committal order. Officers and paramedics attempted to get the female into the patrol car willingly but were unsuccessful. Officers grabbed the female and assisted her into the patrol car to be transported back to the medical facility. No injuries were reported, and no criminal charges were filed.

Charges: No charges

Demographics: 15-year-old white female

#### Incident 11: 23003233

Use of Force: Grabbed subject Date: August 25, 2023, at 23:57

Details: Officers were dispatched to a local residence for a report of a disturbance and nuisance party. Upon arrival, officers located a male urinating in the backyard of the residence. The male asked officers if he could finish using the restroom before he spoke with them. After the male finished urinating, he took off running from officers. Officers caught

him a short distance away as he was trying to climb a fence. The officers took ahold of the male and took him to the ground and placed him in handcuffs. No other use of force was needed.

Charges: Public Intoxication, Interference with Official Acts, Urination in Public

Demographics: 19-year-old white male

#### Incident 12: 23003286

Use of Force: Grabbed subject Date: August 29, 2023, at 01:55

Details: Officers were dispatched to a local apartment building and found a male unconscious on the floor of the elevator with an open bottle of alcohol in his hand. Officers woke the male, and he became uncooperative. The male attempted to pull away from officers and spit at officers. Officers pushed the male against the patrol car and held his head away from them to avoid being spit on. Officers were able to get the male into the patrol car without further incident.

Charges: Public Intoxication, Interference with Official Acts, Public Consumption

Demographics: 33-year-old black male

#### Incident 13: 23003302

Use of Force: Grabbed subject Date: August 30, 2023, at 02:50

Details: Officers were dispatched to a local apartment complex for a disorderly conduct complaint. Officers located a wanted subject who retreated to a back bedroom of one of the apartments and barricaded the door with a one-year-old inside the room. Officers later contacted the male and placed him under arrest. The male began pushing and pulling against officers. Officers took him down onto the bed to gain control of the male. The male had to be carried to the patrol car for his and the officers' safety.

Charges: Child Endangerment, Interference with Official Acts, Arrest Warrant-Other Agency Demographics: 29-year-old black male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
