USE OF FORCE DETAIL

Incident 1: 23003859

Use of Force: Grabbed subject

Date: October 5, 2023, at 05:31

Details: Officers were dispatched to a local apartment for an intoxicated male who was arguing with the residents and refusing to leave. Officers attempted to place the male in handcuffs, but he began pulling away. Officers pushed the intoxicated male onto a bed to gain control of him and secure him in handcuffs.

Charges: Public Intoxication

Demographics: 30-year-old black male

Incident 2: 23003887

Use of Force: Grabbed subject

Date: October 7, 2023, at 00:58

Details: An officer was on routine patrol when he observed a male urinating on a local business. The officer parked his patrol vehicle and approached the man who took off running. The officer chased the male, but the officer tripped and fell to the ground causing injury to his hands, knees and wrist. As the officer was getting back up, he observed the male suspect had fallen down a short distance away. The officer ran to where the male suspect was and pinned the male suspect to the ground. The officer was ultimately able to secure the male in handcuffs without further incident.

Charges: Interference with Official Acts Causing Bodily Injury, Public Intoxication, Urination in Public
Demographics: 20-year-old white male

Incident 3: 23004018

Use of Force: Display of firearm, Grabbed subject

Date: October 16, 2023, at 11:28

Details: An officer was on routine patrol when he observed a vehicle traveling at a high rate of speed in a residential neighborhood. The officer parked his patrol vehicle and used the LIDAR and found the vehicle to be traveling well over the posted speed limit. The officer conducted a traffic stop. The driver of the vehicle admitted he did not have a driver's license but provided his name. The officer recognized the name and knew the male was a known gang member and was also known to carry a gun. The male began reaching for the small of his back, so the officer drew his firearm and ordered the male to show his hands. When backup arrived, the male driver was secured in handcuffs. The male was found to have a warrant and was taken to the Story County courthouse to appear before a judge. He was cited and released for driving under suspension and excessive speed. Officers gave the female passenger commands to exit the vehicle and she refused. Officers had to grab the female and escort her out of the vehicle. She was issued a juvenile referral for interference with official acts.

Charges (Juvenile Referrals): Interference with Official Acts, Driving Under Suspension, Excessive Speed, Warrant Arrest
Demographics: 17-year-old black male, 17-year-old black female

Incident 4: 23004123

Use of Force: Display of firearm

Date: October 23, 2023, at 14:29

Details: An officer was running LIDAR when he observed a vehicle traveling at a high rate of speed in a residential neighborhood. The officer found the vehicle to be traveling well over the posted speed limit. The officer attempted to conduct a traffic stop but the vehicle did not stop. The vehicle continued but was obeying traffic laws. The officer called for assistance and when the suspect vehicle stopped at a red light two officers boxed the suspect vehicle in. The initiating officer then exited his vehicle with his weapon drawn and gave verbal commands to the driver to show his hands. The officer ultimately realized the driver was unable to understand his commands due to a language barrier. The driver exited his vehicle and showed his hands at which time the officer holstered his duty firearm and continued his investigation without any additional use of force.

Charges: Excessive Speed, Failure to Have Valid License or Permit
Demographics: 29-year-old white male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

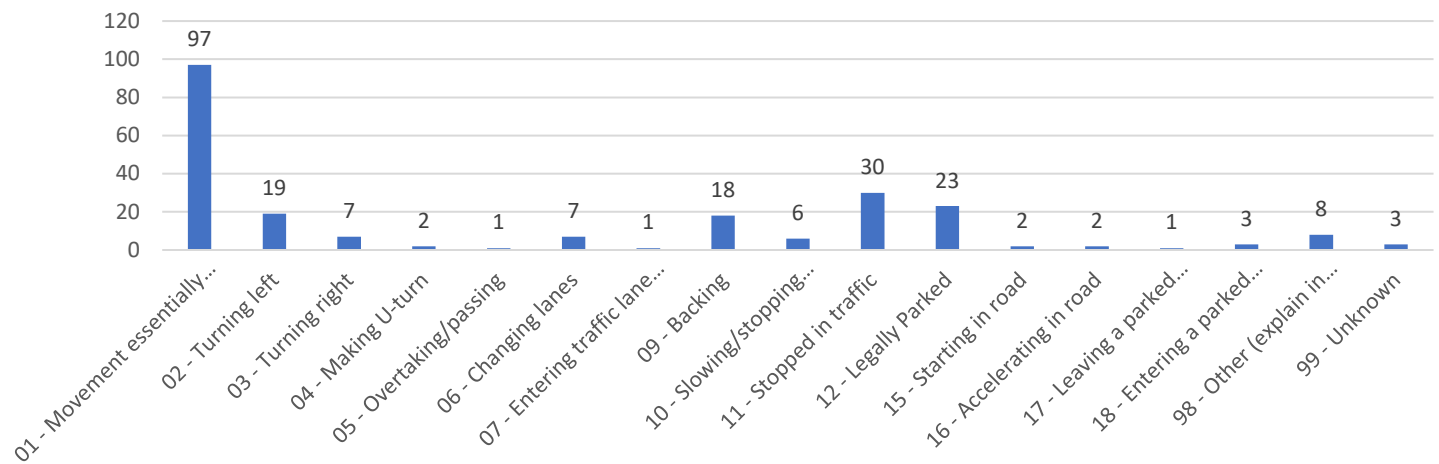




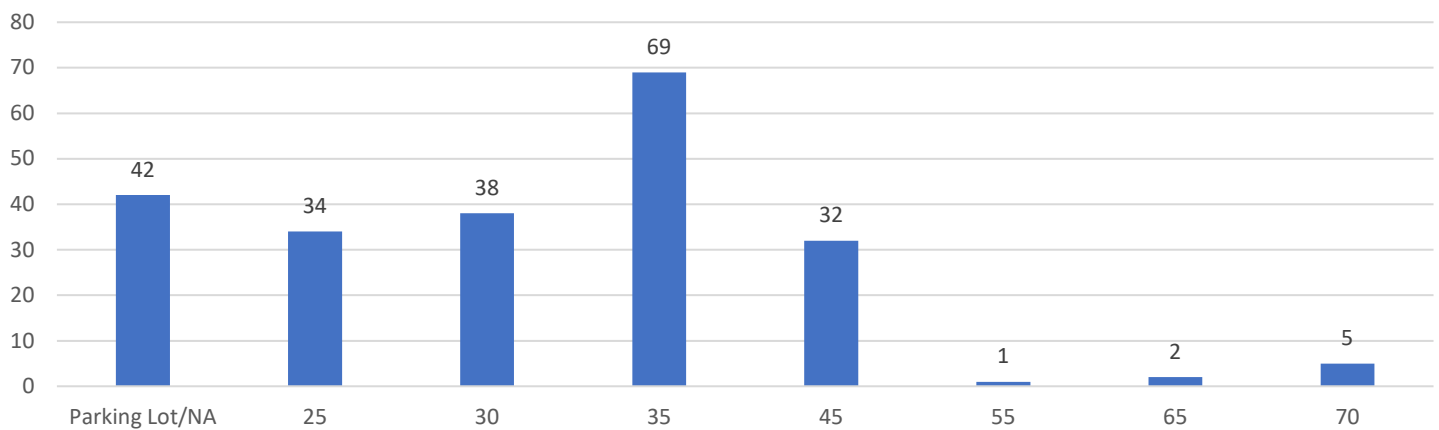
Driver Injuries



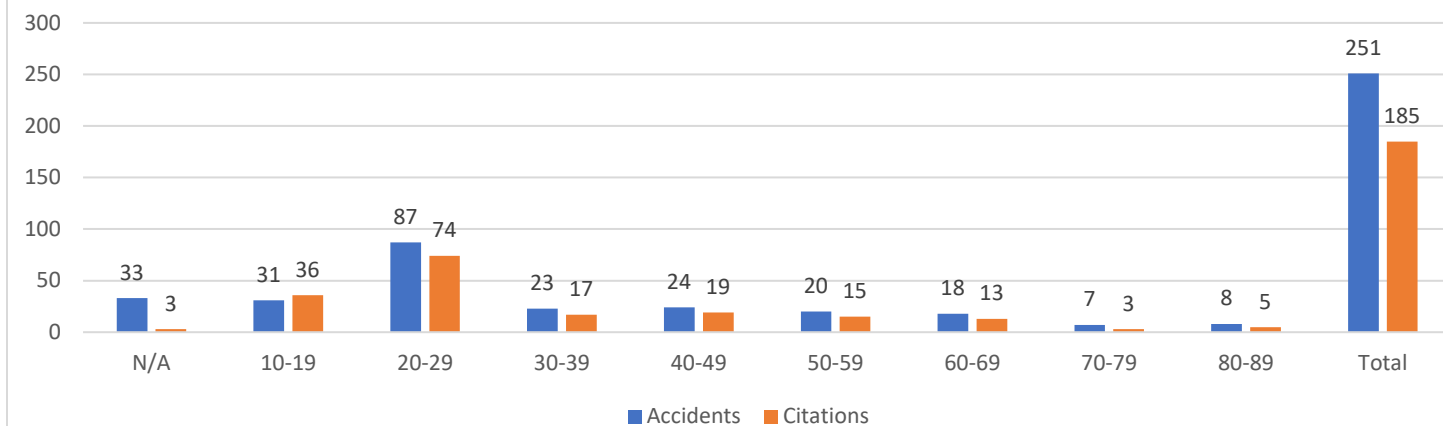
Vehicle Action

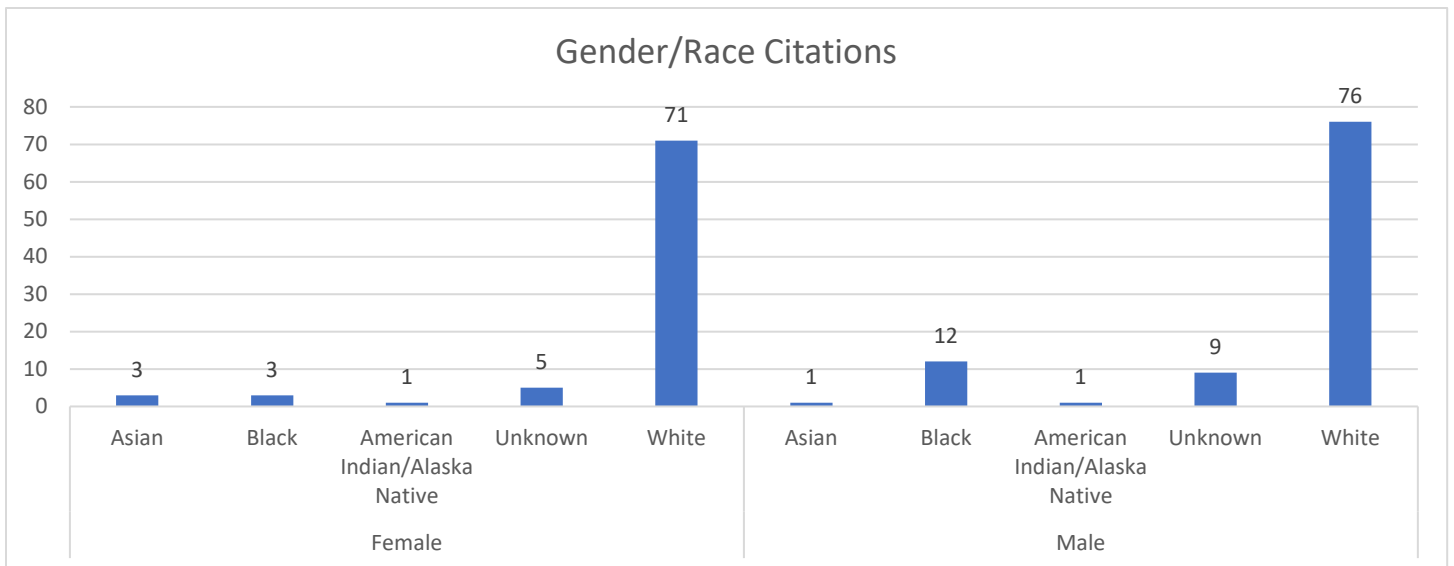
