

REQUIREMENTS FOR A DEMOLITION PERMIT

Steps to prepare for demolition:

1. Obtain a Demolition Permit Application from the Inspection Division (attached).
2. Verify compliance with asbestos removal regulations for the Iowa Department of Natural Resources. Contact the DNR Air Quality Bureau:

3. Contact each utility company that has services provided on the property and request disconnection/abandonment. Please indicate which services are present and return the contact information sheet (attached) with the demolition permit application.
4. Obtain the necessary excavation permit from Public Works for work in the right of way and plumbing permit from the Inspection Division for the water and sewer abandonment. The water and sewer services must be abandoned at the proper locations, if applicable.
5. If the project is in the Historic Preservation Overlay District, contact the Department of Planning and Housing to obtain a Certificate of Appropriateness: 515-239-5400.
6. Call Iowa One Call 48 hours before you dig 1-800-292-8989.
7. Trucks hauling debris from the demolition site shall be covered to prevent loss of materials.

DEMOLITION SHALL NOT BEGIN PRIOR TO THE ISSUANCE OF A DEMOLITION PERMIT

A Demolition Permit cannot be issued until:

1. A Demolition Permit Application has been submitted to the Inspection Division.
2. A representative of each utility has notified the City of Ames certifying that the disconnection or service abandonment has been completed, if applicable, and the Sign-Off has been submitted to the Inspection Division.
3. A Certificate of Appropriateness has been obtained (if the demolition project is in the Historic Preservation Overlay District).
