### SUMMARY

**March Training:** All officers completed bloodborne pathogen, hazardous material, and defensive tactics training. One lieutenant and one officer attended Risk Management training, and two sergeants attended an employee law class. One sergeant attended Leadership Fundamental training and several officers attended wellness and resiliency training. One officer assisted the Iowa Law Enforcement Academy, and another officer attended an evidence-based interview course. One officer attended trauma informed sexual assault response and two officers attended the city’s communication and customer service class. One officer attended the Iowa Association of Women’s Police Conference.

**March Outreach and Engagement:** Tobacco compliance checks were completed throughout the city. Officers completed three car seat checks and attended multiple career fairs. One officer presented on alcohol and risk mitigation for a new member symposium for fraternities on campus. The day shift lieutenant presented at the Story County ID Program. Officers conducted ALICE training for ACPC.

### USE OF FORCE DETAIL

#### Incident 1: 24000791

**Use of Force: Display of firearm**

**Date: March 1, 2024, at 14:32**

Details: Officers executed a search warrant at a local residence. Officers had their duty weapons drawn when they secured the residence. No other use of force was needed during the remainder of the investigation.

Charges: Ongoing investigation

Demographics: 24-year-old white male and 24-year-old black male

#### Incident 2: 24000799

**Use of Force: Grabbed subject**

**Date: March 1, 2024, at 19:57**

Details: Officers were dispatched to a suspicious male who was on a skateboard in the middle of the road waving down cars asking for a ride. As officers arrived in the area, they located the male who was tampering with the front door of a local residence which did not belong to the male. Officers contacted the male and found him to be intoxicated. The male was placed under arrest for public intoxication. During the search of the male’s property, officers located a bottle of alcohol in his possession. Officers placed the male in the back of the patrol vehicle, but the male attempted to stand up and he became noncompliant, so officers had to grab him and assist him back into the patrol car.

Charges: Public Intoxication, Possession of Alcohol Under the Legal Age

Demographics: 18-year-old white male

#### Incident 3: 24000805

**Use of Force: Grabbed subject**

**Date: March 2, 2024, at 21:50**

Details: Officers were dispatched to a local hotel regarding a male who was actively fighting with family members. Dispatch informed responding officers that the male had been drinking all day and was likely intoxicated. Officers arrived on scene and spoke with family members as well as hotel staff. Staff wanted our assistance in removing the male from

their property. Officers went with family members up to the room where the male was. When the door opened, officers found the mother and sister holding the male down on the ground. Officers moved in and secured the male in handcuffs. The male attempted to spit on officers so one officer had to control the male's head to prevent him from spitting on officers.

Charges: Disorderly Conduct by Loud and Raucous Noise

Demographics: 24-year-old black male

**Incident 4: 24000819**

**Use of Force: Display of taser, Grabbed subject**

**Date: March 4, 2024, at 04:20**

Details: Officers were dispatched to a local address on a report of suspicious activity. Officers located a male outside the address who was hallucinating and threatening to kill everyone inside. An officer displayed their taser and ordered the male to the ground. The male complied and was handcuffed and placed in the back of a patrol car. The male was transported to a local hospital for a mental health evaluation. The male continued being hostile and non-compliant with officers and medical staff so officers physically restrained the male until medical staff could safely perform their necessary duties.

Charges: No charges

Demographics: 49-year-old white male

**Incident 5: 24000829**

**Use of Force: Grabbed subject**

**Date: March 5, 2024, at 12:03**

Details: Officers were dispatched to a local school reference an out-of-control juvenile. Upon arrival, officers located two staff members attempting to hold a juvenile down on the ground. Officers assisted staff by helping control the juvenile and prevent him from thrashing around which could cause injury to himself or others. Once the juvenile was calm, no further assistance was needed.

Charges (Juvenile Referrals): Disorderly Conduct by Loud and Raucous Noise

Demographics: 11-year-old black male

**Incident 6: 24000845**

**Use of Force: Display of handgun**

**Date: March 6, 2024, at 13:13**

Details: Officers executed a search warrant at a local apartment. Officers had their duty weapons drawn when they secured the residence. No other use of force was needed during the remainder of the investigation.

Charges: Ongoing investigation

Demographics: 22-year-old black male

**Incident 7: 24000881**

**Use of Force: Grabbed subject**

**Date: March 9, 2024, at 15:24**

Details: Officers were dispatched to a local business to take a report of a burglary to a motor vehicle. Officers were advised that a male subject had entered an unlocked car while parked on the roadway and removed items from the owner's purse. The male had a protection order with the female who owned the purse. Officers searched the area and were unable to locate the male. Officers were later dispatched to the female's residence as the same male had entered her apartment. The male fled out the back door prior to officer arrival and was located a short distance away. The male refused to stop for officers. Officers grabbed the male and secured him in handcuffs. Once at the PD, the male became combative and was kicking officers and threatening to spit on them and bite them. Officers took the male to the ground to prohibit him from injuring himself or the officers. Officers were kicked by the male as they loaded him into the squad car for transport to the jail.

Charges: Burglary 3<sup>rd</sup> Degree-Theft from Motor Vehicle, Contempt-Violation of No Contact Order, Interference with Official Acts, Interference with Official Acts Causing Bodily Injury

Demographics: 30-year-old black male

**Incident 8: 24000885**

**Use of Force: Grabbed subject**

**Date: March 9, 2024, at 21:00**

Details: Officers were dispatched to a local residence for a report of a male trying to break in. Officers located the male and found him to be intoxicated. The male attempted to enter the residence while officers were present. Officers grabbed the male to prevent him from entering a location he had no legal authority to occupy. The male was placed under arrest. The male became uncooperative during the search of his person and officers had to physically move one of the male's legs to finish searching him prior to transport to the jail.

Charges: Public Intoxication

Demographics: 32-year-old white male

**Incident 9: 24000924**

**Use of Force: Grabbed subject, Taser deployment**

**Date: March 15, 2024, at 14:48**

Details: Officers were dispatched to a local residence for a civil standby. Officers were informed that the male had an active mental health pickup order. Officers contacted the male and informed him of the order. After several minutes of speaking with the male, the male became more agitated and refused to comply with their commands. Officers grabbed the male by his arm but were not in a good position to secure him in handcuffs. The male pulled away and continued speaking with officers. While officers on scene waited for additional units to arrive, the male continued to be non-compliant. Another officer arrived and tried to reason with the male. The male reached into his back pocket and retrieved a knife. One officer deployed a taser striking the male in the abdomen. The taser was effective and officers were able to gain control of the male and secure him in handcuffs without anyone being injured. The male was ultimately transported to a local hospital to satisfy the pickup order.

Charges: Interference with Official Acts

Demographics: 31-year-old white male

**Incident 10: 24001018**

**Use of Force: Display of firearm**

**Date: March 22, 2024, at 10:26**

Details: Officers executed a search warrant at a local apartment. Officers had their duty weapons drawn when they secured the residence. No other use of force was needed during the remainder of the investigation.

Charges: Felon in Possession of a Firearm, Drug Stamp Criminal Penalties, Warrants-Other Agency

Demographics: 27-year-old black male, 26-year-old white male, 27-year-old black male, 26-year-old black male

**Incident 11: 24001043**

**Use of Force: Display of firearm**

**Date: March 24, 2024, at 00:36**

Details: Officers were dispatched to a report of a reckless driver. Another agency located the vehicle at a fast-food establishment in town and attempted to speak to the driver. The driver sped away from law enforcement and a pursuit ensued. Officers assisted in the pursuit. The vehicle fled the city and ultimately became disabled in a farm field. As officers approached the driver, they had their duty weapons drawn. The driver was taken from his vehicle and placed under arrest by the other agency involved. Local traffic related charges were filed as the male struck a light pole and knocked it down while inside city limits.

Charges: Leaving the Scene of a Traffic Accident-Vehicle Damage Only, Striking Fixtures Upon a Highway

Demographics: 50-year-old white male

**Incident 12: 24001099**

**Use of Force: Grabbed subject, Display of pepper spray****Date: March 28, 2024, at 20:34**

Details: Officers conducted a routine traffic stop on a vehicle. The vehicle smelled of marijuana. The passenger exited the vehicle and refused to identify himself to officers. Officers grabbed the male and told him to place his hands behind his back, but he refused. Officers struggled with the male and attempted to take him to the ground to gain control of him. One officer displayed pepper spray, but the male tried to grab it and the officers were not able to effectively deploy the spray without contaminating the officers as well. The male continued fighting with officers until they finally got the male to the ground and secured in handcuffs. During the altercation, one of the officers sustained minor injuries to their legs and arms.

Charges: Interference with Official Acts Causing Bodily Injury, Harassment of Public Official or Employee

Demographics: 28-year-old black male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
