May Training: All officers attended department firearms training. One officer attended highway drug investigations for patrol officers. A sergeant attended active shooter incident management. One officer attended highway drug investigations. Two officers started their four-month field training program. Several police leaders attended the city’s leadership fundamentals training. One officer attended high risk event planning and another officer attended arson investigation school.

May Outreach and Engagement: Officers assisted with the Mayor’s Bike Ride event. Officers attended breakfast and read books at Kate Mitchell School. Another officer attended elementary field day at Ames elementary schools. One officer presented on de-escalation. Several officers attended Coffee with a Cop. Officers completed a site walk with Mary Greeley Medical Center staff and met with staff and clients at Mainstream Living. Officers participated in the Special Olympics Torch Run and opening ceremonies. Officers gave squad car tours at Brookside Park. Officers presented on workplace violence to ChildServe staff and attended raising readers at North Grand Mall. Afternoon officers attended a bike rodeo and spoke with kids about bicycle safety.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Grabbed subject

Date: May 9, 2024, at 17:46

Details: Officers were dispatched to business for a disorderly male who was harassing employees and threatening to kill bystanders in the parking lot. Officers located the disorderly male and placed him under arrest. The male began kicking officers and threatening to kill them. Officers pinned the male against their squad car to prevent him from injuring officers or himself. The male continued to be combative, so officers picked the male up and placed him in the back of their patrol car and transported him to jail.

Charges: Harassment 1st Degree, Disorderly Conduct, Interference with Official Acts
 Demographics: 30-year-old white male

Incident 2:

Use of Force: Grabbed subject

Date: May 12, 2024, at 02:22

Details: Officers were dispatched to a suspicious vehicle that was parked by the railroad tracks with a group of females running around the outside of the car. Officers located the vehicle stopped in traffic with its hazards on and a group of individuals outside the vehicle. Officers contacted the individuals. One female was found to be highly intoxicated and began urinating on the curb while officers were trying to speak with her. The female was placed under arrest. At the PD, the female attempted to lick one of the paramedics who was assisting her and tried to bite one of the officers. The female refused to get into the back of the patrol car and officers had to grab her and assist her into the vehicle.

Charges: Public Intoxication, Urination in Public, Interference with Official Acts
 Demographics: 22-year-old black female

Incident 3:**Use of Force: Display of firearm****Date: May 12, 2024, at 18:31**

Details: Officers were dispatched to a local residence for a report of a domestic situation. On scene, officers were met by the female victim who had visible injuries to her face and head. Officers were informed the male suspect had struck the victim with a gun and had threatened to kill the victim. The male kept the female inside the residence for a few days so that no one would see her injuries. The male was still inside the residence at the time of the call. Officers deployed their patrol rifles and shields and called the male on the phone. The male agreed to come out of the residence. Officers secured the male in handcuffs without incident. No other use of force was used.

Charges: False Imprisonment, Domestic Assault with Weapon, Drug Possession of Controlled Substance, Possession of Drug Paraphernalia

Demographics: 28-year-old white male

Incident 4:**Use of Force: Grabbed subject****Date: May 14, 2024, at 14:04**

Details: Officers contacted a male near a business who had an active mental health pickup order. Officers were familiar with the male and attempted to get him to go willingly to the hospital. The male became verbally aggressive and looked as if he was going to run from officers. Officers grabbed the male and secured him in handcuffs to prevent him from fleeing. The male was transported to a local hospital and no charges were filed.

Charges: No charges

Demographics: 49-year-old white male

Incident 5:**Use of Force: Grabbed subject, Display of firearm****Date: May 16, 2024, at 16:49**

Details: Officers were assisting an outside agency in locating a male who had felony warrants for his arrest. Officers knew the male was known to be armed and dangerous. The male was located at a business and left from the area on a bicycle. Officers pursued the male who later discarded the bicycle and took off running from the area. Officers tackled the male to prevent him from escaping. Multiple officers deployed their duty weapons during this investigation for their safety and the safety of the public.

Charges: Felon in Possession of a Firearm, Interference with Official Acts in Possession of a Firearm, Arrest Warrant-Other Agency

Demographics: 18-year-old black male

Incident 6:**Use of Force: Display of firearm****Date: May 17, 2024, at 23:26**

Details: Officers were dispatched to a residence for a report of a male holding a gun to a female's head. Officers arrived on scene and found a male standing outside with a female. Officers drew their duty weapons and gave the male verbal commands, and he did not comply. The female was behind the male, so officers instructed her to go back inside the residence and she complied. Officers continued working with the male and were eventually able to secure him in handcuffs without incident. The female was found to be the protected party in a no contact order with the male.

Charges: Domestic Assault-2nd Offense, Harassment 1st Degree, Interference with Official Acts, Contempt-Violation of No Contact Order

Demographics: 45-year-old white male

Incident 7:**Use of Force: Grabbed subject****Date: May 18, 2024, at 20:50**

Details: Officers were dispatched to an apartment for a disorderly conduct call. Officers located an intoxicated male who was placed under arrest. The male began spitting at officers and attempting to kick them. Officers had to place the male

against the squad car to avoid being spit on and kicked. When officers went to place the male in the back of the squad car he spit on officers and kicked one officer in the chest.

Charges: Interference with Official Acts-Bodily Injury, Public Intoxication

Demographics: 34-year-old white male

Incident 8:

Use of Force: Display of pepper spray

Date: May 19, 2024, at 16:39

Details: Officers were dispatched to an apartment complex for a report of disorderly conduct. Officers were advised that a male had pulled the fire alarm inside the complex and then went outside and jumped on a vehicle and was smashing out the windows. Officers arrived on scene and located the male by the damaged vehicle. Officers displayed their pepper spray and gave the male verbal commands, and he complied. No other use of force was needed. While escorting the male to the patrol car, he admitted to officers that he beat a man with his hands. Officers located an injured man nearby who indicated the male jumped him and began beating him.

Charges: Criminal Mischief 4th Degree and Assault Causing Bodily Injury

Demographics: 22-year-old white male

Incident 9:

Use of Force: Display of firearm

Date: May 25, 2024, at 00:20

Details: Officers were dispatched to an apartment for a disorderly conduct call for service. Officers arrived on scene and heard a single gunshot and saw individuals running from the area. Officers located a couple of individuals who had injuries to their faces that were consistent with being involved in a physical altercation. These individuals advised they were assaulted by the same male who fired a gunshot. Officers drew their duty weapons and approached the vehicle the male was said to have gotten into. The male complied with commands and no other use of force was needed.

Charges: Public Intoxication, Disorderly Conduct-Loud Raucous Noise

Demographics: 22-year-old black male

Incident 10:

Use of Force: Grabbed subject

Date: May 25, 2024, at 22:48

Details: Officers were dispatched to an apartment for a hangup 911 call where dispatch could hear a male and female arguing. Officers arrived on scene and spoke with several individuals. The male was ultimately placed under arrest. The male resisted walking to the patrol car so officers had to grab him and escort him to the vehicle. The male eventually complied and sat in the backseat without incident.

Charges: Domestic Assault, Child Endangerment

Demographics: 21-year-old black male

Incident 11:

Use of Force: Grabbed subject

Date: May 28, 2024, at 05:08

Details: Officers were dispatched to a convenience store reference a male threatening an employee. Officers arrived on scene and located the employee and a male who was disorderly and cursing at the employee. The employee had been assaulted by the male. The male was found to be intoxicated. Officers attempted to place the male in handcuffs, but he resisted. Officers pushed the male against a nearby wall to gain control of him and prevent him from injuring himself or others. Officers ultimately secured the male in handcuffs without further incident.

Charges: Assault-Simple, Public Intoxication, Interference with Official Acts

Demographics: 21-year-old black male

Incident 12:**Use of Force: Display of firearm****Date: May 28, 2024, at 11:27**

Details: Officers were dispatched to a convenience store for a report of theft. The suspect had fled the scene into another business. Officers saw the suspect leave the other business and attempted to get him to stop. The male refused and began running from officers. Officers pursued the male in their patrol vehicles. After the male exhausted himself, officers exited their vehicles and gave verbal commands. The male then reached toward his front pocket, so officers drew their duty weapons and ordered the male to the ground, and he complied. No other use of force was needed.

Charges: Theft 5th Degree, Interference with Official Acts

Demographics: 21-year-old white male

Incident 13:**Use of Force: Grabbed subject****Date: May 28, 2024, at 22:16**

Details: During a traffic stop, a female passenger was found to have a warrant for her arrest. Officers asked the female to step out of the vehicle, and she complied. Officers attempted to place the female in handcuffs, and she refused and began resisting. Officers grabbed the female and place her hands behind her back to secure her in handcuffs.

Charges: Interference with Official Acts, Warrant-Other Agency

Demographics: 48-year-old white female

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
