**June Training:** All officers attended department drivers training. Several officers attended Iowa Acts of Interest; a training related to new laws enacted in 2024. Two officers attended tactical medicine for patrol officers. One officer attended proper patrol tactics. One officer attended crisis negotiator training. One officer attended undercover social media and technology in today’s investigations. Several police leaders attended the City of Ames Leadership Fundamentals training. Two officers attended the National Association of Field Training Officers conference. One officer assisted the Iowa Law Enforcement Academy as a driving instructor.

**June Outreach and Engagement:** Several officers assisted with “Donuts in the Park” at Inis Grove. Afternoon shift attended several neighborhood block parties throughout the month. Several officers assisted with the Ames Police Benefit Association (APBA) and Boys and Girls Club pancake breakfast. Officers completed several car seat checks throughout the month. A lieutenant presented to the Red Hat Society regarding scams. One officer completed tobacco compliance checks. Two officers stopped by the Brock Purdy football camp.

#### USE OF FORCE DETAIL

##### Incident 1:

**Use of Force: Display of firearm, Grabbed subject**

**Date: June 1, 2024, at 09:59**

Details: Officers were dispatched to a parking lot of an apartment complex reference a child being taken by an individual with a shotgun. Officers arrived on scene and did not locate anyone. Officers proceeded to the apartment where the call originated. The resident answered the door and brandished a gun. One officer drew his firearm and ordered the male to drop the weapon. The other officer grabbed the male and the gun that was in his possession fell to the ground. Officers struggled with the male but eventually were able to secure him in handcuffs. The male was taken to a local hospital for a mental health evaluation.

Charges: No charges

Demographics: 53-year-old black male

##### Incident 2:

**Use of Force: Grabbed subject**

**Date: June 4, 2024, at 02:56**

Details: Officers were dispatched to a residence for a domestic assault in progress. The caller was a roommate to the two individuals involved in the physical altercation and witnessed the assault. Officers arrived on scene and located the female half outside. Officers noted visible injuries on the female. The male half was ultimately placed under arrest. During the arrest, the male began resisting and refused to place his hands behind his back. Officers grabbed the male’s arms and placed them behind his back and were able to secure him in handcuffs without further incident.

Charges: Domestic Assault Strangulation with Injury, Interference with Official Acts

Demographics: 25-year-old black male

**Incident 3:****Use of Force: Display of firearm, Display of taser****Date: June 5, 2024, at 00:52**

Details: Officers were dispatched to an apartment complex for a male trying to get inside apartments. The reporting party was familiar with the male and relayed his information to officers on scene. Officers on scene were familiar with the male and knew he was wanted by another agency. The male ultimately jumped out of the window of one of the apartments and took off running from officers. Officers pursued him on foot as he ran into a parking garage and concealed himself among vehicles. One officer drew their firearm, and one drew their taser. Officers located the male hiding underneath a vehicle and gave him verbal commands. He was ultimately placed under arrest without incident.

Charges: Arrest Warrant-Other Agency, Interference with Official Acts

Demographics: 27-year-old white male

**Incident 4:****Use of Force: Grabbed subject****Date: June 5, 2024, at 15:07**

Details: Officers were dispatched to a public park for an intoxicated female. Officers located the female and confirmed she was intoxicated. The female was placed under arrest and secured in handcuffs. As officers were escorting her to the patrol car, she kicked one officer and tried to pull away from them. The female refused to get into the back of the patrol car. Officers were eventually able to get her in the vehicle. During transport to the PD, the female kicked the windows and partition inside the squad car causing minor damage to the vehicle.

Charges: Criminal Mischief 5<sup>th</sup> Degree, Public Intoxication, Interference with Official Acts, Providing False Identification Information

Demographics: 56-year-old white female

**Incident 5:****Use of Force: Display of firearm****Date: June 10, 2024, at 12:57**

Details: Officers conducted a search warrant at a residence. During the execution of the warrant, officers displayed their firearms. No other use of force was used. The case remains under investigation.

Charges: Under Investigation

Demographics: 24-year-old black male

**Incident 6:****Use of Force: Grabbed subject****Date: June 24, 2024, at 18:21**

Details: Officers were dispatched to a business for a shoplifter in custody. Officers arrived on scene and the female provided false identification information to them. Officers ultimately placed the female under arrest and secured her in handcuffs. The female attempted to get away from officers and tried to get out of the handcuffs. Officers grabbed the female's wrists and readjusted the handcuffs to secure them appropriately.

Charges: Theft 4<sup>th</sup> Degree, Harassment of Public Officials and Employees

Demographics: 22-year-old black female

**Incident 7:****Use of Force: Display of firearm****Date: June 28, 2024, at 19:02**

Details: Officers were contacted by an outside agency for a wanted subject who was at a local residence. Officers confirmed the information and attempted to serve the arrest warrant. Officers arrived at the location and the resident was outside. Officers asked the resident if the wanted male was inside to which he confirmed he was. The resident attempted to get the wanted male to exit the residence, but he refused. Officers then entered the residence utilizing a ballistic shield and having their duty firearms drawn for their safety. The wanted male was located and complied with orders from the officers and was taken into custody without incident.

Charges: Arrest Warrant-Other Agency

Demographics: 52-year-old white male

**Incident 8:**

**Use of Force: Grabbed subject**

**Date: June 29, 2024, at 01:30**

Details: Officers were flagged down by the male requesting a ride to Des Moines. Officers attempted to help the male locate a ride but were unsuccessful. Due to comments the male was making, officers requested an ambulance to the scene. Officers learned the male was wanted by an outside agency. The male refused to comply with paramedics and exited the ambulance and became aggressive with officers. Officers grabbed the male to place him under arrest, but he resisted. Officers took the male to the ground to secure him in handcuffs.

Charges: Arrest Warrant-Other Agency, Interference with Official Acts

Demographics: 24-year-old black male

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.

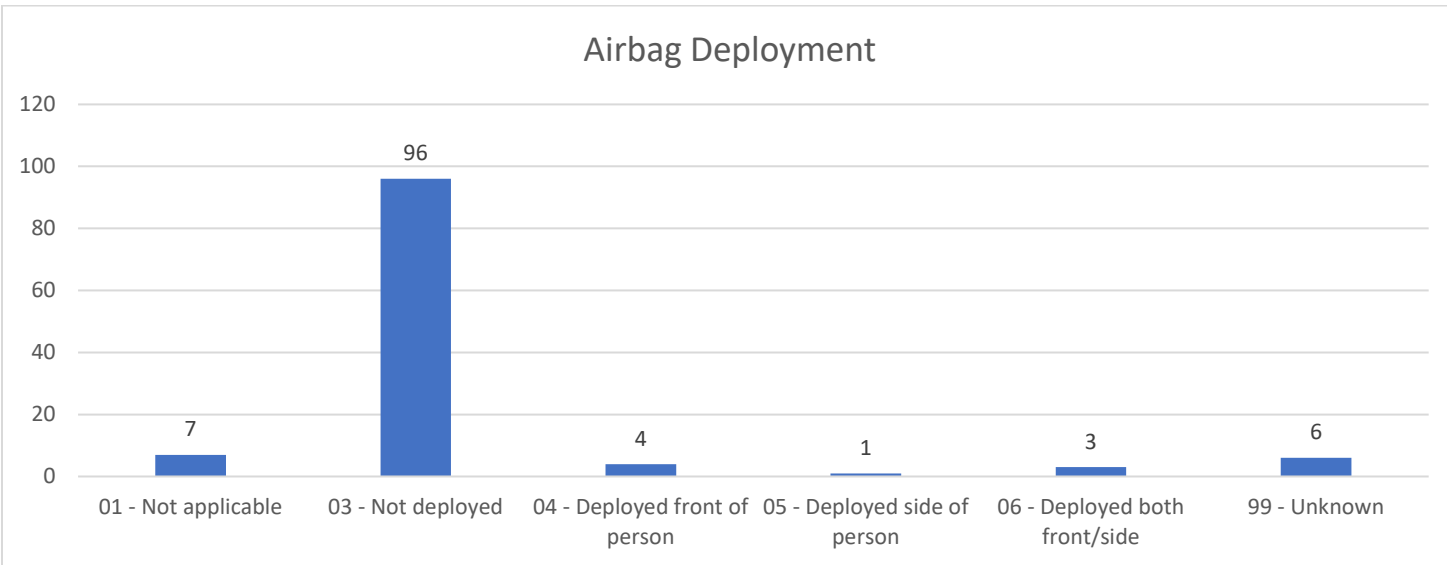
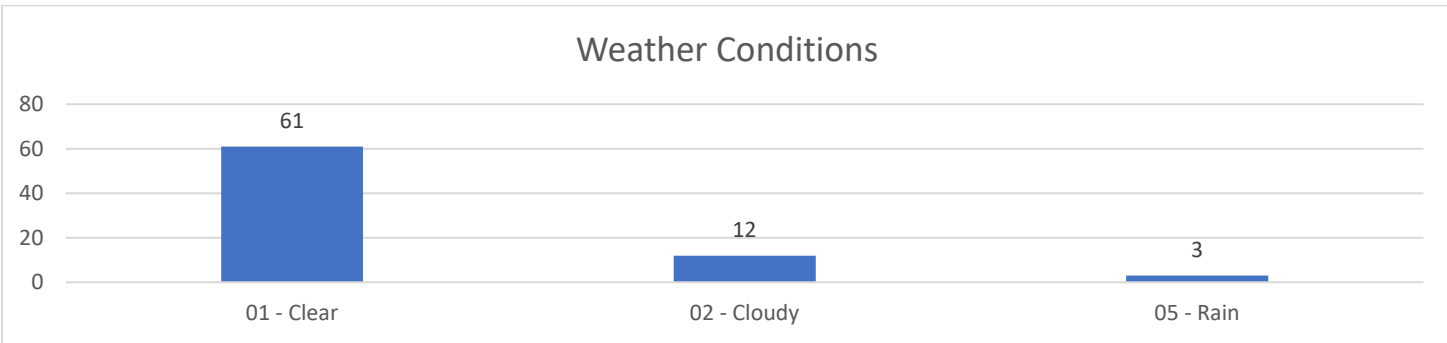
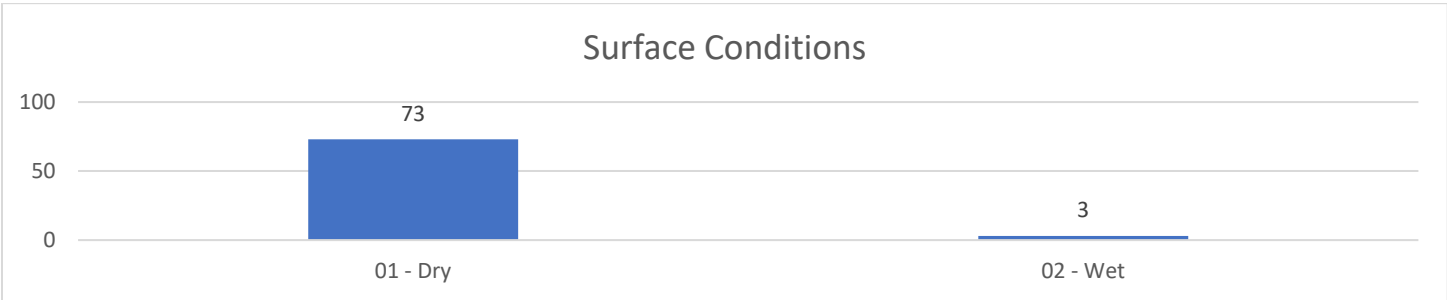
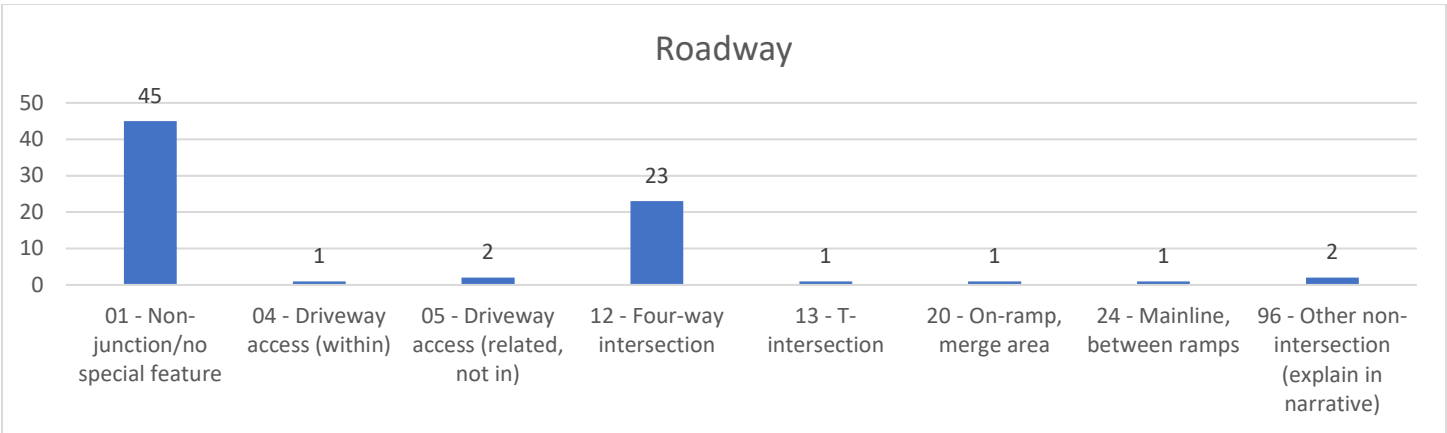


### Light Conditions

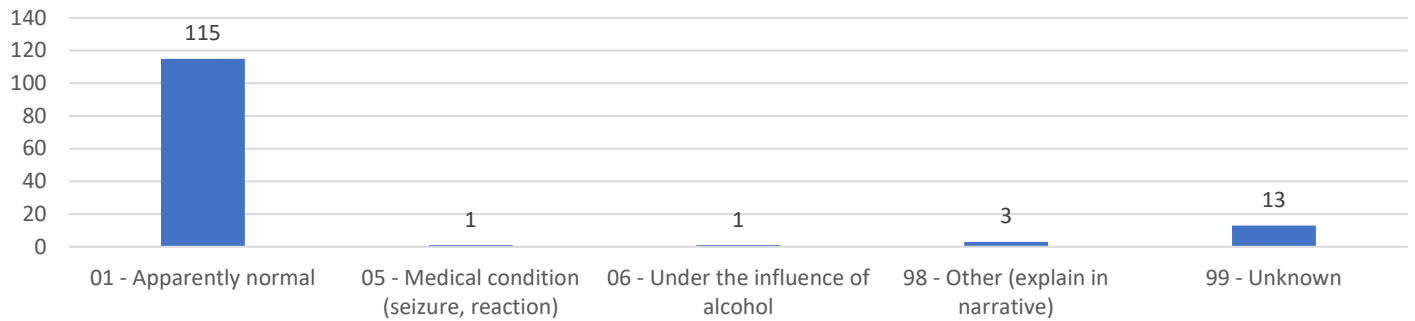


### Manner of Crash

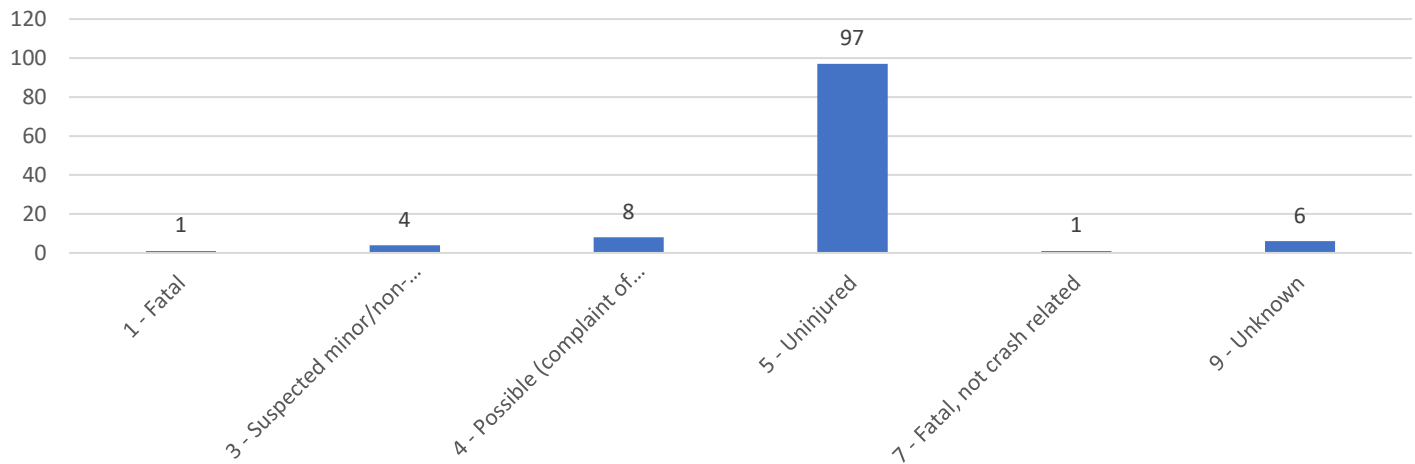




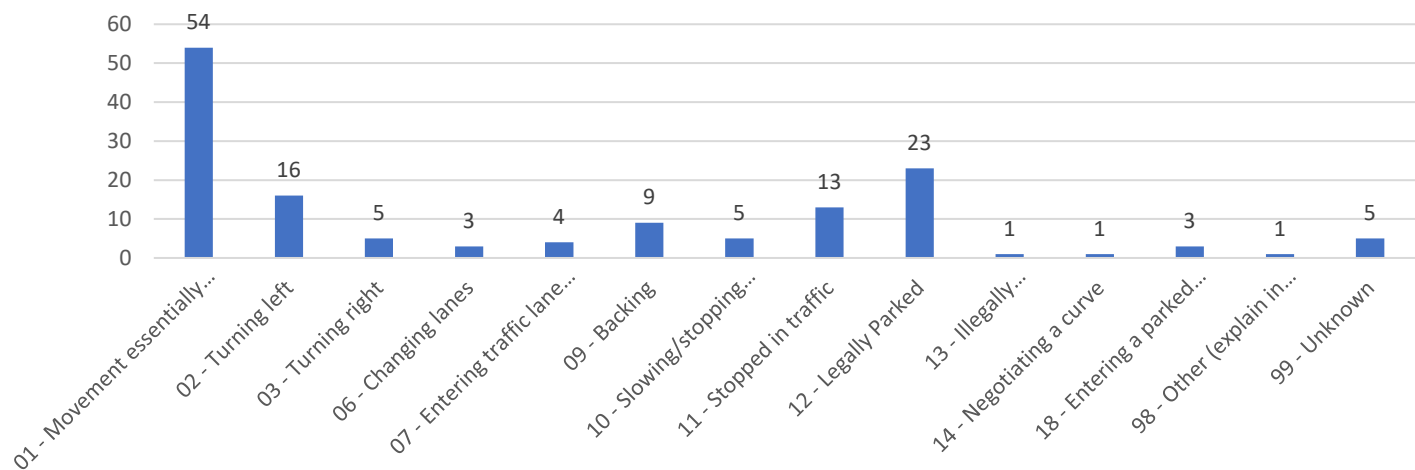
