



## AMES POLICE DEPARTMENT MONTHLY ACTIVITY REPORT

### August 2024



#### SUMMARY

**August Training:** Three officers continued their training at the Iowa Law Enforcement Academy (ILEA). Two officers continued in the field training program. Several police leaders attended the city’s leadership fundamentals course. All officers completed annual drivers training. One officer attended pistol instructor recertification at ILEA.

**August Outreach and Engagement:** Several officers from the department assisted with the National Night Out event. Officers attended summer block parties throughout the month. One officer joined the multi-disciplinary team with the Iowa Department of Health and Human Services regarding child abuse reporting. Command staff officers presented the traffic report each morning on KASI with “Mel in the Morning.” Officers attended the “Clap-In” at Edwards Elementary. Officers presented to several groups and provided outreach at several events throughout the “Cyclone Welcome Weekend.” Officers participated in the “Cop on the Top” fundraiser at Dunkin Donuts. The department hosted the quarterly bar meeting with local business owners and managers. Officers conducted monthly ID and alcohol talks.

#### USE OF FORCE DETAIL

##### Incident 1:

##### Use of Force: Grabbed subject

**Date: August 3, 2024, at 01:46**

Details: Officers were flagged down and made aware of two adult males who were passed out in front of an apartment complex. As officers approached the males, they observed an open bottle of tequila, and they noticed the strong smell of marijuana. Officers found that one of the males had an active warrant from another agency. Officers attempted to place the male under arrest, and he began to physically fight the officers. The male stood up at one point and officers had to take the male to the ground to gain control of him. Officers ultimately secured the wanted male in handcuffs. During the arrest of the wanted male, the other male woke up and began to physically resist officers. This male also got to his feet and had to be taken to the ground to gain control of him. Both males were intoxicated and arrested.

Charges: Arrest Warrant-Other Agency, Interference with Official Acts, Possession of a Controlled Substance-Marijuana 3<sup>rd</sup> or Subsequent, Public Intoxication

Demographics: 33-year-old black male, 36-year-old black male

##### Incident 2:

##### Use of Force: Grabbed subject

**Date: August 5, 2024, at 17:39**

Details: Officers were dispatched to an apartment complex for a report of disorderly conduct. Officers located an intoxicated male outside causing a disturbance. Officers attempted to place the male in handcuffs, but he tried pulling away. Officers took control of the male’s arms, but he continued to resist. Officers took the male to the ground at which point officers were able to secure the male in handcuffs. One officer sustained minor injuries because of the physical altercation with the male subject.

Charges: Public Intoxication, Interference with Official Acts, Interference with Official Acts Causing Injury

Demographics: 45-year-old white male

**Incident 3:****Use of Force: Grabbed subject****Date: August 6, 2024, at 14:03**

Details: Officers were dispatched to an apartment complex for two people fighting. Upon officer arrival, they could hear a male and female screaming inside. The male was threatening the female. The female seemed to be in distress. Officers knocked on the door and ultimately the male opened the door and officers grabbed the male and detained him in handcuffs while they investigated further. Both parties were separated and interviewed. No injuries were reported, and no charges were filed.

Charges: None

Demographics: 28-year-old white male, 33-year-old white female

**Incident 4:****Use of Force: Grabbed subject****Date: August 12, 2024, at 23:21**

Details: Officers were dispatched to a business reference a fight in progress. Upon arrival, officers located four males. The males were separated and three of them calmed down and spoke with officers. The fourth male appeared to have been in a physical altercation. His shirt and shoes were off, he was sweating profusely, and was unable to calm down. Officers told the male he was not free to leave, and he began to walk away. Officers grabbed the male and secured him in handcuffs. The male kept reaching for the duty belt and vest of one of the officers. The male was escorted to a patrol vehicle where he proceeded to spit multiple times inside of it.

Charges: Disorderly Conduct, Interference with Official Acts

Demographics: 24-year-old black male

**Incident 5:****Use of Force: Display of firearm****Date: August 13, 2024, at 12:06**

Details: Officers assisted an outside agency with a drug investigation. A traffic stop was initiated on the male subject and officers displayed their firearms due to the nature of the investigation. Upon contact with the male, the male ultimately complied, and no other use of force was needed. The case remains under investigation.

Charges: Under investigation

Demographics: 37-year-old white male

**Incident 6:****Use of Force: Grabbed subject****Date: August 22, 2024, at 10:32**

Details: Officers were dispatched to a residence reference a suicide attempt. Officers contacted the suicidal female. The female admitted taking several prescription pills. The female refused to walk to the ambulance. Officers grabbed the female and secured her in handcuffs as she continued to become more physically resistive. The female attempted to throw herself down the stairs however, officers were able to prevent this from happening. The female was transported to a local hospital for treatment.

Charges: None

Demographics: 60-year-old white female

**Incident 7:****Use of Force: Grabbed subject****Date: August 24, 2024, at 23:33**

Details: Officers were on foot patrol when they observed a male with an open container of alcohol in public. Officers attempted to speak with the male and identify him. The male attempted to run from officers, but one officer grabbed the male, and his shirt ripped, and he fell to the ground. The male did not resist officers after that. The male was secured in handcuffs and arrested. The male was under the age of 21 and highly intoxicated.

Charges: Public Intoxication, Possession of Alcohol Under the Legal Age, Interference with Official Acts

Demographics: 19-year-old white male

**Incident 8:**

**Use of Force: Display of firearm, Grabbed subject**

**Date: August 25, 2024, at 02:07**

Details: After a complaint of a male who had violated a no-contact order, officers responded to his location. The man earlier told officers he was armed with a gun. After making entry into the apartment an officer pointed a firearm at the man who then retreated into a bedroom to barricade himself inside. Officers breached the door and grabbed the man and secured him in handcuffs. The man had a large knife next to him.

Charges: Stalking, Contempt-Violation of No-Contact or Protection Order

Demographics: 30-year-old black male

**Incident 9:**

**Use of Force: Grabbed subject**

**Date: August 25, 2024, at 20:27**

Details: Officers were assisting with a medical call that involved a man known to have a valid arrest warrant. During his evaluation at the hospital the man began to strike his head against the bedrail. Officers grabbed the man to stop the self-harm. Once the man was cleared by medical staff, he was taken into custody on his warrant.

Charges: Arrest Warrant-Other Agency

Demographics: 39-year-old white male

**Incident 10:**

**Use of Force: Grabbed subject**

**Date: August 30, 2024, at 23:28**

Details: Officers were on routine patrol when they observed a fight in progress. Officers exited their patrol vehicles and yelled at the group to stop fighting. Three of the males complied and the fourth continued to hold onto another male by his shirt. Officers grabbed the male by the arm and escorted him away from the scene. The male ultimately complied, and no other use of force was needed.

Charges: Disorderly Conduct

Demographics: 22-year-old white male

**Incident 11:**

**Use of Force: Grabbed subject**

**Date: August 31, 2024, at 19:43**

Details: Officers were dispatched to an apartment complex on the report of a female breaking into the reporting party's vehicle and refusing to get out of it. Upon arrival, the female had locked herself in the mechanical storage closet inside the apartment complex and refused to come out. Officers removed the door and found the female inside stuffing items into a backpack. The female refused to get up, so officers assisted her and placed her hands behind her back. The female was in possession of items from the reporting party's vehicle.

Charges: Burglary 3<sup>rd</sup> Degree-Motor Vehicle

Demographics: 33-year-old white female

\*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.
