

#### CITY ADDS MORE ELECTRIC VEHICLES TO REDUCE CARBON EMISSIONS

Following the recommendations suggested in the community Climate Action Plan (CAP), several new all-electric vehicles have been added to the City's fleet. For years, the City has experimented with fuel-efficient compact and hybrid vehicles. Since accepting the CAP, the Ames City Council set a goal of purchasing zero emission vehicles, if possible, as fleet vehicles are retired and replaced.



Pricing and availability of electric vehicles (EVs) has greatly improved recently and changes in the tax code allow non-



profit entities like the City of Ames to qualify for a tax credit of up to \$7,500 on qualified EV purchases. The City expects fuel and maintenance savings from the new EVs. The new EVs bring the total number all-electric vehicles in the City's fleet to six. Also, the City Council recently approved the purchases of four additional Ford F150 Lightnings.

The City's fleet already includes many hybrid and flex fuel vehicles. City snow

plows have been using biodiesel fuel successfully for several years. CyRide has two all-electric buses with five on order and a goal of reaching 17 total.

To support EV drivers, the City manages 10 EV charging locations around Ames. The EVs added to the City fleet will primarily charge at department locations, but may sometimes use the public charging stations while in service.

#### Are You on a Snow Route? Things to Know When it Snows!



Winter weather is just around the corner and that means snow is not far behind. If you park on a snow route, you should know when the snow ordinance

is in effect. Snow

plowing begins after

two inches of snow accumulates on the major streets in Ames, and two inches of snowfall also activates the City's snow ordinance.

When the snow ordinance is in effect, drivers parked along snow routes – marked with red and white signs - need to move their vehicles to avoid ticketing and/or towing. Vehicles may return to the street when it has stopped snowing, no additional snow is forecast, and the

street has been plowed from curb to curb. Because this happens at different times throughout the city, there is no official announcement that the ordinance is over.

## PROJECT SHARE PROVIDES FINANCIAL ASSISTANCE FOR UTILITIES

A simple way to share the warmth with those in need is to make a monthly pledge or a one-time contribution to Project Share.

Project Share is a program developed by Ames Electric Services to assist low-income customers with winter utility bills. A committee

bills. A committee appointed by the Ames City Council determines the permissible uses of the funds donated to Project Share. The guidelines established by this committee ensure that 100 percent of every contribution is used to assist low-income customers. Last year, Ames Electric Services

contributed \$4,195 in staff time

and materials toward the cost of administering this program. Mid-Iowa Community Action (MICA) shares in the administration of the program

> by determining the eligibility of households for Project Share funds.

Project Share's success is the result of our customers' compassion and

generosity. Through your support, Project Share has provided \$549,483 in assistance to 4,471 households since the program's inception in 1990. Last winter alone, Project Share provided \$21,956 in assistance to 173 households. With your continued generosity, more Ames households will stay safe and warm this winter.



# FACILITY UPGRADES WILL IMPROVE WATER DISCHARGE

Work has started on the Nutrient Reduction Modifications project at the Water Pollution Control Facility, 56797 280th St. The \$62-million project enhances and upgrades the existing facility, which treats wastewater from Ames and discharges into the South Skunk River. The renovation project will meet discharge permit obligations adopted by the Iowa Department of Natural Resources to reduce nutrients in Iowa waterways.

"Our Water Pollution Control Facility has been recognized for more than 34 years for perfect compliance with our National Pollutant Discharge Elimination System permit, and we remain committed to protecting public health and the environment," said Water and Pollution Control Director John Dunn.

The project transitions the facility from an existing trickling filter/solids contact process to a biological nutrient process in two phases over the next 20 years to take advantage of the remaining useful life of the existing facilities.



Is Ames Electric Services ready for electric vehicles? How will you be able to handle all new power needs if all your customers purchase one (or even two) electric vehicles?

Ames Electric Services is excited about electric vehicles (EVs), but it's true that they are going to cause some changes to our business. An EV can use almost as much energy in a year as one of our typical residential customers. So EVs could result in a significant overall increase in the electricity Ames Electric needs to purchase or generate. However, it's very important when customers use energy, not just how much they use. I'll give a little background on how our utility currently manages its peak usage and then talk about how EVs could impact the utility.

Ames Electric is a utility that sees its peak energy usage during hot parts of the summer. This increased load is due primarily to the added cooling load, which is on top of all the other uses our customers have for electricity. On a hot summer day, the utility will typically see its peak usage sometime between 2 to 6 p.m. We encourage customers to conserve energy during these peak usage periods because our peak annual load drives a lot of the utility's expenses. Keeping the peak low can help us keep rates low for our customers.

With smart growth in electric use, we can increase the amount

of electricity sold, without increasing our annual peak needs. This will help keep rates low since it better utilizes the existing infrastructure that is sized to meet peak summer demand. On the other hand, if EVs and other new electric equipment creates a large growth in our peak load, the utility may need to make potentially expensive investments in larger wires and other equipment to deliver energy to our customers.



Helping all customers, especially EV owners, shift energy from the peak usage periods will be important for Ames Electric to manage growth in energy sales. Customers with EVs can help by delaying charging until later in the evening. This can be done by programming a car or charger to delay charging until after peak hours.

Are we ready for electric vehicles? Yes. We believe that through smart growth we can add a lot of new EV load to our utility without requiring major investments.
