October Training: All officers completed annual physical fitness testing. All officers attended Taser Training. Three officers continued their initial training at the Iowa Law Enforcement Academy (ILEA). Two officers continued their field training program. One officer completed the FTO (Field Training Officer) instructor course and will be assigned as a new FTO for the department. One officer instructed on Domestic Violence at ILEA and another presented firearms training at ILEA. Several supervisors attended the City’s Leadership Fundamentals training. Three officers attended EFC Combatives/Defensive Tactics training. Newly assigned APD officers attended long gun training.

October Outreach and Engagement: Several officers assisted with the annual Boys and Girls Club’s “Carving with Cops” event. Officers attended the Halloween event at North Grand Mall. Officers also attended a trunk or treat event at Ontario Church. One officer presented to probation and parole and another officer presented an ID training session for local merchants. One officer presented on bank robberies to Members First Community Credit Union. Officers participated in the Gilbert Schools First Responder Parade. One officer presented on scams to a P.E.O Chapter.

USE OF FORCE DETAIL

Incident 1:

Use of Force: Displayed Firearm

Date: October 9, 2024, at 15:44

Details: Officers responded to a call for a report of a man with a knife. It was reported the man had a knife held to his chest and there were others in the residence. When officers arrived, they encountered the man with two knives held under his chin. An officer drew their duty weapon, but did not point it at the subject. The officer gave the man verbal commands, and he did follow them and was detained in handcuffs. The man was transported to a local hospital for a mental evaluation. Criminal charges were filed after interviewing witnesses.

Charges: Assault While Displaying a Dangerous Weapon
 Demographics: 27-year-old white male

Incident 2:

Use of Force: Grabbed Subject/Took to Ground

Date: October 13, 2024, at 05:55

Details: Officers were dispatched to a business for a report of a man refusing to leave and harassing other customers. Officers arrived at the business and asked the man to leave several times, but he refused. Officers attempted to place him under arrest, and he pulled away. Officers grabbed the man, he continued to pull away and was taken to the ground to place him in handcuffs.

Charges: Trespass and Interference with Official Acts
 Demographics: 48-year-old white male

Incident 3:**Use of Force: Displayed Firearm****Date: October 13, 2024, at 20:29**

Details: Officers were dispatched to a vacant house where it was reported flashlights were seen. Officers heard noises from the basement. Officers drew their duty handguns and called the man out. The man was secured and gave false information to the officers. Eventually his identity was confirmed along with the fact he had broken in.

Charges: Burglary 3rd Degree, Providing False Identification

Demographics: 28-year-old white male

Incident 4:**Use of Force: Displayed Firearm/Grabbed Subject****Date: October 24, 2024, at 14:07**

Details: Officers were dispatched to a medical call where a man had taken an unknown number of pills and was somewhat combative. An officer grabbed the man and assisted in getting him to a local hospital for evaluation.

Charges: None

Demographics: 63-year-old white male

Incident 5:**Use of Force: Grabbed Subject/Took to Ground****Date: October 25, 2024, at 08:26**

Details: Officers were dispatched to an intersection for a male having what appeared to be a mental health episode. Officers were familiar with the male and ran his information through dispatch. The male returned wanted out of another agency. The male refused to comply with officers and continued walking away from them. As officers grabbed the male, he locked his arms in front of his chest and lost his balance and began to fall so officers guided him to the ground to avoid injury. Officers had to pry the male's hands out from his chest to secure him in handcuffs.

Charges: Warrant Arrest-Other Agency, Interference with Official Acts

Demographics: 58-year-old Asian male

Incident 6:**Use of Force: Grabbed Subject****Date: October 25, 2024, at 22:25**

Details: Officers were dispatched to an apartment where a male pulled a gun and was threatening a female. Officers were advised there was a large party, and several party goers had been threatened with the gun. Officers arrived on scene and drew their duty handguns. Officers located the male and a female in the hallway. Officers watched the gun get thrown down the hallway toward officers, so they approached the male and female. The male then began walking toward the gun. Officers ordered the male to not pick up the gun, but he did. Officers yelled at the male to drop the gun, and he threw it back on the ground. Officers grabbed the male and pushed him against a wall to create distance between him and the gun. The male was secured in handcuffs and escorted out of the apartment complex.

Charges: False Imprisonment, Intimidation with a Dangerous Weapon, Assault While Displaying a Weapon x 3, Possession/Carrying Firearm While Under the Influence, Interference with Official Acts, Harassment 1st Degree x 3, Harassment of Public Official

Demographics: 21-year-old black male

*A note on arrests and charges. There is a difference between a discretionary and non-discretionary arrest. Non-discretionary arrests involve incidents when the officer has no choice but to make an arrest. Examples include, but not limited to; Driving While Barred, Driving While Revoked, Driving While Suspended, Warrant Arrests, Contempt of Court, Failure to Appear, Probation/Parole Violations, Domestic Assaults, and Theft calls when a private business wants to file charges on offenses such as shoplifting. Other cases are incidents where there is a victim, and we have victim focused investigations allowing them voice in the decision-making process. In all cases, an officer must establish probable cause to make an arrest.









Driver Condition




Vehicle Action


